Technical assistance. Upon request, the commissioner shall provide technical 3.22 assistance to an organization that meets the requirement in subdivision 3, clause (1). The 3.23 technical assistance may include, but is not limited to: 3.24 (1) tax site development and management training; 3.25 (2) VITA and TCE site coordinator training; 3.26 (3) individual tax preparer and reviewer training on tax law; 3.27 (4) support in developing volunteer training; 3.28 (5) tax return preparation software and e-file administration training; and 3.29 (6) one-on-one support by phone and e-mail for problem solving at tax site programs. 3.30
