1.1 A bill for an act  
1.2 relating to public safety; expanding the reporting of crimes motivated by bias;  
1.3 amending the crimes of assault, property damage, and harassment motivated by  
1.4 bias; requiring the Board of Peace Officer Standards and Training to update training  
1.5 in recognizing, responding to, and reporting crimes of bias; appropriating money;  
1.6 amending Minnesota Statutes 2020, sections 363A.06, subdivision 1; 609.2231,  
1.7 subdivision 4; 609.2233; 609.595, subdivisions 1a, 2; 609.749, subdivision 3;  
1.8 626.5531, subdivision 1; 626.8451, subdivision 1; 626.8469, subdivision 1.

1.9 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

1.10 Section 1. Minnesota Statutes 2020, section 363A.06, subdivision 1, is amended to read:

1.11 Subdivision 1. **Formulation of policies.** (a) The commissioner shall formulate policies  
1.12 to effectuate the purposes of this chapter and shall do the following:

1.13 (1) exercise leadership under the direction of the governor in the development of human  
1.14 rights policies and programs, and make recommendations to the governor and the legislature  
1.15 for their consideration and implementation;

1.16 (2) establish and maintain a principal office in St. Paul, and any other necessary branch  
1.17 offices at any location within the state;

1.18 (3) meet and function at any place within the state;

1.19 (4) employ attorneys, clerks, and other employees and agents as the commissioner may  
1.20 deem necessary and prescribe their duties;

1.21 (5) to the extent permitted by federal law and regulation, utilize the records of the  
1.22 Department of Employment and Economic Development of the state when necessary to  
1.23 effectuate the purposes of this chapter;

2.1 (6) obtain upon request and utilize the services of all state governmental departments  
2.2 and agencies;

2.3 (7) adopt suitable rules for effectuating the purposes of this chapter;

2.4 (8) issue complaints, receive and investigate charges alleging unfair discriminatory  
2.5 practices, and determine whether or not probable cause exists for hearing;

2.6 (9) subpoena witnesses, administer oaths, take testimony, and require the production for  
2.7 examination of any books or papers relative to any matter under investigation or in question  
2.8 as the commissioner deems appropriate to carry out the purposes of this chapter;

2.9 (10) attempt, by means of education, conference, conciliation, and persuasion to eliminate  
2.10 unfair discriminatory practices as being contrary to the public policy of the state;

2.11 (11) develop and conduct programs of formal and informal education designed to  
2.12 eliminate discrimination and intergroup conflict by use of educational techniques and  
2.13 programs the commissioner deems necessary;

2.14 (12) make a written report of the activities of the commissioner to the governor each  
2.15 year;

2.16 (13) accept gifts, bequests, grants, or other payments public and private to help finance  
2.17 the activities of the department;

2.18 (14) create such local and statewide advisory committees as will in the commissioner's  
2.19 judgment aid in effectuating the purposes of the Department of Human Rights;

2.20 (15) develop such programs as will aid in determining the compliance throughout the  
2.21 state with the provisions of this chapter, and in the furtherance of such duties, conduct  
2.22 research and study discriminatory practices based upon race, color, creed, religion, national  
2.23 origin, sex, age, disability, marital status, status with regard to public assistance, familial  
2.24 status, sexual orientation, or other factors and develop accurate data on the nature and extent  
2.25 of discrimination and other matters as they may affect housing, employment, public  
2.26 accommodations, schools, and other areas of public life;

2.27 (16) develop and disseminate technical assistance to persons subject to the provisions  
2.28 of this chapter, and to agencies and officers of governmental and private agencies;

2.29 (17) provide staff services to such advisory committees as may be created in aid of the  
2.30 functions of the Department of Human Rights;

2.31 (18) make grants in aid to the extent that appropriations are made available for that  
2.32 purpose in aid of carrying out duties and responsibilities; ~~and~~

3.1 (19) cooperate and consult with the commissioner of labor and industry regarding the  
 3.2 investigation of violations of, and resolution of complaints regarding section 363A.08,  
 3.3 subdivision 7;

3.4 (20) collaborate and consult with the Board of Peace Officer Standards and Training  
 3.5 regarding the training of peace officers in identifying, responding to, and reporting crimes  
 3.6 motivated by bias pursuant to sections 626.8451, subdivision 1, and 626.8469, including  
 3.7 but not limited to the duty of peace officers to report crimes motivated by bias under section  
 3.8 626.5531; and

3.9 (21) solicit, receive, and compile reports from community organizations, school districts  
 3.10 and charter schools, and individuals regarding crimes a community member or community  
 3.11 organization believes are motivated by the victim's or another's actual or perceived race,  
 3.12 color, ethnicity, religion, sex, gender, sexual orientation, gender identity, gender expression,  
 3.13 age, national origin, marital status, status with regard to public assistance, familial status,  
 3.14 or disability as defined in section 363A.03, or because of the victim's actual or perceived  
 3.15 association with another person or group of a certain actual or perceived race, color, ethnicity,  
 3.16 religion, sex, gender, sexual orientation, gender identity, gender expression, age, national  
 3.17 origin, or disability as defined in section 363A.03, and develop data on the nature and extent  
 3.18 of crimes motivated by bias and include this information in the report required under clause  
 3.19 (12). The commissioner shall provide information on the department's website about when  
 3.20 and how a victim reports criminal conduct to a law enforcement agency.

3.21 In performing these duties, the commissioner shall give priority to those duties in clauses  
 3.22 (8), (9), and (10) and to the duties in section 363A.36.

3.23 (b) All gifts, bequests, grants, or other payments, public and private, accepted under  
 3.24 paragraph (a), clause (13), must be deposited in the state treasury and credited to a special  
 3.25 account. Money in the account is appropriated to the commissioner of human rights to help  
 3.26 finance activities of the department.

3.27 **EFFECTIVE DATE.** This section is effective July 1, 2021.

3.29 Subd. 4. **Assaults motivated by bias.** (a) Whoever assaults another in whole or in part  
 3.30 because of the victim's or another's actual or perceived race, color, ethnicity, religion, sex,  
 3.31 gender, sexual orientation, gender identity, gender expression, age, national origin, or  
 3.32 disability as defined in section 363A.03, ~~age, or national origin~~ or because of the victim's  
 3.33 actual or perceived association with another person or group of a certain actual or perceived

4.1 race, color, ethnicity, religion, sex, gender, sexual orientation, gender identity, gender  
 4.2 expression, age, national origin, or disability as defined in section 363A.03, may be sentenced  
 4.3 to imprisonment for not more than one year or to payment of a fine of not more than \$3,000,

4.5 (b) Whoever violates the provisions of paragraph (a) within five years of a previous

4.14 A person who violates section 609.221, 609.222, or 609.223 because of the victim's or  
 4.15 another person's actual or perceived race, color, ethnicity, religion, sex, gender, sexual  
 4.16 orientation, gender identity, gender expression, age, national origin, or disability as defined  
 4.17 in section 363A.03, ~~age, or national origin~~ or because of the victim's actual or perceived  
 4.18 association with another person or group of a certain actual or perceived race, color, ethnicity,  
 4.19 religion, sex, gender, sexual orientation, gender identity, gender expression, age, national  
 4.20 origin, or disability as defined in section 363A.03, is subject to a statutory maximum penalty  
 4.21 of 25 percent longer than the maximum penalty otherwise applicable.

 5.25 property without the other person's consent may be sentenced to imprisonment for not more  
 5.26 than one year or to payment of a fine of not more than \$3,000, or both, if: (1) the damage  
 5.27 reduces the value of the property by more than \$500 but not more than \$1,000 as measured  
 5.28 by the cost of repair and replacement; or (2) the damage was to a public safety motor vehicle  
 5.29 and the defendant knew the vehicle was a public safety motor vehicle.

5.30 (b) Whoever intentionally causes damage to another person's physical property without

6.23 be prosecuted in any county in which one of the offenses was committed for all of the  
6.24 offenses aggregated under this paragraph.

6.25 **EFFECTIVE DATE.** This section is effective August 1, 2021, and applies to crimes  
6.26 committed on or after that date.

6.27 Sec. 6. Minnesota Statutes 2020, section 609.749, subdivision 3, is amended to read:

6.28 Subd. 3. **Aggravated violations.** (a) A person who commits any of the following acts  
6.29 is guilty of a felony and may be sentenced to imprisonment for not more than five years or  
6.30 to payment of a fine of not more than \$10,000, or both:

6.31 (1) commits any offense described in subdivision 2 because of the victim's or another's  
6.32 actual or perceived race, color, ethnicity, religion, sex, gender, sexual orientation, gender  
6.33 identity, gender expression, age, national origin, or disability as defined in section 363A.03,

7.1 ~~age, or national origin~~ or because of the victim's actual or perceived association with another  
 7.2 person or group of a certain actual or perceived race, color, ethnicity, religion, sex, gender,  
 7.3 sexual orientation, gender identity, gender expression, age, national origin, or disability as

7.5 (2) commits any offense described in subdivision 2 by falsely impersonating another;

 7.12 proceeding; or

 7.25 reason to believe, or if the victim alleges, that the offender was motivated to commit the  
 7.26 act ~~by~~ in whole or in part because of the victim's actual or perceived race, color, ethnicity,  
 7.27 religion, ~~national origin,~~ sex, gender, sexual orientation, gender identity, gender expression,  
 7.28 age, national origin, or disability as defined in section 363A.03, or ~~characteristics identified~~  
 7.29 as sexual orientation because of the victim's actual or perceived association with another

8.16 Subdivision 1. **Training course; crimes motivated by bias.** (a) The board must prepare  
8.17 a training course to assist peace officers in identifying and, responding to, and reporting  
8.18 crimes motivated by in whole or in part because of the victim's or another's actual or  
8.19 perceived race, color, ethnicity, religion, national origin, sex, gender, sexual orientation,  
8.20 gender identity, gender expression, age, national origin, or disability as defined in section  
8.21 363A.03, or characteristics identified as sexual orientation because of the victim's actual or  
8.22 perceived association with another person or group of a certain actual or perceived race,  
8.23 color, ethnicity, religion, sex, gender, sexual orientation, gender identity, gender expression,  
8.24 age, national origin, or disability as defined in section 363A.03. The course must include  
8.25 material to help officers distinguish bias crimes from other crimes, to help officers in  
8.26 understanding and assisting victims of these crimes, and to ensure that bias crimes will be

8.28 must be updated periodically every three years and update it as the board, in consultation  
8.29 with the commissioner of human rights, considers appropriate.

9.3 Subdivision 1. **In-service training required.** (a) Beginning July 1, 2018, the chief law  
9.4 enforcement officer of every state and local law enforcement agency shall provide in-service  
9.5 training in crisis intervention and mental illness crises; conflict management and mediation;  
9.6 ~~and~~ recognizing and valuing community diversity and cultural differences to include implicit  
9.7 bias training; and training to assist peace officers in identifying, responding to, and reporting  
9.8 crimes committed in whole or in part because of the victim's actual or perceived race,  
9.9 religion, national origin, sex, age, disability, or characteristics identified as sexual orientation  
9.10 to every peace officer and part-time peace officer employed by the agency. The training  
9.11 shall comply with learning objectives developed and approved by the board and shall meet  
9.12 board requirements for board-approved continuing education credit. The board shall perform  
9.13 an annual review of the learning objectives and must consult and collaborate with the  
9.14 commissioner of human rights in identifying appropriate objectives related to identifying,  
9.15 responding to, and reporting crimes committed in whole or in part because of the victim's  
9.16 or another's actual or perceived race, color, ethnicity, religion, national origin, sex, gender,  
9.17 sexual orientation, gender identity, gender expression, age, national origin, or disability as  
9.18 defined in section 363A.03, or characteristics identified as sexual orientation because of  
9.19 the victim's actual or perceived association with another person or group of a certain actual  
9.20 or perceived race, color, ethnicity, religion, sex, gender, sexual orientation, gender identity,

9.22 training shall consist of at least 16 continuing education credits within an officer's three-year  
9.23 licensing cycle. Each peace officer with a license renewal date after June 30, 2018, is not  
9.24 required to complete this training until the officer's next full three-year licensing cycle.

9.25 (b) Beginning July 1, 2021, the training mandated under paragraph (a) must be provided  
9.26 by an approved entity. The board shall create a list of approved entities and training courses  
9.27 and make the list available to the chief law enforcement officer of every state and local law  
9.28 enforcement agency. Each peace officer (1) with a license renewal date before June 30,  
9.29 2022, and (2) who received the training mandated under paragraph (a) before July 1, 2021,  
9.30 is not required to receive this training by an approved entity until the officer's next full  
9.31 three-year licensing cycle.
