1.8	a Z-Degree by academic year 2020-2021.
1.9	(b) Six additional colleges must offer the opportunity to earn a Z-Degree in the 2022-2023
1.10	academic year.
1.11	(c) A college's course offerings for its Z-Degree program must include at least two
1.12	distinct courses in each transfer curriculum goal area and at least enough credits in each
1.13	transfer curriculum goal area to complete the transfer curriculum package.
