1.5	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:
1.6	Section 1. Minnesota Statutes 2018, section 297A.71, is amended by adding a subdivision
1.7	to read:
1.8	Subd. 51. Government services facilities. (a) Materials and supplies used or consumed
1.9	in and equipment incorporated into the construction, remodeling, expansion, or improvement
1.10	of a government services building, including related facilities, owned and operated by Rice
1.11	County are exempt.
1.12	(b) For purposes of this subdivision, "related facilities" includes access roads, lighting,
1.13	sidewalks, and utility components, on or adjacent to the property on which the government
1.14	services buildings are located, that are necessary for safe access to and use of those buildings.
1.15	(c) The tax must be imposed and collected as if the rate under section 297A.62,
1.16	subdivision 1, applied and then refunded in the manner provided in section 297A.75. Refunds
1.17	applied for under this subdivision must not exceed \$300,000.
1.18	(d) The exemption under this subdivision is effective retroactively for sales and purchases
1.19	made after September 30, 2018, and before January 1, 2021.
