1.5	Section 1. [124D.901] TUTORING GRANTS PROGRAM.
1.6	Subdivision 1. Establishment. (a) The Department of Education must administer a grant
1.7	program to support highly effective tutoring programs that address learning loss or unfinished
1.8	learning, create learning supports that meet the immediate and diverse needs of students,
1.9	and are accessible to students with the greatest learning needs.
1.10	(b) Grant funds may be used to sustain tutoring programs established with federal funding
1.11	during the 2020-2021 to 2022-2023 school years or to implement new tutoring programs
1.12	using best practices.
1.13	Subd. 2. Definitions. (a) For purposes of this section, the following definitions have the
