1.4	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:
1.5	Section 1. CASEY JONES STATE TRAIL.
1.6	Subdivision 1. Appropriation. \$1,049,000 is appropriated from the bond proceeds fund
1.7	to the commissioner of natural resources for development of the Casey Jones State Trail
1.8	under Minnesota Statutes, section 85.015, subdivision 2. The Casey Jones trail must be
1.9	established as a primary, not a secondary trail.
1.10	Subd. 2. Bond sale. To provide the money appropriated in this section from the bond
1.11	proceeds fund, the commissioner of management and budget shall sell and issue bonds of
1.12	the state in an amount up to \$1,049,000 in the manner, upon the terms, and with the effect
1.13	prescribed by Minnesota Statutes, sections 16A.631 to 16A.675, and by the Minnesota
1.14	Constitution, article XI, sections 4 to 7.

1.15 **EFFECTIVE DATE.** This section is effective the day following final enactment.
