State partisan primary ballot; party columns. The state partisan primary 1.6 ballot shall be headed by the words "State Partisan Primary Ballot." The ballot shall be 1.7 printed on white paper. There must be at least three vertical columns on the ballot and each 1.8 major political party shall have a separate column headed by the words "........... Party," 19 giving the party name. The party columns shall be substantially the same in width, type, and appearance. The columns shall be separated by a 12-point solid line.

Subd. 6. State and county nonpartisan primary ballot. The state and county nonpartisan primary ballot shall be headed "State and County Nonpartisan Primary Ballot." It shall be printed in the manner provided in the rules of the secretary of state. The names of candidates for nomination to the Supreme Court, Court of Appeals, district court, and all county offices shall be placed on this ballot. The candidates for state senator shall be listed first, candidates for state representative second, candidates for nomination to the
