1.12	industrialization center that trains students in high-growth, high-demand careers, which

1.14	school districts, trade associations, unions, local chamber of commerce, or economic

1.16	(c) "Commissioner" means the commissioner of the Office of Higher Education.
1.17	Subd. 2. Establishment; eligibility. (a) The commissioner, in consultation with
1.18	representatives from Minnesota State Colleges and Universities and the business community,
1.19	must establish and administer a program annually awarding grants to eligible postsecondary
