1.8	Subdivision 1. Emerging farmer working group. (a) To advise the commissioner and
1.9	legislature regarding the development and implementation of programs and initiatives that
1.10	support emerging farmers in this state, the commissioner must periodically convene a
1.11	working group consisting, to the extent possible, of persons who are, and organizations that
1.12	represent, farmers or aspiring farmers who are women, veterans, persons with disabilities,
1.13	American Indian or Alaskan Natives, members of a community of color, young, and urban,
1.14	and any other emerging farmers as determined by the commissioner. No later than January
1.15	15 each year, the commissioner must update the chairs and ranking minority members of
1.16	the legislative committees and divisions with jurisdiction over agriculture regarding the
1.17	working group's activities and recommendations.
1.18	(b) The commissioner is authorized to accept for and on behalf of the state donations of
1.19	money or services or other assistance or gifts from public or private sources for the purpose
1.20	of furthering the objectives of the emerging farmer working group.
