

1.1 A bill for an act

1.2 relating to taxation; sales and use; exempting construction materials and
1.3 equipment used in the construction and improvement of a regional wastewater
1.4 treatment facility; amending Minnesota Statutes 2008, sections 297A.71,
1.5 by adding a subdivision; 297A.75, subdivision 3; Minnesota Statutes 2009
1.6 Supplement, section 297A.75, subdivisions 1, 2.

1.7 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

1.8 Section 1. Minnesota Statutes 2008, section 297A.71, is amended by adding a
1.9 subdivision to read:

1.10 Subd. 42. **Construction materials; wastewater treatment facility.** Materials
1.11 and supplies used or consumed in, and equipment incorporated into, the construction,
1.12 expansion, and rehabilitation of a regional wastewater treatment facility to serve the
1.13 communities of St. Cloud, Waite Park, Sauk Rapids, Sartell, St. Joseph, and St. Augusta
1.14 are exempt. The tax must be imposed and collected as is the rate under section 297A.62,
1.15 subdivision 1, applied, and then refunded in the manner provided in section 297A.75.

1.16 **EFFECTIVE DATE.** This section is effective for sales and purchases made after
1.17 January 1, 2010.

1.20 Subdivision 1. **Tax collected.** The tax on the gross receipts from the sale of the
1.21 following exempt items must be imposed and collected as if the sale were taxable and the
1.22 rate under section 297A.62, subdivision 1, applied. The exempt items include:

2.21 (12) commuter rail vehicle and repair parts under section 297A.70, subdivision
2.22 3, clause (11);

2.23 (13) materials, supplies, and equipment for construction or improvement of projects
2.24 and facilities under section 297A.71, subdivision 40;~~and~~

2.25 (14) materials, supplies, and equipment for construction or improvement of a meat
2.26 processing facility exempt under section 297A.71, subdivision 41;and

2.27 (15) materials, supplies, and equipment for construction, expansion, and
2.28 rehabilitation of the facility exempt under section 297A.71, subdivision 42.

2.29 **EFFECTIVE DATE.** This section is effective for sales and purchases made after
2.30 January 1, 2010.

2.32 amended to read:

2.33 Subd. 2. **Refund; eligible persons.** Upon application on forms prescribed by the
2.34 commissioner, a refund equal to the tax paid on the gross receipts of the exempt items
2.35 must be paid to the applicant. Only the following persons may apply for the refund:

- 3.1 (1) for subdivision 1, clauses (1) to (3), the applicant must be the purchaser;
- 3.2 (2) for subdivision 1, clauses (4) and (7), the applicant must be the governmental
3.3 subdivision;
- 3.4 (3) for subdivision 1, clause (5), the applicant must be the recipient of the benefits
3.5 provided in United States Code, title 38, chapter 21;
- 3.6 (4) for subdivision 1, clause (6), the applicant must be the owner of the homestead
3.7 property;
- 3.8 (5) for subdivision 1, clause (8), the owner of the qualified low-income housing
3.9 project;
- 3.10 (6) for subdivision 1, clause (9), the applicant must be a municipal electric utility or
3.11 a joint venture of municipal electric utilities;
- 3.12 (7) for subdivision 1, clauses (10), (11), and (14), the owner of the qualifying
3.13 business; and
- 3.14 (8) for subdivision 1, clauses (12) ~~and~~, (13), and (15) the applicant must be the
3.15 governmental entity that owns or contracts for the project or facility.

3.16 **EFFECTIVE DATE.** This section is effective for sales and purchases made after
3.17 January 1, 2010.

3.18 Sec. 4. Minnesota Statutes 2008, section 297A.75, subdivision 3, is amended to read:

3.19 Subd. 3. **Application.** (a) The application must include sufficient information
3.20 to permit the commissioner to verify the tax paid. If the tax was paid by a contractor,
3.21 subcontractor, or builder, under subdivision 1, clause (4), (5), (6), (7), (8), (9), (10), (11),
3.22 (12), (13), ~~or~~ (14), or (15), the contractor, subcontractor, or builder must furnish to the
3.23 refund applicant a statement including the cost of the exempt items and the taxes paid on
3.24 the items unless otherwise specifically provided by this subdivision. The provisions of
3.25 sections 289A.40 and 289A.50 apply to refunds under this section.

3.26 (b) An applicant may not file more than two applications per calendar year for
3.27 refunds for taxes paid on capital equipment exempt under section 297A.68, subdivision 5.

3.28 (c) Total refunds for purchases of items in section 297A.71, subdivision 40, must not
3.29 exceed \$5,000,000 in fiscal years 2010 and 2011. Applications for refunds for purchases
3.30 of items in sections 297A.70, subdivision 3, paragraph (a), clause (11), and 297A.71,
3.31 subdivision 40, must not be filed until after June 30, 2009.

3.32 **EFFECTIVE DATE.** This section is effective for sales and purchases made after
3.33 January 1, 2010.
