1.3 Minnesota Statutes 2016, sections 360.013, by adding a subdivision; 360.017,  
1.4 subdivision 1; 360.021, subdivision 1; 360.062; 360.063, subdivisions 1, 3; 360.064,  
1.5 subdivision 1; 360.065, subdivision 1; 360.066, subdivision 1; 360.067, by adding  
1.6 a subdivision; 360.071, subdivision 2; 360.305, subdivision 6; 394.22, by adding  
1.7 a subdivision; 394.23; 394.231; 394.25, subdivision 3; 462.352, by adding a  
1.8 subdivision; 462.355, subdivision 1; 462.357, subdivision 9, by adding a  
1.9 subdivision; proposing coding for new law in Minnesota Statutes, chapter 360;  
1.10 repealing Minnesota Statutes 2016, sections 360.063, subdivision 4; 360.065,  
1.11 subdivision 2; 360.066, subdivisions 1a, 1b.

1.12 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

1.13 Section 1. Minnesota Statutes 2016, section 360.013, is amended by adding a subdivision  
1.14 to read:

1.15 Subd. 46a. Comprehensive plan. "Comprehensive plan" has the meaning given in  
1.16 section 394.22, subdivision 9, or 462.352, subdivision 5.

1.17 Sec. 2. Minnesota Statutes 2016, section 360.017, subdivision 1, is amended to read:

1.18 Subdivision 1. **Creation; authorized disbursements.** (a) There is hereby created a  
1.19 fund to be known as the state airports fund. The fund shall consist of all money appropriated  
1.20 to it, or directed to be paid into it, by the legislature.

1.21 (b) The state airports fund shall be paid out on authorization of the commissioner and  
1.22 shall be used:

1.23 (1) to acquire, construct, improve, maintain, and operate airports and other air navigation  
1.24 facilities;

2.1 (2) to assist municipalities in the planning, acquisition, construction, improvement, and  
2.2 maintenance of airports and other air navigation facilities;

2.3 (3) to assist municipalities to initiate, enhance, and market scheduled air service at their  
2.4 airports;

2.5 (4) to promote interest and safety in aeronautics through education and information; and

2.6 (5) to pay the salaries and expenses of the Department of Transportation related to  
2.7 aeronautic planning, administration, and operation. All allotments of money from the state  
2.8 airports fund for salaries and expenses shall be approved by the commissioner of management  
2.9 and budget.

2.10 ~~(e) A municipality that adopts a comprehensive plan that the commissioner finds is~~  
2.11 ~~incompatible with the state aviation plan is not eligible for assistance from the state airports~~  
2.12 ~~fund.~~

2.13 Sec. 3. Minnesota Statutes 2016, section 360.021, subdivision 1, is amended to read:

2.14 Subdivision 1. **Authority to establish.** The commissioner is authorized and empowered,  
2.15 on behalf of and in the name of this state, within the limitation of available appropriations,  
2.16 to acquire, by purchase, gift, devise, lease, condemnation proceedings, or otherwise, property,  
2.17 real or personal, for the purpose of establishing and constructing restricted landing areas  
2.18 and other air navigation facilities and to acquire in like manner, own, control, establish,  
2.19 construct, enlarge, improve, maintain, equip, operate, regulate, and police such restricted  
2.20 landing areas and other air navigation facilities, either within or without this state; and to  
2.21 make, prior to any such acquisition, investigations, surveys, and plans. The commissioner  
2.22 may maintain, equip, operate, regulate, and police airports, either within or without this  
2.23 state. The operation and maintenance of airports is an essential public service. The  
2.24 commissioner may maintain at such airports facilities for the servicing of aircraft and for  
2.25 the comfort and accommodation of air travelers. The commissioner may dispose of any  
2.26 such property, airport, restricted landing area, or any other air navigation facility, by sale,  
2.27 lease, or otherwise, in accordance with the laws of this state governing the disposition of  
2.28 other like property of the state. The commissioner may not acquire or take over any restricted  
2.29 landing area, or other air navigation facility without the consent of the owner. The  
2.30 commissioner shall not acquire any additional state airports nor establish any additional  
2.31 state-owned airports. The commissioner may erect, equip, operate, and maintain on any  
2.32 airport buildings and equipment necessary and proper to maintain, and conduct such airport  
2.33 and air navigation facilities connected therewith. The commissioner shall not expend money  
2.34 for land acquisition, or for the construction, improvement, or maintenance of airports, or

3.1 for air navigation facilities for an airport, unless the ~~governmental unit~~ municipality, county,  
 3.2 or joint airport zoning board involved has or is establishing a zoning authority for that  
 3.3 airport, and the authority has made a good-faith showing that it is in the process of and will  
 3.4 complete with due diligence, an airport zoning ordinance in accordance with sections 360.061  
 3.5 to 360.074. The commissioner may provide funds to support airport safety projects that  
 3.6 maintain existing infrastructure, regardless of a zoning authority's efforts to complete a  
 3.7 zoning regulation. The commissioner may withhold funding from only the airport subject  
 3.8 to the proposed zoning ordinance. Notwithstanding the foregoing prohibition, the  
 3.9 commissioner may continue to maintain the state-owned airport at Pine Creek.

3.10 Sec. 4. Minnesota Statutes 2016, section 360.062, is amended to read:

3.11 **360.062 AIRPORT HAZARD PREVENTION; PROTECTING EXISTING**  
 3.12 **NEIGHBORHOOD LAND USES.**

3.13 (a) It is hereby found that an airport hazard endangers the lives and property of users of  
 3.14 the airport and of occupants of land in its vicinity, and may reduce the size of the area  
 3.15 available for the landing, takeoff, and maneuvering of aircraft, thereby impairing the utility  
 3.16 of the airport and the public investment therein. It is also found that the social and financial  
 3.17 costs of disrupting existing land uses around airports ~~in built-up urban areas, particularly~~  
 3.18 ~~established residential neighborhoods,~~ often outweigh the benefits of a reduction in airport  
 3.19 hazards that might result from the elimination or removal of those uses.

3.20 (b) Accordingly, it is hereby declared: (1) ~~that~~ the creation or establishment of an airport  
 3.21 hazard is a public nuisance and an injury to the community served by the airport in question;  
 3.22 (2) ~~that~~ it is ~~therefor~~ necessary in the interest of the public health, public safety, and general  
 3.23 welfare that the creation or establishment of airport hazards be prevented and that this should  
 3.24 be accomplished to the extent legally possible, by exercise of the police power, without  
 3.25 compensation; and (3) ~~that~~ the elimination or removal of existing land uses, ~~particularly~~  
 3.26 ~~established residential neighborhoods in built-up urban areas,~~ or their designation as  
 3.27 nonconforming uses is not in the public interest and should be avoided whenever possible  
 3.28 consistent with reasonable standards of safety.

3.29 (c) It is further declared that the prevention of the creation or establishment of airport  
 3.30 hazards and the elimination, removal, alteration, mitigation, or marking and lighting of  
 3.31 existing airport hazards are essential public purposes services for which political subdivisions  
 3.32 may raise and expend public funds and acquire land or property interests therein.

4.1 Sec. 5. Minnesota Statutes 2016, section 360.063, subdivision 1, is amended to read:

4.2 Subdivision 1. **Enforcement under police power.** (a) In order to prevent the creation  
4.3 or establishment of airport hazards, every municipality having an airport hazard area within  
4.4 its territorial limits may, unless a joint airport zoning board is permitted under subdivision  
4.5 3, adopt, amend from time to time, administer, and enforce, under the police power and in  
4.6 the manner and upon the conditions hereinafter prescribed, airport zoning regulations for  
4.7 such airport hazard area, which regulations may divide such area into zones, and, within  
4.8 such zones, specify the land uses permitted and regulate and restrict the height to which  
4.9 structures and trees may be erected or allowed to grow.

4.10 (b) ~~For the purpose of promoting~~ In order to promote health, safety, order, convenience,  
4.11 prosperity, general welfare and ~~for conserving~~ to conserve property values and ~~encouraging~~  
4.12 encourage the most appropriate use of land, the municipality may regulate ~~the location, size~~  
4.13 ~~and use of buildings and the density of population in that portion of an airport hazard area~~  
4.14 ~~under approach zones for a distance not to exceed two miles from the airport boundary and~~  
4.15 ~~in other portions of an~~ in airport hazard area may regulate by land use zoning for a distance  
4.16 ~~not to exceed one mile from the airport boundary, and by height restriction zoning for a~~  
4.17 ~~distance not to exceed 1-1/2 miles from the airport boundary~~ areas: (1) land use; (2) height  
4.18 restrictions; (3) the location, size, and use of buildings; and (4) the density of population.

4.19 (c) The powers granted by this subdivision may be exercised by metropolitan airports  
4.20 commissions in contiguous cities of the first class in and for which they have been created.

4.21 (d) In the case of airports owned or operated by the state of Minnesota such powers shall  
4.22 be exercised by the state airport zoning boards or by the commissioner of transportation as  
4.23 authorized herein.

4.24 Sec. 6. Minnesota Statutes 2016, section 360.063, subdivision 3, is amended to read:

4.25 Subd. 3. **Joint airport zoning board.** (a) Where an airport is owned or controlled by a  
4.26 municipality and an airport hazard area appertaining to the airport is located within the  
4.27 territorial limits of another county or municipality, the municipality owning or controlling  
4.28 the airport may request a county or municipality in which an airport hazard area is located:

4.29 (1) to adopt and enforce airport zoning regulations for the area in question ~~that conform~~  
4.30 ~~to standards prescribed by the commissioner pursuant to subdivision 4~~ under sections  
4.31 360.0655 and 360.0656; or

4.32 (2) to join in creating a joint airport zoning board pursuant to paragraph (b). The owning  
4.33 or controlling municipality shall determine which of these actions it shall request, except

5.1 as provided in paragraph (e) for the Metropolitan Airports Commission. The request shall  
5.2 be made by certified mail to the governing body of each county and municipality in which  
5.3 an airport hazard area is located.

5.4 (b) Where an airport is owned or controlled by a municipality and an airport hazard area  
5.5 appertaining to the airport is located within the territorial limits of another county or  
5.6 municipality, the municipality owning or controlling the airport and the county or other  
5.7 municipality within which the airport hazard area is located may, by ordinance or resolution  
5.8 duly adopted, create a joint airport zoning board, which board shall have the same power  
5.9 to adopt, administer, and enforce airport zoning regulations applicable to the airport hazard  
5.10 area in question as that vested by subdivision 1 in the municipality within which the area  
5.11 is located. A joint board shall have as members two representatives appointed by the  
5.12 municipality owning or controlling the airport and two from the county or municipality, or  
5.13 in case more than one county or municipality is involved two from each county or  
5.14 municipality, in which the airport hazard is located, and in addition a chair elected by a  
5.15 majority of the members so appointed. All members shall serve at the pleasure of their  
5.16 respective appointing authority. Notwithstanding any other provision of law to the contrary,  
5.17 if the owning and controlling municipality is a city of the first class it shall appoint four  
5.18 members to the board, and the chair of the board shall be elected from the membership of  
5.19 the board.

5.20 (c) If a county or municipality, within 60 days of receiving a request from an owning  
5.21 or controlling municipality pursuant to paragraph (a), fails to adopt, or thereafter fails to  
5.22 enforce, the zoning regulations or fails to join in creating a joint airport zoning board, the  
5.23 owning or controlling municipality, or a joint airport zoning board created without  
5.24 participation by the subdivisions which fail to join the board, may itself adopt, administer,  
5.25 and enforce airport zoning regulations for the airport hazard area in question. In the event  
5.26 of conflict between the regulations and airport zoning regulations adopted by the county or  
5.27 municipality within which the airport hazard area is located, section 360.064, subdivision  
5.28 2, applies.

5.29 (d) "Owning or controlling municipality," as used in this subdivision, includes:

5.30 (1) a joint airport operating board created pursuant to section 360.042 that has been  
5.31 granted all the powers of a municipality in zoning matters under the agreement creating the  
5.32 board;

5.33 (2) a joint airport operating board created pursuant to section 360.042 that has not been  
5.34 granted zoning powers under the agreement creating the board; provided that the board shall

6.1 not itself adopt zoning regulations nor shall a joint airport zoning board created at its request  
 6.2 adopt zoning regulations unless all municipalities that created the joint operating board join  
 6.3 to create the joint zoning board; and

6.4 (3) the Metropolitan Airports Commission established and operated pursuant to chapter  
 6.5 473.

6.6 (e) The Metropolitan Airports Commission shall request creation of one joint airport  
 6.7 zoning board for each airport operated under its authority.

6.8 Sec. 7. Minnesota Statutes 2016, section 360.064, subdivision 1, is amended to read:

6.9 Subdivision 1. **Comprehensive regulations.** In the event that a municipality has adopted,  
 6.10 or hereafter adopts, a comprehensive zoning ordinance regulating, among other things the  
 6.11 height of buildings, any airport zoning regulations applicable to the same area or portion  
 6.12 thereof ~~may~~ must be incorporated in and made a part of such comprehensive zoning  
 6.13 regulations and be administered and enforced in connection therewith.

6.14 Sec. 8. Minnesota Statutes 2016, section 360.065, subdivision 1, is amended to read:

6.15 Subdivision 1. **Notice of proposed zoning regulations, hearing.** (a) No airport zoning  
 6.16 regulations shall be adopted, amended, or changed under sections 360.011 to 360.076,  
 6.17 except by action of the governing body of the municipality or county in question, or joint  
 6.18 airport zoning board under section 360.0655 or 360.0656, or the boards provided for in  
 6.19 section 360.063, subdivisions 3 and 7, or by the commissioner as provided in subdivisions  
 6.20 6 and 8, after public hearings, at which parties in interest and citizens shall have an  
 6.21 opportunity to be heard.

6.22 (b) A public hearing shall must be held on the proposed airport zoning regulations  
 6.23 proposed by a municipality, county, or joint airport zoning board before they are submitted  
 6.24 for approval to the commissioner and after that approval but before final adoption by the  
 6.25 local zoning authority for approval. If any changes that alter the regulations placed on a  
 6.26 parcel of land are made to the proposed airport zoning regulations after the initial public  
 6.27 hearing, the municipality, county, or joint airport zoning board must hold a second public  
 6.28 hearing before final adoption of the regulation. The commissioner may require a second  
 6.29 hearing as determined necessary.

6.30 (c) Notice of a hearing required pursuant to this subdivision shall must be published by  
 6.31 the local zoning authority municipality, county, or joint airport zoning board at least three  
 6.32 times during the period between 15 days and five days ten days before the hearing in an

7.1 ~~official newspaper and in a second newspaper designated by that authority which~~ at least  
 7.2 one general circulation newspaper that has a wide general circulation in the area affected  
 7.3 by the proposed regulations and posted on the municipality's, county's, or joint airport zoning  
 7.4 board's Web site. The notice shall not be published in the legal notice section of a newspaper.  
 7.5 must specify the time, location, and purpose of the hearing, and must identify any additional  
 7.6 location and time the proposed regulations will be available for public inspection. A copy  
 7.7 of the published notice must be added to the record of the proceedings.

7.8 ~~(d) Notice of a hearing shall also be mailed to the governing body of each political~~  
 7.9 ~~subdivision in which property affected by the regulations is located. Notice shall~~ must ~~be~~  
 7.10 ~~given by mail at least 15~~ ten ~~days before each hearing to any persons in municipalities that~~  
 7.11 ~~own land proposed to be included in safety zone A or B as provided in the rules of the~~  
 7.12 ~~Department of Transportation and~~ landowners where the location or size of a building, or  
 7.13 the density of population, will be regulated. Mailed notice must also be provided at least  
 7.14 ten days before each hearing to persons or municipalities that have previously requested  
 7.15 such notice from the ~~authority~~ municipality, county, or joint airport zoning board. The notice  
 7.16 must specify the time, location, and purpose of the hearing, and must identify any additional  
 7.17 location and time the proposed regulations will be made available for public inspection.  
 7.18 Mailed notice must also identify the property affected by the regulations. For the purpose  
 7.19 of ~~giving~~ providing mailed notice, the ~~authority~~ municipality, county, or joint airport zoning  
 7.20 board may use any appropriate records to determine the names and addresses of owners. A  
 7.21 copy of the notice and a list of the owners and addresses to which the notice was sent ~~shall~~  
 7.22 ~~be attested to by the responsible person and shall~~ must ~~be made a part of~~ added to the records  
 7.23 of the proceedings. ~~The Failure to give~~ provide mailed notice to individual property owners;  
 7.24 or ~~defects a defect in the notice, shall~~ does not invalidate the proceedings; ~~provided if a~~  
 7.25 bona fide attempt to comply with this subdivision ~~has been~~ was made. A notice shall describe  
 7.26 ~~the property affected by the proposed regulations and the restrictions to be imposed on the~~

7.29 **Sec. 9. [360.0655] AIRPORT ZONING REGULATIONS BASED ON**  
 7.30 **COMMISSIONER'S STANDARDS; SUBMISSION PROCESS.**

7.31 Subdivision 1. **Submission to commissioner; review.** (a) Except as provided in section  
 7.32 360.0656, prior to adopting zoning regulations, the municipality, county, or joint airport  
 7.33 zoning board must submit the proposed regulations to the commissioner for the commissioner  
 7.34 to determine whether the regulations conform to the standards prescribed by the  
 7.35 commissioner. The municipality, county, or joint airport zoning board may elect to complete

8.1 custom airport zoning under section 360.0656 instead of using the commissioner's standard,  
8.2 but only after providing written notice to the commissioner.

8.3 (b) The commissioner must examine the proposed regulations within 90 days of receipt  
8.4 of the regulations and report to the municipality, county, or joint airport zoning board the  
8.5 commissioner's approval or objections, if any. Failure to respond within 90 days is deemed  
8.6 an approval. The commissioner may request additional information from the municipality,  
8.7 county, or joint airport zoning board within the 90-day review period. If the commissioner  
8.8 requests additional information, the 90-day review period is tolled until the commissioner  
8.9 receives information and deems the information satisfactory.

8.10 (c) If the commissioner objects on the grounds that the regulations do not conform to  
8.11 the standards prescribed by the commissioner, the municipality, county, or joint airport  
8.12 zoning board must make amendments necessary to resolve the objections or provide written  
8.13 notice to the commissioner that the municipality, county, or joint airport zoning board will  
8.14 proceed with zoning under section 360.0656.

8.15 (d) If the municipality, county, or joint airport zoning board makes revisions to the  
8.16 proposed regulations after its initial public hearing, the municipality, county, or joint airport  
8.17 zoning board must conduct a second public hearing on the revisions and resubmit the revised  
8.18 proposed regulations to the commissioner for review. The commissioner must examine the  
8.19 revised proposed regulations within 90 days of receipt to determine whether the revised  
8.20 proposed regulations conform to the standards prescribed by the commissioner.

8.21 (e) If, after a second review period, the commissioner determines that the municipality,  
8.22 county, or joint airport zoning board failed to submit proposed regulations that conform to  
8.23 the commissioner's standards, the commissioner must provide a final written decision to  
8.24 the municipality, county, or joint airport zoning board.

8.25 (f) The municipality, county, or joint airport zoning board must not adopt regulations  
8.26 or take other action until the proposed regulations are approved by the commissioner.

8.27 (g) The commissioner may approve local zoning ordinances that are more stringent than  
8.28 the commissioner's standards.

8.29 (h) If the commissioner approves the proposed regulations, the municipality, county, or  
8.30 joint airport zoning board may adopt the regulations.

8.31 (i) A copy of the adopted regulations must be filed with the county recorder in each  
8.32 county that contains a zoned area subject to the regulations.



9.1 (j) Substantive rights that existed and had been exercised prior to August 1, 2017, are  
9.2 not affected by the filing of the regulations.

9.3 Subd. 2. **Protection of existing land uses.** (a) In order to ensure minimum disruption  
9.4 of existing land uses, the commissioner's airport zoning standards and local airport zoning  
9.5 ordinances or regulations adopted under section 360.0655 must distinguish between the  
9.6 creation or establishment of a use and the elimination of an existing use, and must avoid  
9.7 the elimination, removal, or reclassification of existing uses to the extent consistent with  
9.8 reasonable safety standards. The commissioner's standards must include criteria for  
9.9 determining when an existing land use may constitute an airport hazard so severe that public  
9.10 safety considerations outweigh the public interest in preventing disruption to that land use.

9.11 (b) Airport zoning regulations that classify as a nonconforming use or require  
9.12 nonconforming use classification with respect to any existing low-density structure or  
9.13 existing isolated low-density building lots must be adopted under sections 360.061 to  
9.14 360.074.

9.15 (c) A local airport zoning authority may classify a land use described in paragraph (b)  
9.16 as an airport hazard if the authority finds that the classification is justified by public safety  
9.17 considerations and is consistent with the commissioner's airport zoning standards. Any land  
9.18 use described in paragraph (b) that is classified as an airport hazard must be acquired, altered,  
9.19 or removed at public expense.

9.20 (d) This subdivision must not be construed to affect the classification of any land use  
9.21 under any zoning ordinances or regulations not adopted under sections 360.061 to 360.074.

9.22 **Sec. 10. [360.0656] CUSTOM AIRPORT ZONING STANDARDS.**

9.23 Subdivision 1. **Custom airport zoning standards; factors.** (a) Notwithstanding section  
9.24 360.0655, a municipality, county, or joint airport zoning board must provide notice to the  
9.25 commissioner when the municipality, county, or joint airport zoning board intends to establish  
9.26 and adopt custom airport zoning regulations under this section.

9.27 (b) Airport zoning regulations submitted to the commissioner under this subdivision are  
9.28 not subject to the commissioner's zoning regulations under section 360.0655 or Minnesota  
9.29 Rules, part 8800.2400.

9.30 (c) When developing and adopting custom airport zoning regulations under this section,  
9.31 the municipality, county, or joint airport zoning board must include in the record a detailed  
9.32 analysis that explains how the proposed custom airport zoning regulations addressed the  
9.33 following factors to ensure a reasonable level of safety:

- 10.1 (1) the location of the airport, the surrounding land uses, and the character of  
10.2 neighborhoods in the vicinity of the airport, including:
- 10.3 (i) the location of vulnerable populations, including schools, hospitals, and nursing  
10.4 homes, in the airport hazard area;
- 10.5 (ii) the location of land uses that attract large assemblies of people in the airport hazard  
10.6 area;
- 10.7 (iii) the availability of contiguous open spaces in the airport hazard area;
- 10.8 (iv) the location of wildlife attractants in the airport hazard area;
- 10.9 (v) airport ownership or control of the federal Runway Protection Zone and the  
10.10 department's Clear Zone;
- 10.11 (vi) land uses that create or cause interference with the operation of radio or electronic  
10.12 facilities used by the airport or aircraft;
- 10.13 (vii) land uses that make it difficult for pilots to distinguish between airport lights and  
10.14 other lights, result in glare in the eyes of pilots using the airport, or impair visibility in the  
10.15 vicinity of the airport;
- 10.16 (viii) land uses that otherwise inhibit a pilot's ability to land, take off, or maneuver the  
10.17 aircraft;
- 10.18 (ix) airspace protection to prevent the creation of air navigation hazards in the airport  
10.19 hazard area; and
- 10.20 (x) the social and economic costs of restricting land uses;
- 10.21 (2) the airport's type of operations and how the operations affect safety surrounding the  
10.22 airport;
- 10.23 (3) the accident rate at the airport compared to a statistically significant sample, including  
10.24 an analysis of accident distribution based on the rate with a higher accident incidence;
- 10.25 (4) the planned land uses within an airport hazard area, including any applicable platting,  
10.26 zoning, comprehensive plan, or transportation plan; and
- 10.27 (5) any other information relevant to safety or the airport.
- 10.28 Subd. 2. **Submission to commissioner; review.** (a) Except as provided in section  
10.29 360.0655, prior to adopting zoning regulations, the municipality, county, or joint airport  
10.30 zoning board must submit its proposed regulations and the supporting record to the  
10.31 commissioner for review. The commissioner must determine whether the proposed custom

11.1 airport zoning regulations and supporting record (1) evaluate the criteria under subdivision  
11.2 1, and (2) provide a reasonable level of safety.

11.3 (b) The commissioner must examine the proposed regulations within 90 days of receipt  
11.4 of the regulations and report to the municipality, county, or joint airport zoning board the

The commissioner shall immediately examine the proposed regulations and report to the municipality, county, or joint airport zoning board the commissioner's approval, or objections, if any. If objections are made by the commissioner on the ground that the regulations do not conform to the standards prescribed by the commissioner for the class of airport involved, the municipality, county, or joint zoning board shall make amendments as are necessary to meet the objections unless it demonstrates that the social and economic costs of restricting land uses in accordance with the standards outweigh the benefits of a strict application of the standards. The governing body of the municipality or county or the joint airport zoning board shall not adopt the regulations or take other action until the proposed regulations are approved by the commissioner. The commissioner may approve local zoning ordinances that are more stringent than the standards. A copy of the regulations as adopted shall be filed with the county recorder in each county in which the zoned area is located.

Substantive rights existing prior to the passage of this subdivision and previously exercised are not affected by the filing of the regulations.

**360.066 AIRPORT ZONING; MINIMUM STANDARDS, LAND USES.**

Subd. 1a. **Protection of existing neighborhood.** (a) In order to ensure the minimum disruption of existing land uses, particularly established residential neighborhoods in built-up urban areas, the airport zoning standards of the commissioner and the local airport zoning ordinances or regulations adopted under sections 360.061 to 360.074 shall distinguish between the creation or establishment of a use and the elimination of an existing use, and shall avoid the elimination, removal, or reclassification of existing uses to the extent consistent with reasonable standards of safety. The standards of the commissioner shall include criteria for determining when an existing land use may constitute an airport hazard so severe that considerations of public safety outweigh the public interest in preventing disruption to that land use.

(b) No airport zoning standards or local airport zoning ordinances or regulations shall be adopted pursuant to sections 360.061 to 360.074 that classify as a nonconforming use or require such classification with respect to any low-density residential structure or isolated low-density residential building lots existing on January 1, 1978 in an established residential neighborhood.

(c) A local airport zoning authority may classify a land use described in paragraph (b) as an airport hazard if that authority finds that this classification is justified by considerations of public safety and is consistent with the airport zoning standards of the commissioner. Any land use described in paragraph (b) which is classified as an airport hazard shall be acquired, altered, or removed at public expense.

(d) The provisions of this subdivision shall not be construed to affect the classification of any land use under any zoning ordinances or regulations not adopted pursuant to sections 360.061 to 360.074.

Subd. 1b. **Amendment of standards.** Within nine months after March 29, 1978, the commissioner shall amend the standards defining airport hazard areas and categories of uses permitted therein to conform with the requirements of Laws 1978, chapter 654. Until the commissioner adopts amended standards as required by this subdivision the unamended standards, insofar as they require classification of any residential property as a nonconforming use contrary to the provisions of subdivision 1a, paragraph (b), shall be without force or effect.
