1.11 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

1.12 **ARTICLE 1**
1.13 **PREDATORY OFFENDER REGISTRATION**

1.14 Section 1. Minnesota Statutes 2018, section 171.07, subdivision 1a, is amended to read:

1.15 Subd. 1a. **Filing photograph or image; data classification.** The department shall file,
1.16 or contract to file, all photographs or electronically produced images obtained in the process
1.17 of issuing drivers' licenses or Minnesota identification cards. The photographs or
1.18 electronically produced images shall be private data pursuant to section 13.02, subdivision
1.19 12. Notwithstanding section 13.04, subdivision 3, the department shall not be required to
1.20 provide copies of photographs or electronically produced images to data subjects. The use
1.21 of the files is restricted:

- 1.22 (1) to the issuance and control of drivers' licenses;
- 1.23 (2) to criminal justice agencies, as defined in section 299C.46, subdivision 2, for the
- 1.24 investigation and prosecution of crimes, service of process, enforcement of no contact
- 1.25 orders, location of missing persons, investigation and preparation of cases for criminal,

2.1 juvenile, and traffic court, location of individuals required to register under section 243.166
 2.2 or 243.167, and supervision of offenders;

2.3 (3) to public defenders, as defined in section 611.272, for the investigation and preparation
 2.4 of cases for criminal, juvenile, and traffic courts;

2.5 (4) to child support enforcement purposes under section 256.978; and

2.6 (5) to a county medical examiner or coroner as required by section 390.005 as necessary
 2.7 to fulfill the duties under sections 390.11 and 390.25.

2.8 Sec. 2. Minnesota Statutes 2018, section 243.166, subdivision 1a, is amended to read:

2.9 Subd. 1a. **Definitions.** (a) As used in this section, unless the context clearly indicates
 2.10 otherwise, the following terms have the meanings given them.

2.11 (b) "Bureau" means the Bureau of Criminal Apprehension.

2.12 (c) "Corrections agent" means a county or state probation agent or other corrections
 2.13 employee. Corrections agent also includes employees of the federal government who work
 2.14 with a person subject to this section.

2.15 ~~(d)~~ (d) "Dwelling" means the building where the person lives under a formal or informal
 2.16 agreement to do so. However, dwelling does not include a supervised publicly or privately
 2.17 operated shelter or facility designed to provide temporary living accommodations for
 2.18 homeless individuals as defined in section 116L.361, subdivision 5.

2.19 ~~(e)~~ (e) "Incarceration" and "confinement" do not include electronic home monitoring.

2.20 ~~(f)~~ (f) "Law enforcement authority" or "authority" means, ~~with respect to the chief of~~
 2.21 police of a home rule charter or statutory city, the chief of police, and with respect to the
 2.22 county sheriff of an unincorporated area, the county sheriff in that county. An authority
 2.23 must be located in Minnesota.

2.24 ~~(g)~~ (g) "Motor vehicle" has the meaning given in section 169.011, subdivision 92.

2.25 ~~(h)~~ (h) "Primary address" means the mailing address of the person's dwelling. If the
 2.26 mailing address is different from the actual location of the dwelling, primary address also
 2.27 includes the physical location of the dwelling described with as much specificity as possible.

2.28 ~~(i)~~ (i) "School" includes any public or private educational institution, including any
 2.29 secondary school, trade, or professional institution, or institution of higher education, that
 2.30 the person is enrolled in on a full-time or part-time basis.

3.1 ~~(j)~~ (j) "Secondary address" means the mailing address of any place where the person
3.2 regularly or occasionally stays overnight when not staying at the person's primary address.
3.3 If the mailing address is different from the actual location of the place, secondary address
3.4 also includes the physical location of the place described with as much specificity as possible.
3.5 However, the location of a supervised publicly or privately operated shelter or facility
3.6 designated to provide temporary living accommodations for homeless individuals as defined
3.7 in section 116L.361, subdivision 5, does not constitute a secondary address.

3.8 ~~(k)~~ (k) "Treatment facility" means a residential facility, as defined in section 244.052,
3.9 subdivision 1, and residential chemical dependency treatment programs and halfway houses
3.10 licensed under chapter 245A, including, but not limited to, those facilities directly or
3.11 indirectly assisted by any department or agency of the United States.

3.12 ~~(l)~~ (l) "Work" includes employment that is full time or part time for a period of time
3.13 exceeding 14 days or for an aggregate period of time exceeding 30 days during any calendar
3.14 year, whether financially compensated, volunteered, or for the purpose of government or
3.15 educational benefit.

3.16 Sec. 3. Minnesota Statutes 2018, section 243.166, subdivision 1b, is amended to read:

3.17 Subd. 1b. **Registration required.** (a) A person shall register under this section if:

3.18 (1) the person was charged with or petitioned for a felony violation of or attempt to
3.19 violate, or aiding, abetting, or conspiracy to commit, any of the following, and convicted
3.20 of or adjudicated delinquent for that offense or another offense arising out of the same set
3.21 of circumstances:

3.22 (i) murder under section 609.185, paragraph (a), clause (2);

3.23 (ii) kidnapping under section 609.25;

3.24 (iii) criminal sexual conduct under section 609.342; 609.343; 609.344; 609.345; 609.3451,
3.25 subdivision 3; or 609.3453; or

3.26 (iv) indecent exposure under section 617.23, subdivision 3;

3.27 (2) the person was charged with or petitioned for a violation of, or attempt to violate, or
3.28 aiding, abetting, or conspiring to commit any of the following and convicted of or adjudicated
3.29 delinquent for that offense or another offense arising out of the same set of circumstances:

3.30 (i) criminal abuse in violation of section 609.2325, subdivision 1, paragraph (b);

3.31 (ii) false imprisonment in violation of section 609.255, subdivision 2;

4.1 (iii) solicitation, inducement, or promotion of the prostitution of a minor or engaging in
4.2 the sex trafficking of a minor in violation of section 609.322;

4.3 (iv) a prostitution offense in violation of section 609.324, subdivision 1, paragraph (a);

4.4 (v) soliciting a minor to engage in sexual conduct in violation of section 609.352,
4.5 subdivision 2 or 2a, clause (1);

4.6 (vi) using a minor in a sexual performance in violation of section 617.246; or

4.7 (vii) possessing pornographic work involving a minor in violation of section 617.247;
4.8 ~~and convicted of or adjudicated delinquent for that offense or another offense arising out~~
4.9 ~~of the same set of circumstances;~~

4.10 (3) the person was sentenced as a patterned sex offender under section 609.3455,
4.11 subdivision 3a; ~~or~~

4.12 (4) the person was charged with or petitioned for, including pursuant to a court martial,
4.13 violating a law of the United States, including the Uniform Code of Military Justice, similar
4.14 to the offenses described in clause (1), (2), or (3), and convicted of or adjudicated delinquent
4.15 for that offense or another offense arising out of the same set of circumstances; or

4.16 (5) the person was charged with or petitioned for a violation of a law similar to an offense
4.17 described in clause (1), (2), (3), or (4) in another country where there are sufficient safeguards
4.18 for fundamental fairness and due process for the accused and the person was convicted of
4.19 or adjudicated delinquent for that offense or another offense arising out of the same set of
4.20 circumstances.

4.21 (b) A person also shall register under this section if:

4.22 (1) the person was charged with or petitioned for an offense in another state that would
4.23 be a violation of a law described in paragraph (a) if committed in this state and convicted
4.24 of or adjudicated delinquent for that offense or another offense arising out of the same set
4.25 of circumstances;

4.26 (2) the person enters this state to reside, work, or attend school, or enters this state and
4.27 remains for 14 days or longer or for an aggregate period of time exceeding 30 days during
4.28 any calendar year; and

4.29 (3) ten years have not elapsed since the person was released from confinement or, if the
4.30 person was not confined, since the person was convicted of or adjudicated delinquent for
4.31 the offense that triggers registration, unless the person is subject to a longer registration

5.1 period under the laws of another state or country in which the person has been convicted
5.2 or adjudicated, or is subject to lifetime registration.

5.3 If a person described in this paragraph is subject to a longer registration period in another
5.4 state or country or is subject to lifetime registration, the person shall register for that time
5.5 period regardless of when the person was released from confinement, convicted, or
5.6 adjudicated delinquent.

5.7 (c) A person also shall register under this section if the person was committed pursuant
5.8 to a court commitment order under Minnesota Statutes 2012, section 253B.185, chapter
5.9 253D, Minnesota Statutes 1992, section 526.10, or a similar law of another state ~~or~~ the
5.10 United States, or another country, regardless of whether the person was convicted of any
5.11 offense.

5.12 (d) A person also shall register under this section if:

5.13 (1) the person was charged with or petitioned for a felony violation or attempt to violate
5.14 any of the offenses listed in paragraph (a), clause (1), or a similar law of another state ~~or~~
5.15 the United States, or another country, or the person was charged with or petitioned for a
5.16 violation of any of the offenses listed in paragraph (a), clause (2), or a similar law of another
5.17 state ~~or~~ the United States, or another country;

5.18 (2) the person was found not guilty by reason of mental illness or mental deficiency
5.19 after a trial for that offense, or found guilty but mentally ill after a trial for that offense, in
5.20 states or countries with a guilty but mentally ill verdict; and

5.21 (3) the person was committed pursuant to a court commitment order under section
5.22 253B.18 or a similar law of another state ~~or~~ the United States, or another country.

5.23 **EFFECTIVE DATE.** This section is effective August 1, 2019, and applies to crimes
5.24 committed on or after that date.

5.25 Sec. 4. Minnesota Statutes 2018, section 243.166, subdivision 2, is amended to read:

5.26 Subd. 2. **Notice.** When a person who is required to register under subdivision 1b,
5.27 paragraph (a), is sentenced or becomes subject to a juvenile court disposition order, the
5.28 court shall tell the person of the duty to register under this section and that, if the person
5.29 fails to comply with the registration requirements, information about the offender may be
5.30 made available to the public through electronic, computerized, or other accessible means.
5.31 The court may not modify the person's duty to register in the pronounced sentence or
5.32 disposition order. The court shall require the person to read and sign a form stating that the
5.33 duty of the person to register under this section has been explained. The court shall ~~forward~~

6.1 make available the signed ~~sex-offender registration~~ court notification form, the complaint,
6.2 and sentencing documents to the bureau. If a person required to register under subdivision
6.3 1b, paragraph (a), was not notified by the court of the registration requirement at the time
6.4 of sentencing or disposition, the assigned corrections agent shall notify the person of the
6.5 requirements of this section. If a person required to register under subdivision 1b, paragraph
6.6 (a), was not notified by the court of the registration requirement at the time of sentencing
6.7 or disposition and does not have a corrections agent, the law enforcement authority with
6.8 jurisdiction over the person's primary address shall notify the person of the requirements.
6.9 When a person who is required to register under subdivision 1b, paragraph (c) or (d), is
6.10 released from commitment, the treatment facility shall notify the person of the requirements
6.11 of this section. The treatment facility shall also obtain the registration information required
6.12 under this section and forward it to the bureau.

6.13 Sec. 5. Minnesota Statutes 2018, section 243.166, subdivision 4, is amended to read:

6.14 Subd. 4. **Contents of registration.** (a) The registration provided to the corrections agent
6.15 or law enforcement authority, must consist of a statement in writing signed by the person,
6.16 giving information required by the bureau, fingerprints, biological specimen for DNA
6.17 analysis as defined under section 299C.155, subdivision 1, and photograph of the person
6.18 taken at the time of the person's release from incarceration or, if the person was not
6.19 incarcerated, at the time the person initially registered under this section. The registration
6.20 information also must include a written consent form signed by the person allowing a
6.21 treatment facility or residential housing unit or shelter to release information to a law
6.22 enforcement officer about the person's admission to, or residence in, a treatment facility or
6.23 residential housing unit or shelter. Registration information on adults and juveniles may be
6.24 maintained together notwithstanding section 260B.171, subdivision 3.

6.25 (b) For persons required to register under subdivision 1b, paragraph (c), following
6.26 commitment pursuant to a court commitment under Minnesota Statutes 2012, section
6.27 253B.185, chapter 253D, Minnesota Statutes 1992, section 526.10, or a similar law of
6.28 another state ~~or~~, the United States, or another country, in addition to other information
6.29 required by this section, the registration provided to the corrections agent or law enforcement
6.30 authority must include the person's offense history and documentation of treatment received
6.31 during the person's commitment. This documentation is limited to a statement of how far
6.32 the person progressed in treatment during commitment.

6.33 (c) Within three days of receipt, the corrections agent or law enforcement authority shall
6.34 forward the registration information to the bureau. The bureau shall ascertain whether the

7.1 person has registered with the law enforcement authority in the area of the person's primary
7.2 address, if any, or if the person lacks a primary address, where the person is staying, as
7.3 required by subdivision 3a. If the person has not registered with the law enforcement
7.4 authority, the bureau shall ~~send one copy to~~ notify that authority.

7.5 (d) The corrections agent or law enforcement authority may require that a person required
7.6 to register under this section appear before the agent or authority to be photographed. The
7.7 agent or authority shall ~~forward~~ submit the photograph to the bureau.

7.8 (1) Except as provided in clause (2), the agent or authority may photograph any offender
7.9 at a time and frequency chosen by the agent or authority.

7.10 (2) The requirements of this paragraph shall not apply during any period where the
7.11 person to be photographed is: (i) committed to the commissioner of corrections and
7.12 incarcerated, (ii) incarcerated in a regional jail or county jail, or (iii) committed to the
7.13 commissioner of human services and receiving treatment in a secure treatment facility.

7.14 (e) During the period a person is required to register under this section, the following
7.15 provisions apply:

7.16 (1) Except for persons registering under subdivision 3a, the bureau shall mail a
7.17 verification form to the person's last reported primary address. This verification form must
7.18 provide notice to the offender that, if the offender does not return the verification form as
7.19 required, information about the offender may be made available to the public through
7.20 electronic, computerized, or other accessible means. For persons who are registered under
7.21 subdivision 3a, the bureau shall mail an annual verification form to the law enforcement
7.22 authority where the offender most recently reported. The authority shall provide the
7.23 verification form to the person at the next weekly meeting and ensure that the person
7.24 completes and signs the form and returns it to the bureau. Notice is sufficient under this
7.25 paragraph; if the verification form is sent by first class mail to the person's last reported
7.26 primary address, or for persons registered under subdivision 3a, to the law enforcement
7.27 authority where the offender most recently reported.

7.28 (2) The person shall mail the signed verification form back to the bureau within ten days
7.29 after receipt of the form, ~~stating on the form the current and last address of the person's~~
7.30 ~~residence and the other information required under subdivision 4a.~~ The person cannot change
7.31 any registration information as part of the verification process.

7.32 (3) In addition to the requirements listed in this section, an offender who is no longer
7.33 under correctional supervision for a registration offense, or a failure to register offense, but
7.34 who resides, works, or attends school in Minnesota, shall have an in-person contact with a

8.1 law enforcement authority as provided in this section. If the person resides in Minnesota,
 8.2 the in-person contact shall be with the law enforcement authority that has jurisdiction over
 8.3 the person's primary address or, if the person has no address, the location where the person
 8.4 is staying. If the person does not reside in Minnesota but works or attends school in this
 8.5 state, the person shall have an in-person contact with the law enforcement authority or
 8.6 authorities with jurisdiction over the person's school or workplace. During the month of the
 8.7 person's birth date, the person shall report to the authority to verify the accuracy of the
 8.8 registration information and to be photographed. Within three days of this contact, the
 8.9 authority shall enter information as required by the bureau into the predatory offender
 8.10 registration database and submit an updated photograph of the person to the bureau's
 8.11 predatory offender registration unit.

8.12 (4) If the person fails to mail the completed and signed verification form to the bureau
 8.13 within ten days after receipt of the form, or if the person fails to report to the law enforcement
 8.14 authority during the month of the person's birth date, the person is in violation of this section.

8.15 (5) For any person who fails to mail the completed and signed verification form to the
 8.16 bureau within ten days after receipt of the form and who has been determined to be subject
 8.17 to community notification pursuant to section 253D.32 or is a risk level III offender under
 8.18 section 244.052, the bureau shall immediately investigate and notify local law enforcement
 8.19 authorities to investigate the person's location and to ensure compliance with this section.
 8.20 The bureau also shall immediately give notice of the person's violation of this section to the
 8.21 law enforcement authority having jurisdiction over the person's last registered primary
 8.22 address or addresses.

8.23 (6) A law enforcement authority may determine whether the person is at that person's
 8.24 primary address, secondary address, or school or work location, if any, or the accuracy of
 8.25 any other information required under subdivision 4a if the person whose primary address,
 8.26 secondary address, or school or work location, if any, is within the authority's jurisdiction,
 8.27 regardless of the assignment of a corrections agent.

8.28 For persons required to register under subdivision 1b, paragraph (c), following
 8.29 commitment pursuant to a court commitment under Minnesota Statutes 2012, section
 8.30 253B.185, chapter 253D, Minnesota Statutes 1992, section 526.10, or a similar law of
 8.31 another state ~~or~~ the United States, or another country, the bureau shall comply with clause
 8.32 (1) at least ~~four~~ two times each year. For persons who, under section 244.052, are assigned
 8.33 to risk level III and who are no longer under correctional supervision for a registration
 8.34 offense or a failure to register offense, the bureau shall comply with clause (1) at least two
 8.35 times each year. For all other persons required to register under this section, the bureau shall

9.1 comply with clause (1) each year within 30 days of the anniversary date of the person's
9.2 initial registration.

9.3 ~~(f) When sending out a verification form, the bureau shall determine whether the person~~
9.4 ~~to whom the verification form is being sent has signed a written consent form as provided~~
9.5 ~~for in paragraph (a). If the person has not signed such a consent form, the bureau shall send~~
9.6 ~~a written consent form to the person along with the verification form. A person who receives~~
9.7 ~~this written consent form shall sign and return it to the bureau at the same time as the~~
9.8 ~~verification form.~~ For persons registered under this section on the effective date of this
9.9 section, each person, on or before one year from that date, must provide a biological specimen
9.10 for the purpose of DNA analysis to the probation agency or law enforcement authority
9.11 where that person is registered. A person who provides or has provided a biological specimen
9.12 for the purpose of DNA analysis under chapter 299C or section 609.117 meets the
9.13 requirements of this paragraph.

9.14 (g) For persons registered under this section on the effective date of this section, each
9.15 person, on or before one year from that date, must provide fingerprints to the probation
9.16 agency or law enforcement authority where that person is registered.

9.17 Sec. 6. Minnesota Statutes 2018, section 243.166, subdivision 4a, is amended to read:

9.18 Subd. 4a. **Information required to be provided.** (a) A person required to register under
9.19 this section shall provide to the corrections agent or law enforcement authority the following
9.20 information:

9.21 (1) the person's primary address;

9.22 (2) all of the person's secondary addresses in Minnesota, including all addresses used
9.23 for residential or recreational purposes;

9.24 (3) the addresses of all Minnesota property owned, leased, or rented by the person;

9.25 (4) the addresses of all locations where the person is employed;

9.26 (5) the addresses of all schools where the person is enrolled; ~~and~~

9.27 (6) the year, model, make, license plate number, and color of all motor vehicles owned
9.28 or regularly driven by the person;

9.29 (7) the expiration year for the motor vehicle license plate tabs of all motor vehicles
9.30 owned by the person; and

9.31 (8) all telephone numbers including work, school, and home and any cellular telephone
9.32 service.

10.1 (b) The person shall report to the agent or authority the information required to be
10.2 provided under paragraph (a), clauses (2) to ~~(6)~~ (8), within five days of the date the clause
10.3 becomes applicable. If because of a change in circumstances any information reported under
10.4 paragraph (a), clauses (1) to ~~(6)~~ (8), no longer applies, the person shall immediately inform
10.5 the agent or authority that the information is no longer valid. If the person leaves a primary
10.6 address and does not have a new primary address, the person shall register as provided in
10.7 subdivision 3a.

10.8 Sec. 7. Minnesota Statutes 2018, section 243.166, subdivision 4c, is amended to read:

10.9 Subd. 4c. **Notices in writing; signed.** All notices required by this section must be in
10.10 writing and signed by the person required to register. For purposes of this section, a signature
10.11 is as defined in section 645.44, subdivision 14, by an electronic method established by the
10.12 bureau, or by use of a biometric for the person. If a biometric is used, the person must
10.13 provide a sample that is forwarded to the bureau so that it can be maintained for comparison
10.14 purposes to verify the person's identity.

10.15 Sec. 8. Minnesota Statutes 2018, section 243.166, is amended by adding a subdivision to
10.16 read:

10.17 Subd. 4d. **Travel.** (a) A person required to register under this section who intends to
10.18 travel outside the boundaries of the United States must appear in person to notify the person's
10.19 corrections agent or the law enforcement authority with jurisdiction over the person's primary
10.20 address of the travel plans. The person must provide:

10.21 (1) anticipated departure date;

10.22 (2) place of departure;

10.23 (3) place of arrival or return;

10.24 (4) carrier and flight numbers for air travel;

10.25 (5) destination country and address or other contact information;

10.26 (6) means and purpose of travel;

10.27 (7) visa information, if any; and

10.28 (8) any other itinerary information requested by the corrections agent or law enforcement
10.29 authority.

10.30 (b) The notice must be provided at least 21 calendar days before the departure date and
10.31 forwarded to the bureau within one business day of receipt. If it is not possible to give 21

11.1 calendar days' notice due to an emergency or a work assignment, the person is required to
 11.2 notify the corrections agent or the law enforcement authority with jurisdiction over the
 11.3 person's primary address as soon as possible prior to departure. If the travel is due to an
 11.4 emergency, the person must provide a copy of the message conveying the emergency that
 11.5 includes the date and time sent and the source of the information. If the travel is the result
 11.6 of a work assignment, the employer must provide the date the employee was informed of
 11.7 the need to travel and the nature of the work to be performed.

11.8 (c) The corrections agent or law enforcement authority must forward the notification to
 11.9 the bureau as soon as possible after receipt. The bureau must forward the international travel
 11.10 information to the United States Marshals Service pursuant to International Megan's Law,
 11.11 Public Law 114-119.

11.12 (d) A person required to register under this section who is assigned a corrections agent
 11.13 must receive the corrections agent's approval for all international travel. Nothing in this
 11.14 subdivision requires a corrections agent to approve of travel that is inconsistent with the
 11.15 terms of the offender's supervision.

11.16 Sec. 9. Minnesota Statutes 2018, section 243.166, subdivision 5, is amended to read:

11.17 Subd. 5. **Criminal penalty.** (a) A person required to register under this section who was
 11.18 given notice, knows, or reasonably should know of the duty to register and who:

11.19 (1) knowingly commits an act or fails to fulfill a requirement that violates any of its
 11.20 provisions provision of this section; or

11.21 (2) intentionally provides false information to a corrections agent, law enforcement
 11.22 authority, or the bureau is guilty of a felony and may be sentenced to imprisonment for not
 11.23 more than five years or to payment of a fine of not more than \$10,000, or both.

11.24 (b) Except as provided in paragraph (c), a person convicted of violating paragraph (a)
 11.25 shall be committed to the custody of the commissioner of corrections for not less than a
 11.26 year and a day, nor more than five years.

11.27 (c) A person convicted of violating paragraph (a), who has previously been convicted
 11.28 of or adjudicated delinquent for violating this section or a similar statute of another state
