1.5	Section 1. PLANT-BASED FOOD RESEARCH AND DEVELOPMENT.
1.6	(a) The commissioner of agriculture must establish and administer a plant-based food
1.7	research and development pilot grant program to provide competitive grants to eligible
1.8	entities to support research and development projects to accelerate the scaleup and
1.9	commercialization of industry-advancing plant-based food products.
1.10	(b) Eligible grant activities under this section include:
1.11	(1) research to develop new crop varietals;
1.12	(2) the development of plant protein processing innovations, including biological methods
1.13	such as fermentation and enzymatic treatment for improving protein enrichment and
1.14	functionality;
1.15	(3) end food product formulation and manufacturing;
1.16	(4) the design of processing equipment for use in alternative protein production;

- 2.9 (b) No later than January 15, 2024, the commissioner of agriculture must report grant
- 2.10 activity and program outcomes to the legislative committees with jurisdiction over agriculture
- 2.11 policy and finance.
