Minnesota Statutes 2018, section 120B.36, subdivision 1, is amended to read: 1.6 Subdivision 1. School performance reports and public reporting. (a) The commissioner 1.7 shall must report student academic performance data under section 120B.35, subdivisions 1.8 2 and 3; the percentages of students showing low, medium, and high growth under section 1.9 120B.35, subdivision 3, paragraph (b); school safety and student engagement and connection 1.10 under section 120B.35, subdivision 3, paragraph (d); rigorous coursework under section 1.11 120B.35, subdivision 3, paragraph (c); the percentage of students under section 120B.35, 1.12 subdivision 3, paragraph (b), clause (2), whose progress and performance levels are meeting 1.13 career and college readiness benchmarks under sections 120B.30, subdivision 1, and 120B.35, 1.14 subdivision 3, paragraph (e); longitudinal data on the progress of eligible districts in reducing 115 disparities in students' academic achievement and realizing racial and economic integration 1.16 under section 124D.861; the acquisition of English, and where practicable, native language 1.17 academic literacy, including oral academic language, and the academic progress of all 1.18 English learners enrolled in a Minnesota public school course or program who are currently 1.19 or were previously counted as English learners under section 124D.59; two separate 1.20 student-to-teacher ratios that clearly indicate the definition of teacher consistent with sections 1.21 122A.06 and 122A.15 for purposes of determining these ratios; staff characteristics excluding 1.22 salaries; student enrollment demographics; foster care status, including all students enrolled 1.23

in a Minnesota public school course or program who are currently or were previously in
foster care, student homelessness, and district mobility; and extracurricular activities.
(b) The school performance report for a school site and a school district must include
school performance reporting information and calculate proficiency rates as required by the

 until the commissioner publicly releases the data. The commissioner shall annually post
 school performance reports to the department's public website no later than September 1,
 except that in years when the reports reflect new performance standards, the commissioner
 shall post the school performance reports no later than October 1.

Subdivision 1. Task force established; membership. The commissioner of education 2.24 must appoint an advisory task force to advise the commissioner on how to improve the 2.25 accessibility and functionality of the school performance reports required under Minnesota 2.26 Statutes, section 120B.36. The advisory task force must include at least five members. At 2.27 least half of the task force must consist of parents or guardians of children participating or 2.28 enrolled in a prekindergarten program or students in grades kindergarten through grade 12. 2.29 The commissioner must, in appointing members of the task force, give preference to the 2.30 parents or guardians of students enrolled in a school that receives funds under Title I, Part 2.31 A, of the most recently reauthorized Elementary and Secondary Education Act. 2.32
