1.7	Subd. 2e. Cross subsidy reduction aid. (a) A school district's annual cross subsidy
1.8	reduction aid equals (1) the school district's initial special education cross subsidy for the
1.9	previous fiscal year times the cross subsidy aid factor for that fiscal year, less (2) the district's
1.10	special education general education reduction defined in paragraph (c).
1.11	(b) The cross subsidy aid factor equals 2.6 percent for fiscal year 2020 and 6.43 percent
1.12	for fiscal year 2021 2023 and 100 percent for fiscal year 2024 and later.
1.13	(c) A district's special education general education reduction equals the general education
1.14	revenue attributable to special education students who spend 60 percent or more of the
1.15	school day outside of the regular classroom receiving special education services. This
1.16	calculation must be prepared according to the methodology outlined in the annual special
1.17	education cross subsidy report prepared by the Department of Education.
