Minnesota Statutes 2020, section 290.01, subdivision 7, is amended to read: 1.5 Subd. 7. Resident. (a) The term "Resident" means any individual domiciled in Minnesota, 1.6 except that: 1.7 (1) an individual is not domiciled in this state if before the close of the taxable year the 1.8 individual files an affidavit with the commissioner stating that the individual is domiciled 1.9 in another state or country; or 1.10 (2) an individual is not a "resident" for the period of time that the individual is a "qualified 1.11 individual" as defined in section 911(d)(1) of the Internal Revenue Code, if the qualified 1.12 individual notifies the county within three months of moving out of the country that 1.13 homestead status be revoked for the Minnesota residence of the qualified individual, and 1.14 the property is not classified as a homestead while the individual remains a qualified 1.15 individual. 1.16 An affidavit filed under clause (1) must be made in the form prescribed by the commissioner 1.17 and remains in effect until revoked. - (c) For purposes of this subdivision, presence within the state for any part of a an individual must be present in this state for substantially all of a calendar day constitutes, including an overnight stay, to constitute a day spent in the state. Presence in Minnesota for the primary purpose of receiving medical treatment by an individual, or the spouse, child, or parent of the individual, is not treated as a day spent in Minnesota. For purposes of this section, "medical treatment" is treatment as defined in section 213(d)(1)(A) of the Internal Revenue Code. Individuals shall keep adequate records to substantiate the days spent outside the state.
- (d) The term "Abode" means a dwelling maintained by an individual, whether or not owned by the individual and whether or not occupied by the individual, and includes a dwelling place owned or leased by the individual's spouse.
- (e) (e) In determining where an individual is domiciled, neither the commissioner nor any court shall consider:
 - (1) charitable contributions made by the individual within or without the state;
- (2) the location of the individual's attorney, certified public accountant, or financial adviser; or
