1.9	Subd. 1a. Transmittal of fees to commissioner of management and budget. (a) Every
1.10	person, including the state of Minnesota and all bodies politic and corporate, who shall
1.11	transact any business in the district court, shall pay to the court administrator of said court
1.12	the sundry fees prescribed in subdivision 2. Except as provided in paragraph (d), the court
1.13	administrator shall transmit the fees monthly to the commissioner of management and budget
1.14	for deposit in the state treasury and credit to the general fund. $\frac{30}{60}$ of each fee collected
1.15	in a dissolution action under subdivision 2, clause (1), must be deposited by the commissioner
1.16	of management and budget in the special revenue fund and is appropriated to the
