

1.1 A bill for an act

1.2 relating to state lands; modifying method of determining value of acquired
1.3 stream easements; providing for certain historic property exemption; modifying
1.4 state forest acquisition provisions; modifying certain requirements for land sales;
1.5 adding to and deleting from state parks and state forests; authorizing public
1.6 and private sales, conveyances, and exchanges of certain state land; amending
1.7 Minnesota Statutes 2008, sections 84.0272, subdivision 2; 85.012, subdivision
1.8 40; 89.032, subdivision 2; Laws 2005, chapter 156, article 2, section 45, as
1.9 amended; Laws 2009, chapter 176, article 4, section 9; proposing coding for new
1.10 law in Minnesota Statutes, chapter 85.

1.11 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

1.12 Section 1. Minnesota Statutes 2008, section 84.0272, subdivision 2, is amended to read:

1.13 Subd. 2. **Stream easements.** (a) Notwithstanding subdivision 1, the commissioner
1.14 may acquire permanent stream easements for angler access, fish management, and habitat
1.15 work for a onetime payment based on a value attributed to both the stream and the
1.16 easement corridor. The payment shall equal:

1.17 (1) the per linear foot of stream within the easement corridor times \$5; plus

1.18 (2) the easement corridor acres times the estimated market value.

1.19 (b) The estimated market value is equal to:

1.20 (1) ~~the total farm market value plus the timberlands value~~ agricultural market value
1.21 plus the rural vacant market value plus the managed forest market value; divided by

1.22 (2) ~~the acres of deeded farmland plus the acres of timber~~ agricultural land plus the
1.23 rural vacant land plus the managed forest land.

1.24 (c) ~~The total farm market value, timberlands value, acres of deeded farmland, and~~
1.25 ~~acres of timber~~ agricultural market value, rural vacant market value, and managed forest
1.26 market value or equivalent are determined from data collected by the Department of
1.27 Revenue during its annual spring mini abstract survey. If the Department of Revenue

2.1 changes its property type groups for its annual spring mini abstract survey, the agricultural
2.2 market value, the rural vacant market value, and the managed forest market value shall be
2.3 determined by the commissioner from data collected by the Department of Revenue in a
2.4 manner that provides the most reasonable substitute for the market values as presently
2.5 reported. The commissioner must use the most recent available data for the city or
2.6 township within which the easement corridor is located.

2.7 (d) The commissioner shall periodically review the easement payment rates under
2.8 this subdivision to determine whether the stream easement payments reflect current
2.9 shoreland market values. If the commissioner determines that the easements do not reflect
2.10 current shoreland market values, the commissioner shall report to the senate and house of
2.11 representatives natural resources policy committees with recommendations for changes
2.12 to this subdivision that are necessary for the stream easement payment rates to reflect
2.13 current shoreland market values. The recommendations may include an adjustment to the
2.14 dollar amount in paragraph (a), clause (1).

2.15 Sec. 2. Minnesota Statutes 2008, section 85.012, subdivision 40, is amended to read:

2.16 Subd. 40. McCarthy Beach State Park, St. Louis ~~County~~ and Itasca Counties, which
2.17 is hereby renamed from McCarthy Beach Memorial State Park.

2.18 Sec. 3. **[85.0144] HILL-ANNEX MINE STATE PARK; HISTORIC PROPERTY**
2.19 **EXEMPTION.**

2.20 In accordance with Laws 1988, chapter 686, article 1, section 53, that provided that
2.21 mining may be conducted on Hill-Annex Mine State Park in the future and that portions
2.22 of the surface estate may be necessary for these mining operations, section 138.665,
2.23 subdivision 2, does not apply to the removal of any taconite or any iron-bearing material
2.24 stockpiles within the Hill-Annex Mine State Park.

2.25 Sec. 4. Minnesota Statutes 2008, section 89.032, subdivision 2, is amended to read:

2.26 Subd. 2. **Acquisition for state forests.** The commissioner may acquire lands or
2.27 interest in lands for state forest purposes. The land or interests in land may be subject
2.28 to mineral reservations.

2.29 Sec. 5. Laws 2005, chapter 156, article 2, section 45, as amended by Laws 2007,
2.30 chapter 148, article 2, section 73, as amended by Laws 2009, chapter 37, article 1, section
2.31 59, is amended to read:

2.32 Sec. 45. **SALE OF STATE LAND.**

3.1 Subdivision 1. **State land sales.** (a) The commissioner of administration shall
3.2 coordinate with the head of each department or agency having control of state-owned land
3.3 to identify and sell at least \$6,440,000 of state-owned land. Sales should be completed
3.4 according to law and as provided in this section as soon as practicable but no later than
3.5 June 30, 2011. Notwithstanding Minnesota Statutes, sections 16B.281 and 16B.282, 94.09
3.6 and 94.10, or any other law to the contrary, the commissioner may offer land for public
3.7 sale by only providing notice of lands or an offer of sale of lands to state departments or
3.8 agencies, the University of Minnesota, cities, counties, towns, school districts, or other
3.9 public entities.

3.10 (b) Of the amount required under paragraph (a), the commissioner of natural
3.11 resources shall sell \$2,216,000 of state-owned land for anticipated savings.

3.12 Subd. 2. **Anticipated savings.** (a) Notwithstanding Minnesota Statutes, section
3.13 94.16, subdivision 3, or other law to the contrary, the amount of the proceeds from the
3.14 sale of land under this section that exceeds the actual expenses of selling the land must
3.15 be deposited in the general fund, except as otherwise provided by the commissioner of
3.16 finance. Notwithstanding Minnesota Statutes, section 94.11 or 16B.283, the commissioner
3.17 of finance may establish the timing of payments for land purchased under this section.
3.18 Except as provided in paragraph (b), if the total of all money deposited into the general
3.19 fund from the proceeds of the sale of land under this section is anticipated to be less
3.20 than \$6,440,000, the governor must allocate the amount of the difference as reductions
3.21 to general fund operating expenditures for other executive agencies for the biennium
3.22 ending June 30, 2011.

3.23 (b) Notwithstanding paragraph (a), reductions in operating expenditures for the
3.24 Department of Natural Resources may be made only for the difference in anticipated
3.25 savings under subdivision 1, paragraph (b).

3.26 Subd. 3. **Sale of state lands revolving loan fund.** \$290,000 is appropriated from
3.27 the general fund in fiscal year 2006 to the commissioner of administration for purposes
3.28 of paying the actual expenses of selling state-owned lands to achieve the anticipated
3.29 savings required in this section. From the gross proceeds of land sales under this section,
3.30 the commissioner of administration must cancel the amount of the appropriation in this
3.31 subdivision to the general fund by June 30, 2011.

3.32 **EFFECTIVE DATE.** This section is effective the day following final enactment.

3.34 Sec. 9. **PRIVATE SALE OF SURPLUS LAND; CLEARWATER COUNTY.**

4.1 (a) Notwithstanding Minnesota Statutes, sections 94.09 and 94.10, the commissioner
4.2 of natural resources may sell by private sale the surplus land that is described in paragraph
4.3 (c).

4.4 (b) The conveyance must be in a form approved by the attorney general. The
4.5 attorney general may make necessary changes to the legal description to correct errors
4.6 and ensure accuracy. The commissioner may sell the land to the White Earth Band of
4.7 Ojibwe for ~~less than the value of the land as determined by the commissioner~~ \$1, but the
4.8 conveyance must provide that the land be used for the public and reverts to the state
4.9 if the band fails to provide for public use or abandons the public use of the land. The
4.10 conveyance may reserve an easement for ingress and egress.

4.11 (c) The land that may be sold is located in Clearwater County and is described as:
4.12 the West 400 feet of the South 750 feet of Government Lot 3, Section 31, Township 145
4.13 North, Range 38 West, containing 6.89 acres, more or less.

4.14 (d) The Department of Natural Resources has determined that the land and building

4.33 follows: commencing at the northeast corner of Section 14, proceed West, a distance

5.34 the Northwest Quarter of the Northwest Quarter, the Northeast Quarter of the Northwest
5.35 Quarter, and the Northwest Quarter of the Northeast Quarter, all in Section 5, Township
5.36 62 North, Range 3 East.

6.1 Subd. 3. [85.012] [Subd. 54.] Split Rock Lighthouse State Park, Lake County.

6.2 The following areas are added to Split Rock Lighthouse State Park, all in Lake County: the
6.3 Southeast Quarter of the Northwest Quarter and the Southwest Quarter of the Northeast
6.4 Quarter, all in Section 32, Township 55 North, Range 8 West.

6.5 Subd. 4. [85.012] [Subd. 55a.] Tettegouche State Park, Lake County. The
6.6 following areas are added to Tettegouche State Park:

6.7 (1) that part of Government Lot 2, Section 15, Township 56, Range 7, Lake County,
6.8 Minnesota, described as follows: commencing at the quarter corner between said Section

8.28 (a) Notwithstanding Minnesota Statutes, sections 94.09 and 94.10, the commissioner
8.29 of natural resources may sell by private sale to a political subdivision the surplus land
8.30 that is described in paragraph (c).

8.31 (b) The conveyance must be in a form approved by the attorney general. The
8.32 attorney general may make necessary changes to the legal description to correct errors
8.33 and ensure accuracy.

9.1 (c) The land that may be sold is located in Anoka County and is described as: the
9.2 East Half of the Southeast Quarter of Section 25, Township 32 North, Range 22 West,
9.3 Anoka County, Minnesota, containing 80 acres, more or less.

9.4 (d) The Department of Natural Resources has determined that the state's land
9.5 management interests would best be served if the land was conveyed to a political
9.6 subdivision. A political subdivision would like to use this parcel as a wetland mitigation
9.7 site.

9.8 Sec. 11. **PUBLIC SALE OF SURPLUS STATE LAND BORDERING PUBLIC**
9.9 **WATER; BELTRAMI COUNTY.**

9.10 (a) Notwithstanding Minnesota Statutes, section 92.45, the commissioner of natural
9.11 resources may sell by public sale the surplus land bordering public water that is described
9.12 in paragraph (c).

9.13 (b) The conveyance must be in a form approved by the attorney general. The
9.14 attorney general may make necessary changes to the legal description to correct errors and
9.15 ensure accuracy. The conveyance must include a reservation of perpetual road easements
9.16 described in paragraph (c) to the state for ingress and egress for constructing, repairing,
9.17 maintaining, and operating an adjacent northern pike spawning and rearing area.

9.18 (c) The land that may be sold is located in Beltrami County and is described as:
9.19 All that part of the Southwest Quarter of the Southwest Quarter and Government Lot 1,
9.20 Section 21, Township 146 North, Range 31 West, bounded by the water's edge of Cass
9.21 Lake and the following described lines: Commencing at the southwest corner of said
