1.6	Subdivision 1. Appropriation. \$140,000 is appropriated from the bond proceeds fund
1.7	to the Board of Trustees of the Minnesota State Colleges and Universities for repair and
1.8	renovation of the air conditioning system on the North Hennepin Community College
1.9	campus, to be spent in accordance with Minnesota Statutes, section 135A.046.
1.10	Subd. 2. Bond sale. To provide the money appropriated in this section from the bond
1.11	proceeds fund, the commissioner of management and budget shall sell and issue bonds of
