A county agricultural society must 1.9 annually determine the amount of sales tax savings attributable to section 297A.70, 1.10 subdivision 21. If the county agricultural society owns its own fairgrounds, it, and must use 1.11 the amount equal to the sales tax savings to maintain, improve, or expand society-owned 1.12 buildings and facilities on the fairgrounds; otherwise it must transfer this amount to the 1.13 owner of the fairgrounds.
