1.6	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:
1.7	Section 1. [136F.38] PROGRAM FOR STUDENTS WITH INTELLECTUAL AND
1.8	DEVELOPMENTAL DISABILITIES.
1.9	Subdivision 1. Program required. The Board of Trustees of the Minnesota State Colleges
1.10	and Universities must offer an academic program for students with intellectual and
1.11	developmental disabilities consistent with subdivisions 2 to 4.
1.12	Subd. 2. Program locations. The program must be offered at no less than two college
1.13	or university campuses. The board must choose the campuses based on:
1.14	(1) the school's ability to offer a robust program using existing facilities and resources;
1.15	<u>and</u>
1.16	(2) a goal to provide the program in diverse geographic regions of the state.
1.17	Subd. 3. Enrollment and admission. Each campus offering a program must establish
1.18	an enrollment goal of at least 15 incoming students per academic year. The board must
1.19	establish an application process for the program. A student who successfully completes the
1.20	program must be awarded a certificate, diploma, or other appropriate academic credential.
1.21	Subd. 4. Curriculum and activities. (a) The program must provide an inclusive,
1.22	full-time, two-year residential college experience for students with intellectual and

2.6	(b) In addition to academic requirements, the program must allow participating students
