(d) The commissioner of human services shall seek federal approval to modify the redetermination of eligibility requirements under Minnesota Statutes, section 256L.05, subdivision 3a, requiring eligibility redetermination for MinnesotaCare enrollees every 12 months with the 12-month period beginning the month after the month the application was approved.

(e) The commissioners of commerce and human services shall inform the chairs and ranking minority members of the legislative committees with jurisdiction over commerce and health care when federal approval has been granted or denied.
