1.6 2, 3; 121A.031, subdivisions 5, 6; 121A.41, subdivision 10, by adding subdivisions;  
1.7 121A.45, subdivision 1; 121A.46, subdivision 4, by adding a subdivision; 121A.47,  
1.8 subdivisions 2, 14; 121A.53, subdivision 1; 121A.55; 122A.40, subdivision 8;  
1.9 122A.41, subdivision 5; 123B.09, subdivision 2; 123B.147, subdivision 3;

1.13 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

1.14 **ARTICLE 1**  
1.15 **GENERAL EDUCATION**

1.16 Section 1. Minnesota Statutes 2018, section 120B.11, subdivision 2, is amended to read:

1.17 Subd. 2. **Adopting plans and budgets.** A school board, at a public meeting, ~~shall~~ must  
1.18 adopt a comprehensive, long-term strategic plan to support and improve teaching and  
1.19 learning that is aligned with creating the world's best workforce and includes:

1.20 (1) clearly defined district and school site goals and benchmarks for instruction and  
1.21 student achievement for all student subgroups identified in section 120B.35, subdivision 3,  
1.22 paragraph (b), clause (2);

1.23 (2) a process to assess and evaluate each student's progress toward meeting state and  
1.24 local academic standards, assess and identify students to participate in gifted and talented  
1.25 programs and accelerate their instruction, and adopt early-admission procedures consistent  
1.26 with section 120B.15, and identifying the strengths and weaknesses of instruction in pursuit

2.1 of student and school success and curriculum affecting students' progress and growth toward  
2.2 career and college readiness and leading to the world's best workforce;

2.3 (3) a system to periodically review and evaluate the effectiveness of all instruction and  
2.4 curriculum, taking into account strategies and best practices, student outcomes, school  
2.5 principal evaluations under section 123B.147, subdivision 3, students' access to effective  
2.6 teachers who are members of populations underrepresented among the licensed teachers in  
2.7 the district or school and who reflect the diversity of enrolled students under section 120B.35,  
2.8 subdivision 3, paragraph (b), clause (2), and teacher evaluations under section 122A.40,  
2.9 subdivision 8, or 122A.41, subdivision 5;

2.10 (4) strategies for improving instruction, curriculum, and student achievement, including  
2.11 (i) the English and, where practicable, the native language development and the academic  
2.12 achievement of English learners; and (ii) for all learners, access to culturally relevant or  
2.13 ethnic studies curriculum using culturally responsive methodologies;

2.14 (5) a process to examine the equitable distribution of teachers and strategies to ensure  
2.15 ~~low-income and minority~~ children from low-income families, families of color, and American  
2.16 Indian families are not taught at higher rates than other children by inexperienced, ineffective,  
2.17 or out-of-field teachers;

2.18 (6) education effectiveness practices that integrate high-quality instruction;; rigorous  
2.19 curriculum;; technology;; inclusive and respectful learning and work environments for all  
2.20 students, families, and staff; and a collaborative professional culture that ~~develops and~~  
2.21 ~~supports~~ retains qualified and racially, ethnically, and linguistically diverse staff effective  
2.22 at working with diverse students while developing and supporting teacher quality,  
2.23 performance, and effectiveness; and

2.24 (7) an annual budget for continuing to implement the district plan.

2.25 **EFFECTIVE DATE.** This section is effective for all strategic plans reviewed and  
2.26 updated after the day of final enactment.

2.27 Sec. 2. Minnesota Statutes 2018, section 120B.11, subdivision 3, is amended to read:

2.28 Subd. 3. **District advisory committee.** Each school board ~~shall~~ must establish an advisory  
2.29 committee to ensure active community participation in all phases of planning and improving  
2.30 the instruction and curriculum affecting state and district academic standards, consistent  
2.31 with subdivision 2. A district advisory committee, to the extent possible, ~~shall~~ must reflect  
2.32 the diversity of the district and its school sites, include teachers, parents, support staff,  
2.33 students, and other community residents, and provide translation to the extent appropriate

3.1 and practicable. The district advisory committee ~~shall~~ must pursue community support to  
 3.2 accelerate the academic and native literacy and achievement of English learners with varied  
 3.3 needs, from young children to adults, consistent with section 124D.59, subdivisions 2 and  
 3.4 2a. The district may establish site teams as subcommittees of the district advisory committee  
 3.5 under subdivision 4. The district advisory committee ~~shall~~ must recommend to the school  
 3.6 board rigorous academic standards; student achievement goals and measures consistent  
 3.7 with subdivision 1a and sections 120B.022, subdivisions 1a and 1b, and 120B.35; district  
 3.8 assessments; means to improve students' equitable access to effective and more diverse  
 3.9 teachers; strategies to ensure the curriculum and learning and work environments are  
 3.10 inclusive and respectful toward all racial and ethnic groups; and program evaluations. School  
 3.11 sites may expand upon district evaluations of instruction, curriculum, assessments, or  
 3.12 programs. Whenever possible, parents and other community residents ~~shall~~ must comprise  
 3.13 at least two-thirds of advisory committee members.

3.14 **EFFECTIVE DATE.** This section is effective for all strategic plans reviewed and  
 3.15 updated after the day of final enactment.

3.16 Sec. 3. Minnesota Statutes 2018, section 123B.09, subdivision 2, is amended to read:

3.17 Subd. 2. **School board member training.** A member shall receive training in school  
 3.18 finance and management developed in consultation with the Minnesota School Boards  
 3.19 Association and consistent with section 127A.19. The School Boards Association must  
 3.20 make available to each newly elected school board member training in school finance and  
 3.21 management consistent with section 127A.19 within 180 days of that member taking office.  
 3.22 The program shall be developed in consultation with the department and appropriate  
 3.23 representatives of higher education. For purposes of this subdivision only, the definition of  
 3.24 school board member includes a board member of a tribal contract school under section  
 3.25 124D.83.

3.26 Sec. 4. Minnesota Statutes 2018, section 123B.147, subdivision 3, is amended to read:

3.27 Subd. 3. **Duties; evaluation.** (a) The principal shall provide administrative, supervisory,  
 3.28 and instructional leadership services, under the supervision of the superintendent of schools  
 3.29 of the district and according to the policies, rules, and regulations of the school board, for  
 3.30 the planning, management, operation, and evaluation of the education program of the building  
 3.31 or buildings to which the principal is assigned.

3.32 (b) To enhance a principal's culturally responsive leadership skills and support and  
 3.33 improve teaching practices, school performance, and student achievement for diverse student

4.1 populations, including at-risk students, children with disabilities, English learners, and gifted  
4.2 students, among others, a district must develop and implement a performance-based system  
4.3 for annually evaluating school principals assigned to supervise a school building within the  
4.4 district. The evaluation must be designed to improve teaching and learning by supporting  
4.5 the principal in shaping the school's professional environment and developing teacher  
4.6 quality, performance, and effectiveness. The annual evaluation must:

4.7 (1) support and improve a principal's instructional leadership, organizational management,  
4.8 and professional development, and strengthen the principal's capacity in the areas of  
4.9 instruction, supervision, evaluation, and teacher development;

4.10 (2) support and improve a principal's culturally responsive leadership practices that  
4.11 create inclusive and respectful teaching and learning environments for all students, families,  
4.12 and employees;

4.13 ~~(2)~~ (3) include formative and summative evaluations based on multiple measures of  
4.14 student progress toward career and college readiness;

4.15 ~~(3)~~ (4) be consistent with a principal's job description, a district's long-term plans and  
4.16 goals, and the principal's own professional multiyear growth plans and goals, all of which  
4.17 must support the principal's leadership behaviors and practices, rigorous curriculum, school  
4.18 performance, and high-quality instruction;

4.19 ~~(4)~~ (5) include on-the-job observations and previous evaluations;

4.20 ~~(5)~~ (6) allow surveys to help identify a principal's effectiveness, leadership skills and  
4.21 processes, and strengths and weaknesses in exercising leadership in pursuit of school success;

4.22 ~~(6)~~ (7) use longitudinal data on student academic growth as 35 percent of the evaluation  
4.23 and incorporate district achievement goals and targets;

4.24 ~~(7)~~ (8) be linked to professional development that emphasizes improved teaching and  
4.25 learning, curriculum and instruction, student learning, culturally responsive leadership  
4.26 practices, and a collaborative professional culture; and

4.27 ~~(8)~~ (9) for principals not meeting standards of professional practice or other criteria  
4.28 under this subdivision, implement a plan to improve the principal's performance and specify  
4.29 the procedure and consequence if the principal's performance is not improved.

4.30 The provisions of this paragraph are intended to provide districts with sufficient flexibility  
4.31 to accommodate district needs and goals related to developing, supporting, and evaluating  
4.32 principals.

5.1 **EFFECTIVE DATE.** This section is effective July 1, 2022.

5.2 Sec. 5. Minnesota Statutes 2018, section 124D.861, subdivision 2, is amended to read:

5.3 Subd. 2. **Plan implementation; components.** (a) The school board of each eligible  
5.4 district must formally develop and implement a long-term plan under this section. The plan  
5.5 must be incorporated into the district's comprehensive strategic plan under section 120B.11.  
5.6 ~~Plan components may include: innovative and integrated prekindergarten through grade 12~~  
5.7 ~~learning environments that offer students school enrollment choices; family engagement~~  
5.8 ~~initiatives that involve families in their students' academic life and success; professional~~  
5.9 ~~development opportunities for teachers and administrators focused on improving the academic~~  
5.10 ~~achievement of all students, including teachers and administrators who are members of~~  
5.11 ~~populations underrepresented among the licensed teachers or administrators in the district~~  
5.12 ~~or school and who reflect the diversity of students under section 120B.35, subdivision 3,~~  
5.13 ~~paragraph (b), clause (2), who are enrolled in the district or school; increased programmatic~~  
5.14 ~~opportunities and effective and more diverse instructors focused on rigor and college and~~  
5.15 ~~career readiness for underserved students, including students enrolled in alternative learning~~

5.20 (b) The plan must contain goals for:

5.21 (1) reducing the disparities in academic achievement and in equitable access to effective  
5.22 and more diverse teachers among all students and specific categories of students under  
5.23 section 120B.35, subdivision 3, paragraph (b), excluding the student categories of gender,  
5.24 disability, and English learners; and

5.25 (2) increasing racial and economic diversity and integration in schools and districts.

5.26 (c) The plan must include strategies to make schools' curriculum and learning and work  
5.27 environments more inclusive and respectful of students' racial, ethnic, and linguistic diversity  
5.28 and to address issues of structural inequities in schools that create opportunity and  
5.29 achievement gaps for students, families, and staff who are of color or who are American  
5.30 Indian. Examples of possible structural inequities include but are not limited to policies and  
5.31 practices that unintentionally result in disparate referrals and suspension, inequitable access  
5.32 to advanced coursework, overrepresentation in lower level coursework, inequitable  
5.33 participation in cocurricular activities, inequitable parent involvement, and lack of access  
5.34 to racially and ethnically diverse teachers.

6.1 (d) Plan components and strategies should be informed by local data and may include  
6.2 but are not limited to the following efforts:

6.3 (1) innovative and integrated prekindergarten through grade 12 learning environments  
6.4 that offer students school enrollment choices;

6.5 (2) family engagement initiatives that involve families in their students' academic life  
6.6 and success, and improve relations between home and school;

6.7 (3) creating opportunities for students, families, staff, and community members who are  
6.8 of color or American Indian to share their experiences in the school setting with school staff  
6.9 and administration to inform development of specific proposals for making school  
6.10 environments more inclusive and respectful toward all students, families, and staff;

6.11 (4) professional development opportunities for teachers and administrators focused on  
6.12 improving the academic achievement of all students, including knowledge, skills, and  
6.13 dispositions needed to be culturally responsive and successfully serve students who are  
6.14 from diverse racial, ethnic, and linguistic backgrounds;

6.15 (5) recruitment and retention of teachers, administrators, cultural and family liaisons,  
6.16 paraprofessionals, and other nonlicensed staff from racial, ethnic, and linguistic backgrounds  
6.17 represented in the student population to strengthen relationships with all students, families,  
6.18 and other members of the community;

6.19 (6) examining academic and discipline data, reexamining institutional policies and  
6.20 practices that result in opportunity and achievement disparities between racial and ethnic  
6.21 groups, and making necessary changes that increase access, meaningful participation,  
6.22 representation, and positive outcomes for students of color, American Indian students, and  
6.23 students who qualify for free or reduced-price lunch;

6.24 (7) increased programmatic opportunities and effective and more diverse instructors  
6.25 focused on rigor and college and career readiness for underserved students, including but  
6.26 not limited to students enrolled in alternative learning centers under section 123A.05, contract  
6.27 alternative programs under section 124D.69, and public alternative programs under section  
6.28 126C.05, subdivision 15;

6.29 (8) developing or expanding ethnic studies course offerings to provide all students with  
6.30 in-depth opportunities to learn about their own and others' cultures and historical experiences;  
6.31 or

6.32 (9) examining and revising curricula in various subjects to be culturally relevant and  
6.33 inclusive of various racial and ethnic groups while meeting state academic standards.

7.1 ~~(b)~~ (e) Among other requirements, an eligible district must implement effective,  
 7.2 research-based interventions that include formative assessment practices to reduce the  
 7.3 disparities in student academic performance among the specific categories of students as  
 7.4 measured by student progress and growth on state reading and math assessments and as  
 7.5 aligned with section 120B.11.

7.6 ~~(e)~~ (f) Eligible districts must create efficiencies and eliminate duplicative programs and  
 7.7 services under this section, which may include forming collaborations or a single,  
 7.8 seven-county metropolitan areawide partnership of eligible districts for this purpose.

7.9 **EFFECTIVE DATE.** This section is effective for all plans reviewed and updated after  
 7.10 the day of final enactment.

### 7.12 EDUCATION EXCELLENCE

7.13 Section 1. Minnesota Statutes 2018, section 13.32, subdivision 3, as amended by Laws  
 7.14 2020, First Special Session chapter 2, article 8, section 1, is amended to read:

7.15 Subd. 3. **Private data; when disclosure is permitted.** Except as provided in subdivision  
 7.16 5, educational data is private data on individuals and shall not be disclosed except as follows:

7.17 (a) pursuant to section 13.05;

7.18 (b) pursuant to a valid court order;

7.19 (c) pursuant to a statute specifically authorizing access to the private data;

7.20 (d) to disclose information in health, including mental health, and safety emergencies  
 7.21 pursuant to the provisions of United States Code, title 20, section 1232g(b)(1)(I) and Code  
 7.22 of Federal Regulations, title 34, section 99.36;

7.23 (e) pursuant to the provisions of United States Code, title 20, sections 1232g(b)(1),  
 7.24 (b)(4)(A), (b)(4)(B), (b)(1)(B), (b)(3), (b)(6), (b)(7), and (i), and Code of Federal Regulations,  
 7.25 title 34, sections 99.31, 99.32, 99.33, 99.34, 99.35, and 99.39;

7.26 (f) to appropriate health authorities to the extent necessary to administer immunization  
 7.27 programs and for bona fide epidemiologic investigations which the commissioner of health  
 7.28 determines are necessary to prevent disease or disability to individuals in the public  
 7.29 educational agency or institution in which the investigation is being conducted;

7.30 (g) when disclosure is required for institutions that participate in a program under title  
 7.31 IV of the Higher Education Act, United States Code, title 20, section 1092;

8.1 (h) to the appropriate school district officials to the extent necessary under subdivision  
8.2 6, annually to indicate the extent and content of remedial instruction, including the results  
8.3 of assessment testing and academic performance at a postsecondary institution during the  
8.4 previous academic year by a student who graduated from a Minnesota school district within  
8.5 two years before receiving the remedial instruction;

8.6 (i) to appropriate authorities as provided in United States Code, title 20, section  
8.7 1232g(b)(1)(E)(ii), if the data concern the juvenile justice system and the ability of the  
8.8 system to effectively serve, prior to adjudication, the student whose records are released;  
8.9 provided that the authorities to whom the data are released submit a written request for the  
8.10 data that certifies that the data will not be disclosed to any other person except as authorized  
8.11 by law without the written consent of the parent of the student and the request and a record  
8.12 of the release are maintained in the student's file;

8.13 (j) to volunteers who are determined to have a legitimate educational interest in the data  
8.14 and who are conducting activities and events sponsored by or endorsed by the educational  
8.15 agency or institution for students or former students;

8.16 (k) to provide student recruiting information, from educational data held by colleges  
8.17 and universities, as required by and subject to Code of Federal Regulations, title 32, section  
8.18 216;

8.19 (l) to the juvenile justice system if information about the behavior of a student who poses  
8.20 a risk of harm is reasonably necessary to protect the health or safety of the student or other  
8.21 individuals;

8.22 (m) with respect to Social Security numbers of students in the adult basic education  
8.23 system, to Minnesota State Colleges and Universities and the Department of Employment  
8.24 and Economic Development for the purpose and in the manner described in section 124D.52,  
8.25 subdivision 7;

8.26 (n) to the commissioner of education for purposes of an assessment or investigation of  
8.27 a report of alleged maltreatment of a student as mandated by chapter 260E. Upon request  
8.28 by the commissioner of education, data that are relevant to a report of maltreatment and are  
8.29 from charter school and school district investigations of alleged maltreatment of a student  
8.30 must be disclosed to the commissioner, including, but not limited to, the following:

8.31 (1) information regarding the student alleged to have been maltreated;

8.32 (2) information regarding student and employee witnesses;

8.33 (3) information regarding the alleged perpetrator; and

9.1 (4) what corrective or protective action was taken, if any, by the school facility in response  
9.2 to a report of maltreatment by an employee or agent of the school or school district;

9.3 (o) when the disclosure is of the final results of a disciplinary proceeding on a charge  
9.4 of a crime of violence or nonforcible sex offense to the extent authorized under United  
9.5 States Code, title 20, section 1232g(b)(6)(A) and (B) and Code of Federal Regulations, title  
9.6 34, sections 99.31 (a)(13) and (14);

9.7 (p) when the disclosure is information provided to the institution under United States  
9.8 Code, title 42, section 14071, concerning registered sex offenders to the extent authorized  
9.9 under United States Code, title 20, section 1232g(b)(7); ~~or~~

9.10 (q) when the disclosure is to a parent of a student at an institution of postsecondary  
9.11 education regarding the student's violation of any federal, state, or local law or of any rule  
9.12 or policy of the institution, governing the use or possession of alcohol or of a controlled  
9.13 substance, to the extent authorized under United States Code, title 20, section 1232g(i), and  
9.14 Code of Federal Regulations, title 34, section 99.31 (a)(15), and provided the institution  
9.15 has an information release form signed by the student authorizing disclosure to a parent.  
9.16 The institution must notify parents and students about the purpose and availability of the  
9.17 information release forms. At a minimum, the institution must distribute the information  
9.18 release forms at parent and student orientation meetings; or

9.19 (r) to tribal nations about tribally enrolled or descendant students to allow the tribal  
9.20 nation and school district or charter school to support the educational attainment of the  
9.21 student.

9.22 Sec. 2. Minnesota Statutes 2018, section 120A.22, subdivision 7, is amended to read:

9.23 Subd. 7. **Education records.** (a) A district, a charter school, or a nonpublic school that  
9.24 receives services or aid under sections 123B.40 to 123B.48 from which a student is  
9.25 transferring must transmit the student's educational records, within ten business days of a  
9.26 request, to the district, the charter school, or the nonpublic school in which the student is  
9.27 enrolling. Districts, charter schools, and nonpublic schools that receive services or aid under  
9.28 sections 123B.40 to 123B.48 must make reasonable efforts to determine the district, the  
9.29 charter school, or the nonpublic school in which a transferring student is next enrolling in  
9.30 order to comply with this subdivision.

9.31 (b) A closed charter school must transfer the student's educational records, within ten  
9.32 business days of the school's closure, to the student's school district of residence where the  
9.33 records must be retained unless the records are otherwise transferred under this subdivision.

10.1 (c) A school district, a charter school, or a nonpublic school that receives services or aid  
10.2 under sections 123B.40 to 123B.48 that transmits a student's educational records to another  
10.3 school district or other educational entity, charter school, or nonpublic school to which the  
10.4 student is transferring must include in the transmitted records information about any formal  
10.5 suspension, expulsion, and exclusion disciplinary action under sections 121A.40 to 121A.56.  
10.6 Transmitted records must document any service a pupil requires to prevent the inappropriate  
10.7 behavior from recurring. The district, the charter school, or the nonpublic school that receives  
10.8 services or aid under sections 123B.40 to 123B.48 must provide notice to a student and the  
10.9 student's parent or guardian that formal disciplinary records will be transferred as part of  
10.10 the student's educational record, in accordance with data practices under chapter 13 and the  
10.11 Family Educational Rights and Privacy Act of 1974, United States Code, title 20, section  
10.12 1232(g).

10.13 (d) Notwithstanding section 138.17, a principal or chief administrative officer must  
10.14 remove from a student's educational record and destroy a probable cause notice received  
10.15 under section 260B.171, subdivision 5, or paragraph (e), if one year has elapsed since the  
10.16 date of the notice and the principal or chief administrative officer has not received a  
10.17 disposition or court order related to the offense described in the notice. This paragraph does  
10.18 not apply if the student no longer attends the school when this one-year period expires.

10.19 (e) A principal or chief administrative officer who receives a probable cause notice under  
10.20 section 260B.171, subdivision 5, or a disposition or court order, must include a copy of that  
10.21 data in the student's educational records if they are transmitted to another school, unless the  
10.22 data are required to be destroyed under paragraph (d) or section 121A.75.

10.23 Sec. 3. Minnesota Statutes 2018, section 120B.021, subdivision 2, is amended to read:

10.24 Subd. 2. **Standards development.** (a) The commissioner must consider advice from at  
10.25 least the following stakeholders in developing statewide rigorous core academic standards  
10.26 in language arts, mathematics, science, social studies, including history, geography,  
10.27 economics, government and citizenship, and the arts:

10.28 (1) the Tribal Nations Education Committee under section 124D.79, subdivision 4, and  
10.29 representatives from Minnesota's tribal nations and communities, including both Anishinaabe  
10.30 and Dakota;

10.31 ~~(1)~~ (2) parents of school-age children and members of the public throughout the state;

11.1 ~~(2)~~ (3) teachers throughout the state currently licensed and providing instruction in  
 11.2 language arts, mathematics, science, social studies, or the arts and licensed elementary and  
 11.3 secondary school principals throughout the state currently administering a school site;

11.4 ~~(3)~~ (4) currently serving members of local school boards and charter school boards  
 11.5 throughout the state;

11.6 ~~(4)~~ (5) faculty teaching core subjects at postsecondary institutions in Minnesota; and

11.7 ~~(5)~~ (6) representatives of the Minnesota business community.

11.8 (b) Academic standards must:

11.9 (1) be clear, concise, objective, measurable, and grade-level appropriate;

11.10 (2) not require a specific teaching methodology or curriculum; and

11.11 (3) be consistent with the Constitutions of the United States and the state of Minnesota.

11.12 Sec. 4. **[120B.25] CURRICULUM POLICY.**

11.13 A school board must adopt a written policy that prohibits discrimination or discipline  
 11.14 for a teacher or principal on the basis of incorporating into curriculum contributions by  
 11.15 persons in a federally protected class or protected class under section 363A.13, consistent  
 11.16 with local collective bargaining agreements and sections 121A.41 to 121A.56.

11.17 Sec. 5. Minnesota Statutes 2018, section 121A.031, subdivision 5, is amended to read:

19.7 increasingly diverse student population and to ensure all students have equitable access to
