- 1.12 Section 1. Minnesota Statutes 2022, section 149A.02, subdivision 3, is amended to read:
- 1.13 Subd. 3. **Arrangements for disposition.** "Arrangements for disposition" means any
- 1.14 action normally taken by a funeral provider in anticipation of or preparation for the
- 1.15 entombment, burial in a cemetery, alkaline hydrolysis, ~~or~~ cremation, or, effective July 1,
- 1.16 2025, natural organic reduction of a dead human body.
- 1.17 Sec. 2. Minnesota Statutes 2022, section 149A.02, subdivision 16, is amended to read:
- 1.18 Subd. 16. **Final disposition.** "Final disposition" means the acts leading to and the
- 1.19 entombment, burial in a cemetery, alkaline hydrolysis, ~~or~~ cremation, or, effective July 1,
- 1.20 2025, natural organic reduction of a dead human body.
- 1.21 Sec. 3. Minnesota Statutes 2022, section 149A.02, subdivision 26a, is amended to read:
- 1.22 Subd. 26a. **Inurnment.** "Inurnment" means placing hydrolyzed or cremated remains in
- 1.23 a hydrolyzed or cremated remains container suitable for placement, burial, or shipment.

2.1 Effective July 1, 2025, inurnment also includes placing naturally reduced remains in a  
2.2 naturally reduced remains container suitable for placement, burial, or shipment.

2.3 Sec. 4. Minnesota Statutes 2022, section 149A.02, subdivision 27, is amended to read:

2.4 Subd. 27. **Licensee.** "Licensee" means any person or entity that has been issued a license  
2.5 to practice mortuary science, to operate a funeral establishment, to operate an alkaline  
2.6 hydrolysis facility, ~~or~~ to operate a crematory, or, effective July 1, 2025, to operate a natural  
2.7 organic reduction facility by the Minnesota commissioner of health.

2.8 Sec. 5. Minnesota Statutes 2022, section 149A.02, is amended by adding a subdivision to  
2.9 read:

2.10 Subd. 30b. **Natural organic reduction or naturally reduce.** "Natural organic reduction"  
2.11 or "naturally reduce" means the contained, accelerated conversion of a dead human body  
2.12 to soil. This subdivision is effective July 1, 2025.

2.13 Sec. 6. Minnesota Statutes 2022, section 149A.02, is amended by adding a subdivision to  
2.14 read:

2.15 Subd. 30c. **Natural organic reduction facility.** "Natural organic reduction facility"  
2.16 means a structure, room, or other space in a building or real property where natural organic  
2.17 reduction of a dead human body occurs. This subdivision is effective July 1, 2025.

2.18 Sec. 7. Minnesota Statutes 2022, section 149A.02, is amended by adding a subdivision to  
2.19 read:

2.20 Subd. 30d. **Natural organic reduction vessel.** "Natural organic reduction vessel" means  
2.21 the enclosed container in which natural organic reduction takes place. This subdivision is  
2.22 effective July 1, 2025.

2.23 Sec. 8. Minnesota Statutes 2022, section 149A.02, is amended by adding a subdivision to  
2.24 read:

2.25 Subd. 30e. **Naturally reduced remains.** "Naturally reduced remains" means the soil  
2.26 remains following the natural organic reduction of a dead human body and the accompanying  
2.27 plant material. This subdivision is effective July 1, 2025.

3.1 Sec. 9. Minnesota Statutes 2022, section 149A.02, is amended by adding a subdivision to  
 3.2 read:

3.3 Subd. 30f. **Naturally reduced remains container.** "Naturally reduced remains container"  
 3.4 means a receptacle in which naturally reduced remains are placed. This subdivision is  
 3.5 effective July 1, 2025.

3.6 Sec. 10. Minnesota Statutes 2022, section 149A.02, subdivision 35, is amended to read:

3.7 Subd. 35. **Processing.** "Processing" means the removal of foreign objects, drying or  
 3.8 cooling, and the reduction of the hydrolyzed ~~or~~ remains, cremated remains, or, effective  
 3.9 July 1, 2025, naturally reduced remains by mechanical means including, but not limited to,  
 3.10 grinding, crushing, or pulverizing, to a granulated appearance appropriate for final  
 3.11 disposition.

3.12 Sec. 11. Minnesota Statutes 2022, section 149A.02, subdivision 37c, is amended to read:

3.13 Subd. 37c. **Scattering.** "Scattering" means the authorized dispersal of hydrolyzed ~~or~~  
 3.14 remains, cremated remains, or, effective July 1, 2025, naturally reduced remains in a defined  
 3.15 area of a dedicated cemetery or in areas where no local prohibition exists provided that the  
 3.16 hydrolyzed ~~or~~, cremated, or naturally reduced remains are not distinguishable to the public,  
 3.17 are not in a container, and that the person who has control over disposition of the hydrolyzed  
 3.18 ~~or~~, cremated, or naturally reduced remains has obtained written permission of the property  
 3.19 owner or governing agency to scatter on the property.

3.20 Sec. 12. Minnesota Statutes 2022, section 149A.03, is amended to read:

3.21 **149A.03 DUTIES OF COMMISSIONER.**

3.22 The commissioner shall:

3.23 (1) enforce all laws and adopt and enforce rules relating to the:

3.24 (i) removal, preparation, transportation, arrangements for disposition, and final disposition  
 3.25 of dead human bodies;

3.26 (ii) licensure and professional conduct of funeral directors, morticians, interns, practicum  
 3.27 students, and clinical students;

3.28 (iii) licensing and operation of a funeral establishment;

3.29 (iv) licensing and operation of an alkaline hydrolysis facility; ~~and~~

3.30 (v) licensing and operation of a crematory; and

4.22 Sec. 13. **149A.56 LICENSE TO OPERATE A NATURAL ORGANIC REDUCTION**

4.23 **FACILITY.**

4.24 Subdivision 1. License requirement. This section is effective July 1, 2025. Except as

4.25 provided in section 149A.01, subdivision 3, no person shall maintain, manage, or operate

4.26 a place or premises devoted to or used in the holding and natural organic reduction of a

4.27 dead human body without possessing a valid license to operate a natural organic reduction

4.28 facility issued by the commissioner of health.

4.29 Subd. 2. Requirements for natural organic reduction facility. (a) A natural organic

4.30 reduction facility licensed under this section must consist of:

5.1 (1) a building or structure that complies with applicable local and state building codes,  
5.2 zoning laws and ordinances, and environmental standards, and that contains one or more  
5.3 natural organic reduction vessels for the natural organic reduction of dead human bodies;

5.4 (2) a motorized mechanical device for processing naturally reduced remains; and

5.5 (3) an appropriate refrigerated holding facility for dead human bodies awaiting natural  
5.6 organic reduction.

5.7 (b) A natural organic reduction facility licensed under this section may also contain a  
5.8 display room for funeral goods.

5.9 Subd. 3. **Application procedure; documentation; initial inspection.** (a) An applicant  
5.10 for a license to operate a natural organic reduction facility shall submit a completed  
5.11 application to the commissioner. A completed application includes:

5.12 (1) a completed application form, as provided by the commissioner;

5.13 (2) proof of business form and ownership; and

5.14 (3) proof of liability insurance coverage or other financial documentation, as determined  
5.15 by the commissioner, that demonstrates the applicant's ability to respond in damages for  
5.16 liability arising from the ownership, maintenance, management, or operation of a natural  
5.17 organic reduction facility.

5.18 (b) Upon receipt of the application and appropriate fee, the commissioner shall review  
5.19 and verify all information. Upon completion of the verification process and resolution of  
5.20 any deficiencies in the application information, the commissioner shall conduct an initial  
5.21 inspection of the premises to be licensed. After the inspection and resolution of any  
5.22 deficiencies found and any reinspections as may be necessary, the commissioner shall make  
5.23 a determination, based on all the information available, to grant or deny licensure. If the  
5.24 commissioner's determination is to grant the license, the applicant shall be notified and the  
5.25 license shall issue and remain valid for a period prescribed on the license, but not to exceed  
5.26 one calendar year from the date of issuance of the license. If the commissioner's determination  
5.27 is to deny the license, the commissioner must notify the applicant, in writing, of the denial  
5.28 and provide the specific reason for denial.

5.29 Subd. 4. **Nontransferability of license.** A license to operate a natural organic reduction  
5.30 facility is not assignable or transferable and shall not be valid for any entity other than the  
5.31 one named. Each license issued to operate a natural organic reduction facility is valid only  
5.32 for the location identified on the license. A 50 percent or more change in ownership or  
5.33 location of the natural organic reduction facility automatically terminates the license. Separate

6.1 licenses shall be required of two or more persons or other legal entities operating from the  
6.2 same location.

6.3 Subd. 5. **Display of license.** Each license to operate a natural organic reduction facility  
6.4 must be conspicuously displayed in the natural organic reduction facility at all times.

6.5 Conspicuous display means in a location where a member of the general public within the  
6.6 natural organic reduction facility is able to observe and read the license.

6.7 Subd. 6. **Period of licensure.** All licenses to operate a natural organic reduction facility  
6.8 issued by the commissioner are valid for a period of one calendar year beginning on July 1  
6.9 and ending on June 30, regardless of the date of issuance.

6.10 Subd. 7. **Reporting changes in license information.** Any change of license information  
6.11 must be reported to the commissioner, on forms provided by the commissioner, no later  
6.12 than 30 calendar days after the change occurs. Failure to report changes is grounds for  
6.13 disciplinary action.

6.14 Subd. 8. **Application information.** All information submitted to the commissioner for  
6.15 a license to operate a natural organic reduction facility is classified as licensing data under  
6.16 section 13.41, subdivision 5.

6.17 Sec. 14. **[149A.57] RENEWAL OF LICENSE TO OPERATE A NATURAL**  
6.18 **ORGANIC REDUCTION FACILITY.**

6.19 Subdivision 1. **Renewal required.** This section is effective July 1, 2025. All licenses  
6.20 to operate a natural organic reduction facility issued by the commissioner expire on June  
6.21 30 following the date of issuance of the license and must be renewed to remain valid.

6.22 Subd. 2. **Renewal procedure and documentation.** (a) Licensees who wish to renew  
6.23 their licenses must submit to the commissioner a completed renewal application no later  
6.24 than June 30 following the date the license was issued. A completed renewal application  
6.25 includes:

6.26 (1) a completed renewal application form, as provided by the commissioner; and

6.27 (2) proof of liability insurance coverage or other financial documentation, as determined  
6.28 by the commissioner, that demonstrates the applicant's ability to respond in damages for  
6.29 liability arising from the ownership, maintenance, management, or operation of a natural  
6.30 organic reduction facility.

6.31 (b) Upon receipt of the completed renewal application, the commissioner shall review  
6.32 and verify the information. Upon completion of the verification process and resolution of

7.1 any deficiencies in the renewal application information, the commissioner shall make a  
7.2 determination, based on all the information available, to reissue or refuse to reissue the  
7.3 license. If the commissioner's determination is to reissue the license, the applicant shall be  
7.4 notified and the license shall issue and remain valid for a period prescribed on the license,  
7.5 but not to exceed one calendar year from the date of issuance of the license. If the  
7.6 commissioner's determination is to refuse to reissue the license, section 149A.09, subdivision  
7.7 2, applies.

7.8 Subd. 3. **Penalty for late filing.** Renewal applications received after the expiration date  
7.9 of a license will result in the assessment of a late filing penalty. The late filing penalty must  
7.10 be paid before the reissuance of the license and received by the commissioner no later than  
7.11 31 calendar days after the expiration date of the license.

7.12 Subd. 4. **Lapse of license.** A license to operate a natural organic reduction facility shall  
7.13 automatically lapse when a completed renewal application is not received by the  
7.14 commissioner within 31 calendar days after the expiration date of a license, or a late filing  
7.15 penalty assessed under subdivision 3 is not received by the commissioner within 31 calendar  
7.16 days after the expiration of a license.

7.17 Subd. 5. **Effect of lapse of license.** Upon the lapse of a license, the person to whom the  
7.18 license was issued is no longer licensed to operate a natural organic reduction facility in  
7.19 Minnesota. The commissioner shall issue a cease and desist order to prevent the lapsed  
7.20 license holder from operating a natural organic reduction facility in Minnesota and may  
7.21 pursue any additional lawful remedies as justified by the case.

7.22 Subd. 6. **Restoration of lapsed license.** The commissioner may restore a lapsed license  
7.23 upon receipt and review of a completed renewal application, receipt of the late filing penalty,  
7.24 and reinspection of the premises, provided that the receipt is made within one calendar year  
7.25 from the expiration date of the lapsed license and the cease and desist order issued by the  
7.26 commissioner has not been violated. If a lapsed license is not restored within one calendar  
7.27 year from the expiration date of the lapsed license, the holder of the lapsed license cannot  
7.28 be relicensed until the requirements in section 149A.56 are met.

7.29 Subd. 7. **Reporting changes in license information.** Any change of license information  
7.30 must be reported to the commissioner, on forms provided by the commissioner, no later  
7.31 than 30 calendar days after the change occurs. Failure to report changes is grounds for  
7.32 disciplinary action.

7.33 Subd. 8. **Licensing information.** Section 13.41 applies to data collected and maintained  
7.34 by the commissioner pursuant to this section.

8.1 Sec. 15. Minnesota Statutes 2022, section 149A.65, is amended by adding a subdivision  
8.2 to read:

8.3 Subd. 6a. **Natural organic reduction facilities.** This subdivision is effective July 1,  
8.4 2025. The initial and renewal fee for a natural organic reduction facility is \$425. The late  
8.5 fee charge for a license renewal is \$100.

8.6 Sec. 16. Minnesota Statutes 2022, section 149A.70, subdivision 1, is amended to read:

8.7 Subdivision 1. **Use of titles.** Only a person holding a valid license to practice mortuary  
8.8 science issued by the commissioner may use the title of mortician, funeral director, or any  
8.9 other title implying that the licensee is engaged in the business or practice of mortuary  
8.10 science. Only the holder of a valid license to operate an alkaline hydrolysis facility issued  
8.11 by the commissioner may use the title of alkaline hydrolysis facility, water cremation,  
8.12 water-reduction, biocremation, green-cremation, resomation, dissolution, or any other title,  
8.13 word, or term implying that the licensee operates an alkaline hydrolysis facility. Only the  
8.14 holder of a valid license to operate a funeral establishment issued by the commissioner may  
8.15 use the title of funeral home, funeral chapel, funeral service, or any other title, word, or  
8.16 term implying that the licensee is engaged in the business or practice of mortuary science.  
8.17 Only the holder of a valid license to operate a crematory issued by the commissioner may  
8.18 use the title of crematory, crematorium, green-cremation, or any other title, word, or term  
8.19 implying that the licensee operates a crematory or crematorium. Effective July 1, 2025,  
8.20 only the holder of a valid license to operate a natural organic reduction facility issued by  
8.21 the commissioner may use the title of natural organic reduction facility, human composting,  
8.22 or any other title, word, or term implying that the licensee operates a natural organic reduction  
8.23 facility.

8.24 Sec. 17. Minnesota Statutes 2022, section 149A.70, subdivision 2, is amended to read:

8.25 Subd. 2. **Business location.** A funeral establishment, alkaline hydrolysis facility, ~~or~~  
8.26 crematory, or, effective July 1, 2025, natural organic reduction facility shall not do business  
8.27 in a location that is not licensed as a funeral establishment, alkaline hydrolysis facility, ~~or~~  
8.28 crematory, or natural organic reduction facility and shall not advertise a service that is  
8.29 available from an unlicensed location.



9.1 Sec. 18. Minnesota Statutes 2022, section 149A.70, subdivision 3, is amended to read:

9.2 Subd. 3. **Advertising.** No licensee, clinical student, practicum student, or intern shall  
 9.3 publish or disseminate false, misleading, or deceptive advertising. False, misleading, or  
 9.4 deceptive advertising includes, but is not limited to:

9.5 (1) identifying, by using the names or pictures of, persons who are not licensed to practice  
 9.6 mortuary science in a way that leads the public to believe that those persons will provide  
 9.7 mortuary science services;

9.8 (2) using any name other than the names under which the funeral establishment, alkaline  
 9.9 hydrolysis facility, ~~or~~ crematory, or, effective July 1, 2025, natural organic reduction facility  
 9.10 is known to or licensed by the commissioner;

9.11 (3) using a surname not directly, actively, or presently associated with a licensed funeral  
 9.12 establishment, alkaline hydrolysis facility, ~~or~~ crematory, or, effective July 1, 2025, natural  
 9.13 organic reduction facility, unless the surname had been previously and continuously used  
 9.14 by the licensed funeral establishment, alkaline hydrolysis facility, ~~or~~ crematory, or natural  
 9.15 organic reduction facility; and

9.16 (4) using a founding or establishing date or total years of service not directly or  
 9.17 continuously related to a name under which the funeral establishment, alkaline hydrolysis  
 9.18 facility, ~~or~~ crematory, or, effective July 1, 2025, natural organic reduction facility is currently  
 9.19 or was previously licensed.

9.20 Any advertising or other printed material that contains the names or pictures of persons  
 9.21 affiliated with a funeral establishment, alkaline hydrolysis facility, ~~or~~ crematory, or, effective  
 9.22 July 1, 2025, natural organic reduction facility shall state the position held by the persons  
 9.23 and shall identify each person who is licensed or unlicensed under this chapter.

9.24 Sec. 19. Minnesota Statutes 2022, section 149A.70, subdivision 5, is amended to read:

9.25 Subd. 5. **Reimbursement prohibited.** No licensee, clinical student, practicum student,  
 9.26 or intern shall offer, solicit, or accept a commission, fee, bonus, rebate, or other  
 9.27 reimbursement in consideration for recommending or causing a dead human body to be  
 9.28 disposed of by a specific body donation program, funeral establishment, alkaline hydrolysis  
 9.29 facility, crematory, mausoleum, ~~or~~ cemetery, or, effective July 1, 2025, natural organic  
 9.30 reduction facility.

10.1 Sec. 20. Minnesota Statutes 2022, section 149A.71, subdivision 2, is amended to read:

10.2 Subd. 2. **Preventive requirements.** (a) To prevent unfair or deceptive acts or practices,  
 10.3 the requirements of this subdivision must be met. This subdivision applies to natural organic  
 10.4 reduction and naturally reduced remains, goods, and services effective July 1, 2025.

10.5 (b) Funeral providers must tell persons who ask by telephone about the funeral provider's  
 10.6 offerings or prices any accurate information from the price lists described in paragraphs (c)  
 10.7 to (e) and any other readily available information that reasonably answers the questions  
 10.8 asked.

10.9 (c) Funeral providers must make available for viewing to people who inquire in person  
 10.10 about the offerings or prices of funeral goods or burial site goods, separate printed or  
 10.11 typewritten price lists using a ten-point font or larger. Each funeral provider must have a  
 10.12 separate price list for each of the following types of goods that are sold or offered for sale:

10.13 (1) caskets;

10.14 (2) alternative containers;

10.15 (3) outer burial containers;

10.16 (4) alkaline hydrolysis containers;

10.17 (5) cremation containers;

10.18 (6) hydrolyzed remains containers;

10.19 (7) cremated remains containers;

10.20 (8) markers; ~~and~~

10.21 (9) headstones; and

10.22 (10) naturally reduced remains containers.

10.23 (d) Each separate price list must contain the name of the funeral provider's place of  
 10.24 business, address, and telephone number and a caption describing the list as a price list for  
 10.25 one of the types of funeral goods or burial site goods described in paragraph (c), clauses  
 10.26 (1) to ~~(9)~~ (10). The funeral provider must offer the list upon beginning discussion of, but  
 10.27 in any event before showing, the specific funeral goods or burial site goods and must provide  
 10.28 a photocopy of the price list, for retention, if so asked by the consumer. The list must contain,  
 10.29 at least, the retail prices of all the specific funeral goods and burial site goods offered which  
 10.30 do not require special ordering, enough information to identify each, and the effective date  
 10.31 for the price list. However, funeral providers are not required to make a specific price list

11.1 available if the funeral providers place the information required by this paragraph on the  
11.2 general price list described in paragraph (e).

11.3 (e) Funeral providers must give a printed price list, for retention, to persons who inquire  
11.4 in person about the funeral goods, funeral services, burial site goods, or burial site services  
11.5 or prices offered by the funeral provider. The funeral provider must give the list upon  
11.6 beginning discussion of either the prices of or the overall type of funeral service or disposition  
11.7 or specific funeral goods, funeral services, burial site goods, or burial site services offered  
11.8 by the provider. This requirement applies whether the discussion takes place in the funeral  
11.9 establishment or elsewhere. However, when the deceased is removed for transportation to  
11.10 the funeral establishment, an in-person request for authorization to embalm does not, by  
11.11 itself, trigger the requirement to offer the general price list. If the provider, in making an  
11.12 in-person request for authorization to embalm, discloses that embalming is not required by  
11.13 law except in certain special cases, the provider is not required to offer the general price  
11.14 list. Any other discussion during that time about prices or the selection of funeral goods,  
11.15 funeral services, burial site goods, or burial site services triggers the requirement to give  
11.16 the consumer a general price list. The general price list must contain the following  
11.17 information:

11.18 (1) the name, address, and telephone number of the funeral provider's place of business;

11.19 (2) a caption describing the list as a "general price list";

11.20 (3) the effective date for the price list;

11.21 (4) the retail prices, in any order, expressed either as a flat fee or as the prices per hour,  
11.22 mile, or other unit of computation, and other information described as follows:

11.23 (i) forwarding of remains to another funeral establishment, together with a list of the  
11.24 services provided for any quoted price;

11.25 (ii) receiving remains from another funeral establishment, together with a list of the  
11.26 services provided for any quoted price;

11.27 (iii) separate prices for each alkaline hydrolysis, natural organic reduction, or cremation  
11.28 offered by the funeral provider, with the price including an alternative container or shroud  
11.29 or alkaline hydrolysis facility or cremation container; any alkaline hydrolysis, natural

22.4 the inurnment, the naturally reduced remains are not claimed or disposed of according to  
22.5 the written authorization for natural organic reduction, the natural organic reduction facility  
22.6 shall give written notice, by certified mail, to the person with the legal right to control the  
22.7 final disposition or a legal designee, that the naturally reduced remains are unclaimed and  
22.8 requesting further release directions. Should the naturally reduced remains be unclaimed  
22.9 120 calendar days following the mailing of the written notification, the natural organic  
22.10 reduction facility may return the remains to the earth respectfully in any lawful manner  
22.11 deemed appropriate.

22.12 Subd. 21. **Required records.** Every natural organic reduction facility shall create and  
22.13 maintain on its premises or other business location in Minnesota an accurate record of every  
22.14 natural organic reduction provided. The record shall include all of the following information  
22.15 for each natural organic reduction:

22.16 (1) the name of the person or funeral establishment delivering the body for natural  
22.17 organic reduction;

22.18 (2) the name of the deceased and the identification number assigned to the body;

22.19 (3) the date of acceptance of delivery;

22.20 (4) the names of the operator of the natural organic reduction process and mechanical  
22.21 processor operator;

22.22 (5) the times and dates that the body was placed in and removed from the natural organic  
22.23 reduction vessel;

22.24 (6) the time and date that processing and inurnment of the naturally reduced remains  
22.25 was completed;

22.26 (7) the time, date, and manner of release of the naturally reduced remains;

22.27 (8) the name and address of the person who signed the authorization for natural organic  
22.28 reduction;

22.29 (9) all supporting documentation, including any transit or disposition permits, a photocopy  
22.30 of the death record, and the authorization for natural organic reduction; and

22.31 (10) the type of natural organic reduction vessel.

23.1 Subd. 22. **Retention of records.** Records required under subdivision 21 shall be  
23.2 maintained for a period of three calendar years after the release of the naturally reduced  
23.3 remains. Following this period and subject to any other laws requiring retention of records,  
23.4 the natural organic reduction facility may then place the records in storage or reduce them  
23.5 to microfilm, a digital format, or any other method that can produce an accurate reproduction  
23.6 of the original record, for retention for a period of ten calendar years from the date of release  
23.7 of the naturally reduced remains. At the end of this period and subject to any other laws  
23.8 requiring retention of records, the natural organic reduction facility may destroy the records  
23.9 by shredding, incineration, or any other manner that protects the privacy of the individuals  
23.10 identified.
