Sec. 2. Minnesota Statutes 2014, section 144.1501, subdivision 2, is amended to read:
Subd. 2. Creation of account. (a) A health professional education loan forgiveness
program account is established. The commissioner of health shall use money from the
account to establish a loan forgiveness program:

3.1 (1) for medical residents agreeing to practice in designated rural areas or underserved
3.2 urban communities or specializing in the area of pediatric psychiatry;

- 3.3 (2) for midlevel practitioners agreeing to practice in designated rural areas or to
  3.4 teach at least 12 credit hours, or 720 hours per year in the nursing field in a postsecondary
  3.5 program at the undergraduate level or the equivalent at the graduate level;
- 3.6 (3) for nurses who agree to practice in a Minnesota nursing home or; an intermediate
  3.7 care facility for persons with developmental disability; or a hospital if the hospital owns
  and operates a Minnesota nursing home and a minimum of 50 percent of the hours worked
  by the nurse is in the nursing home; or agree to teach at least 12 credit hours, or 720 hours
  per year in the nursing field in a postsecondary program at the undergraduate level or the
  equivalent at the graduate level;
- (4) for other health care technicians agreeing to teach at least 12 credit hours, or 720
  hours per year in their designated field in a postsecondary program at the undergraduate
  level or the equivalent at the graduate level. The commissioner, in consultation with
  the Healthcare Education-Industry Partnership, shall determine the health care fields
  where the need is the greatest, including, but not limited to, respiratory therapy, clinical
  laboratory technology, radiologic technology, and surgical technology;
- 3.18 (5) for pharmacists, mental health professionals, advanced dental therapists, dental
   3.19 <u>therapists, and public health nurses</u> who agree to practice in designated rural areas; and
- 3.20 (6) for dentists agreeing to deliver at least 25 percent of the dentist's yearly patient
  3.21 encounters to state public program enrollees or patients receiving sliding fee schedule
  3.22 discounts through a formal sliding fee schedule meeting the standards established by
  3.23 the United States Department of Health and Human Services under Code of Federal
  3.24 Regulations, title 42, section 51, chapter 303.
- 3.25 (b) Appropriations made to the account do not cancel and are available until
  3.26 expended, except that at the end of each biennium, any remaining balance in the account
  3.27 that is not committed by contract and not needed to fulfill existing commitments shall

  3.33 <u>or education program to become a dentist, dental therapist, advanced dental therapist,</u>
- 3.34 <u>mental health professional, pharmacist, public health nurse, midlevel practitioner,</u>
- 3.35 registered nurse, or a licensed practical nurse training program; and

- 4.1 (2) submit an application to the commissioner of health. If fewer applications are
