1.5	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

Section 1. Minnesota Statutes 2014, section 169A.52, subdivision 1, is amended to read: 1.6 Subdivision 1. Test refusal. If a person refuses to permit a test, then a test must not 1.7 be given, but the peace officer shall report the refusal to the commissioner and the authority 1.8 having responsibility for prosecution of impaired driving offenses for the jurisdiction in 1.9 which the acts occurred. However, if a peace officer has probable cause to believe that 1.10 the person has violated section 609.2112, 609.2113, 609.2114, or Minnesota Statutes 1.11 2012, section 609.21 (criminal vehicular homicide or injury), a test may be required and 1.12 obtained despite the person's refusal. A refusal to submit to an alcohol concentration test 1.13 does not constitute a violation of section 609.50 (obstructing legal process), unless the 1.14 refusal was accompanied by force or violence or the threat of force or violence. 1.15 Sec. 2. Minnesota Statutes 2014, section 169A.52, subdivision 2, is amended to read: 1.16 1.17 Subd. 2. **Reporting test failure.** (a) If a person submits to a test, When a test is obtained, whether pursuant to the implied consent process under section 169A.51 or 1.18

- and to the authority having responsibility for prosecution of impaired driving offenses for
- 1.21 the jurisdiction in which the acts occurred, if the test results indicate:
- 1.22 (1) an alcohol concentration of 0.08 or more;
