1.5	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:
1.6	Section 1. [138.913] 250TH ANNIVERSARY COMMEMORATION COMMISSION.
1.7	Subdivision 1. Establishment. (a) The 250th Anniversary Commemoration Commission
1.8	is created within the Minnesota Humanities Center to execute commemorative and
1.9	educational activities, events, and celebrations related to the 250th anniversary of the
1.10	founding of the United States, as marked by the Declaration of Independence of 1776. The
1.11	commission shall:
1.12	(1) develop a comprehensive plan for promoting and celebrating the 250th anniversary
1.13	of the founding of the United States;
1.14	(2) identify all opportunities for individuals, municipalities, or other entities across the
1.15	state to participate in celebrations of the anniversary and recognize the particular history of
1.16	their geographic areas; and
1.17	(3) promote underrepresented voices in the founding of the country, including but not
1.18	limited to women, American Indians, and persons of color.
1.19	(b) The 250th Anniversary Commemoration Commission is the point of contact for state
1.20	and national organizations and events related to the 250th anniversary.

3.2	sources and may expend or invest any funds the commission receives. Any funds accepted
3.3	by the commission are appropriated to the state historical society on a continuing basis for
3.4	the purpose of supporting the commission's lawful activities.
3.5	(c) The commission may coordinate and engage in semiquincentennial initiatives proposed
3.6	or undertaken by any public or nonpublic person and may initiate or propose
3.7	semiquincentennial activities for the state. The commission shall:
3.8	(1) develop and promote plans for statewide recognition of the 250 years since America's
3.9	founding;
3.10	(2) identify statewide and local community partners to provide local opportunities for
3.11	public discussion regarding the founding of our nation and the subsequent 250 years; and
3.12	(3) identify prominent locations to display items that signify the founding of the United
3.13	States.
3.14	(d) The commission may employ personnel and contract for services.
3.15	Subd. 4. Expiration. This section expires on June 30, 2027.
