

1.1 A bill for an act

1.2 relating to human services; providing grants to community health centers;  
1.3 providing additional subsidies for federally qualified health centers; appropriating  
1.4 money for long-term homeless supportive services and homeless shelters, other  
1.5 supportive services, and the temporary uncompensated care pool.

1.6 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

1.7 Section 1. **GRANTS TO COMMUNITY HEALTH CENTERS.**

1.8 The commissioner of human services shall issue, by August 1, 2010, a request for  
1.9 proposals from federally qualified health centers, rural health clinics, and community  
1.10 mental health centers to expand and improve existing services to low-income persons who  
1.11 are medically underserved or uninsured. Grants may be used to:

1.12 (1) plan for and develop new facilities in underserved areas of the state;

1.13 (2) expand services provided by existing facilities, including, but not limited to,  
1.14 mental health and dental services, or plan for the expansion of services; and

1.15 (3) coordinate the delivery of existing and expanded services, to establish one-stop  
1.16 facilities that provide preventive, primary care, mental health, dental, and other services,  
1.17 and also referrals to specialized services as needed.

1.18 The commissioner shall award grants by January 1, 2011. Grants are onetime. In  
1.19 awarding grants, the commissioner shall give priority to proposals that seek to serve  
1.20 medically underserved areas of the state that are not served by a coordinated care delivery  
1.21 system established under Laws 2010, chapter ..., section 256D.031, subdivision 6, or  
1.22 that expand services to meet unmet needs.

2.1 (a) \$25,000,000 is appropriated in fiscal year 2011 from the general fund to the  
2.2 commissioner of human services for long-term homeless services under Minnesota  
2.3 Statutes, section 256K.26.

2.4 (b) \$5,000,000 is appropriated in fiscal year 2011 from the general fund to the  
2.5 commissioner of human services for grants to homeless shelters for street outreach, job  
2.6 training and employment services, chemical and mental health services, and housing  
2.7 assistance. This appropriation is onetime.

2.8 (c) \$12,000,000 is appropriated in fiscal year 2011 from the general fund to the  
2.9 commissioner of human services to provide grants to community health centers under  
2.10 section 1. This appropriation is onetime.

2.11 (d) \$5,000,000 is appropriated in fiscal year 2011 from the general fund to the  
2.12 commissioner of health to increase subsidies to federally qualified health centers provided  
2.13 under Minnesota Statutes, section 145.9269.

2.14 (e) \$3,000,000 is appropriated in fiscal year 2011 from the general fund to the  
2.15 commissioner of health to provide community clinic grants under Minnesota Statutes,  
2.16 section 145.9268.

2.17 (f) \$4,000,000 is appropriated in fiscal year 2011 from the general fund to the  
2.18 commissioner of human services to provide transitional housing under Minnesota Statutes,  
2.19 section 256E.33.

2.20 (g) \$1,000,000 is appropriated in fiscal year 2011 from the general fund to the  
2.21 commissioner of human services to provide emergency services grants under Minnesota  
2.22 Statutes, section 256E.36.

2.23 (h) \$5,000,000 is appropriated in fiscal year 2011 from the general fund to the  
2.24 commissioner of human services to provide community action grants under Minnesota  
2.25 Statutes, section 256E.30.

2.26 (i) \$20,000,000 is appropriated in fiscal year 2011 from the general fund to  
2.27 the commissioner of human services to provide additional funding to the temporary  
2.28 uncompensated care pool established under Laws 2010, chapter ..., section 256D.031,  
2.29 subdivision 8. This appropriation is onetime.
