**OFFICIAL STATUS** 

A bill for an act 1.1 relating to human services; appropriating money for ALS research and caregiver 12 support programs; amending Laws 2022, chapter 42, section 2. 1.3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA: 1.4

Section 1. Laws 2022, chapter 42, section 2, is amended to read: 1.5

## Sec. 2. APPROPRIATION; ALS RESEARCH. 1.6

(a) \$20,000,000 in fiscal year 2023 is appropriated from the general fund to the 1.7 commissioner of the Office of Higher Education to award competitive grants to applicants 1.8 for research into amyotrophic lateral sclerosis (ALS). The commissioner may work with 1.9 the Minnesota Department of Health to administer the grant program, including identifying 1.10 clinical and translational research and innovations, developing outcomes and objectives 1.11 with the goal of bettering the lives of individuals with ALS and finding a cure for the disease, 1.12 and application review and grant recipient selection. Not more than \$400,000 may be used 1.13 by the commissioner to administer the grant program. 1.14

(b) Grants shall be awarded to support clinical and translational research related to ALS. 1.15 Research topics may include but are not limited to environmental factors, disease 1.16 mechanisms, disease models, biomarkers, drug development, clinical studies, precision 1.17 medicine, medical devices, assistive technology, and cognitive studies. 1.18

(c) Eligible applicants for the grants are research facilities, universities, and health 1.19 systems located in Minnesota. Applicants must submit proposals to the commissioner in 1.20 the time, form, and manner established by the commissioner. Applicants may coordinate 1.21 1.22 research endeavors and submit a joint application. When reviewing the proposals, the
