OFFICIAL STATUS

1.1 A bill for an act  
1.2 relating to capital investment; appropriating money for a sewer separation project  
1.3 in the city of Litchfield; authorizing the sale and issuance of state bonds.

1.4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

1.5 Section 1. **LITCHFIELD; SEWER SEPARATION PROJECT.**

1.6 Subdivision 1. **Appropriation.** \$3,750,000 is appropriated from the bond proceeds fund  
1.7 to the Public Facilities Authority for a grant to the city of Litchfield to design, construct,  
1.8 and equip sewer separation infrastructure to isolate industrial process water from sanitary  
1.9 waste at the city sewer connection point with an expanded wastewater treatment facility in  
1.10 the city of Litchfield.

1.11 Subd. 2. **Bond sale.** To provide the money appropriated in this section from the bond  
1.12 proceeds fund, the commissioner of management and budget shall sell and issue bonds of  
1.13 the state in an amount up to \$3,750,000 in the manner, upon the terms, and with the effect  
1.14 prescribed by Minnesota Statutes, sections 16A.631 to 16A.675, and by the Minnesota  
1.15 Constitution, article XI, sections 4 to 7.

1.16 **EFFECTIVE DATE.** This section is effective the day following final enactment.
