

A bill for an act

relating to human services; making contingent appropriations; amending Minnesota Statutes 2008, sections 254B.03, by adding a subdivision; 256B.0625, subdivision 22; 256B.19, subdivision 1c; 256L.15, subdivision 1; Minnesota Statutes 2009 Supplement, section 256B.0911, subdivision 1a; Laws 2005, First Special Session chapter 4, article 8, section 66, as amended; Laws 2009, chapter 79, article 5, sections 17; 18; 22; article 8, section 2; Laws 2009, chapter 173, article 1, section 17.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

3.3 Subd. 4a. **Division of costs for medical assistance services.** Notwithstanding  
3.4 subdivision 4, for chemical dependency services provided on or after October 1, 2008, and  
3.5 reimbursed by medical assistance, the county share is 30 percent of the nonfederal share.

3.6 Sec. 5. Minnesota Statutes 2008, section 256B.0625, subdivision 22, is amended to

3.8 Subd. 22. **Hospice care.** Medical assistance covers hospice care services under

3.20 (2) providing recommendations on cost-effective community services that are  
3.21 available to the individual;

3.22 (3) development of an individual's person-centered community support plan;

3.23 (4) providing information regarding eligibility for Minnesota health care programs;

3.24 (5) face-to-face long-term care consultation assessments, which may be completed  
3.25 in a hospital, nursing facility, intermediate care facility for persons with developmental

4.7 (b) "Long-term care options counseling" means the services provided by the linkage  
4.8 lines as mandated by sections 256.01 and 256.975, subdivision 7, and also includes  
4.9 telephone assistance and follow up once a long-term care consultation assessment has  
4.10 been completed.

4.11 (c) "Minnesota health care programs" means the medical assistance program under  
4.12 chapter 256B and the alternative care program under section 256B.0913.

4.13 (d) "Lead agencies" means counties or a collaboration of counties, tribes, and health  
4.14 plans administering long-term care consultation assessment and support planning services.

4.16 Subd. 1c. **Additional portion of nonfederal share.** (a) Hennepin County shall  
4.17 be responsible for a monthly transfer payment of \$1,500,000, due before noon on the  
4.18 15th of each month and the University of Minnesota shall be responsible for a monthly  
4.19 transfer payment of \$500,000 due before noon on the 15th of each month, beginning July  
4.20 15, 1995. These sums shall be part of the designated governmental unit's portion of the  
4.21 nonfederal share of medical assistance costs.

4.22 (b) Beginning July 1, 2001, Hennepin County's payment under paragraph (a) shall

5.3 Sec. 8. Minnesota Statutes 2008, section 256L.15, subdivision 1, is amended to read:

5.4 Subdivision 1. **Premium determination.** (a) Families with children and individuals  
5.5 shall pay a premium determined according to subdivision 2.

5.6 (b) Pregnant women and children under age two are exempt from the provisions  
5.7 of section 256L.06, subdivision 3, paragraph (b), clause (3), requiring disenrollment  
5.8 for failure to pay premiums. For pregnant women, this exemption continues until the  
5.9 first day of the month following the 60th day postpartum. Women who remain enrolled  
5.10 during pregnancy or the postpartum period, despite nonpayment of premiums, shall be  
5.11 disenrolled on the first of the month following the 60th day postpartum for the penalty  
5.12 period that otherwise applies under section 256L.06, unless they begin paying premiums.

5.13 (c) Members of the military and their families who meet the eligibility criteria  
5.14 for MinnesotaCare upon eligibility approval made within 24 months following the end  
5.15 of the member's tour of active duty shall have their premiums paid by the commissioner.  
5.16 The effective date of coverage for an individual or family who meets the criteria of this  
5.17 paragraph shall be the first day of the month following the month in which eligibility is  
5.18 approved. This exemption applies for 12 months. This paragraph expires June 30, 2010.  
5.19 If the expiration of this provision is in violation of section 5001 of Public Law 111-5, this  
5.20 provision will expire on the date when it is no longer subject to section 5001 of Public Law  
5.21 111-5. The commissioner of human services shall notify the revisor of statutes of that date.
