Subdivision 1. Adoption of policy. (a) The commissioner of transportation must develop, 63.16 adopt, and implement a policy for every program or process the commissioner uses to 63.17 evaluate, prioritize, or select capital projects; award grants for capital projects; or allocate 63.18 funding or resources for capital projects, including trunk highway and general obligation 63.19 bonds. At a minimum, the commissioner must adopt a policy for capital project selections 63.20 and programs for each of the following: rail grade separation program; greater Minnesota 63.21 transit capital program; state airport development program; safety improvements on crude 63.22 oil corridors; facilities capital improvement program; Minnesota rail service improvement 63.23 program; port development assistance program; and passenger rail program. Prior to 63.24 developing, adopting, or implementing a policy for a program or selection process, the 63.25 63.26 commissioner must consult with the following entities, where appropriate: the Federal 63.27 Highway Administration; metropolitan planning organizations; regional development commissions; area transportation partnerships; local governments; the Metropolitan Council; 63.28 transportation stakeholders; or other appropriate federal, state, or local government agencies. 63.29 The commissioner must develop, adopt, and implement the policy no later than November 63.30 1, 2021, and may update the policy as appropriate.
