| (3) up to \$7,825,000 is appropriated in fiscal year 2012;   |
| (4) up to \$12,100,000 is appropriated in fiscal year 2013;  |
| (5) up to \$14,825,000 is appropriated in fiscal year 2014; and  |
| (6) up to \$15,550,000 is appropriated in fiscal year 2015 and each year thereafter <del>, up to</del> |

| Subd. 4. Report to legislature. The Board of Regents must report to the committees of                  |

| report must at a minimum include for each project, the total cost, the number of researchers,          |
| research grants, and the amount of debt issued by the board.   |

- 4.3 Subd. 6. Services to individuals and firms. Consistent with its mission and governing
  4.4 policies and the requirements for tax-exempt bonds, the university shall make available
  4.5 laboratory and other services on a fee-for-service basis to individuals and firms in the
  4.6 bioscience industry in Minnesota. The university will not assert patent rights when providing
  4.7 services that do not involve its innovative intellectual contributions.

Subd. 7. Refunding of bonds; allocation of savings realized. (a) The board may issue 4.8 bonds in one or more series to refund bonds that were issued for a project before January 4.9 4.10 1, 2019, if refunding is determined by the board to be in the best interest of the university. The principal amount of bonds issued in each refunding must not exceed the amount 4.11 necessary to defease the associated bonds outstanding immediately prior to refunding. The 4.12 amount of the state's annual payment to the university required for the debt service on the 4.13 refunded bonds, or original bonds if not yet refunded, or a combination of the two, shall be 4.14 up to the maximum annual appropriation under subdivision 3 for all series. 4.15 (b) The amount of the annual appropriation under subdivision 3 that is not needed to 4.16 pay the annual debt service under paragraph (a) is appropriated to the Board of Regents of 4.17 the University of Minnesota to pay the annual debt service amount on bonds issued by the 4.18 university to pay the costs of design, land acquisition, site preparation, and preconstruction 4.19 services of the clinical research facility. 4.20 (c) In any year that the state general fund appropriation authorized in this section exceeds 4.21 the amount needed to pay debt service on bonds issued by the university for purposes 4.22 specified in sections 137.61 to 137.65, the excess amount is canceled to the state general 4.23
