1.7	Subdivision 1. Appropriation. \$ is appropriated from the bond proceeds fund to
1.8	the commissioner of education for school safety facility grants according to this section.
1.9	Subd. 2. Application process. A school district may apply for a school safety facility
1.10	grant in the form and manner specified by the commissioner of education.
1.11	Subd. 3. Grant awards. (a) After consultation with the Department of Public Safety's
1.12	Minnesota School Safety Center, the commissioner of education may award a school safety
1.13	facility grant of no more than \$ for each qualifying school building to a school district.
