1.1 A bill for an act  
1.2 relating to workforce development; modifying the requirements of the uniform  
1.3 outcome report cards; amending Minnesota Statutes 2018, section 116L.98,  
1.4 subdivision 3.

1.5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

1.6 Section 1. Minnesota Statutes 2018, section 116L.98, subdivision 3, is amended to read:

1.7 Subd. 3. **Uniform outcome report card; reporting by commissioner.** (a) By December  
1.8 31 of each even-numbered year, the commissioner must report to the chairs and ranking  
1.9 minority members of the committees of the house of representatives and the senate having  
1.10 jurisdiction over economic development and workforce policy and finance the following  
1.11 information separately for each of the previous two fiscal or calendar years, for each program  
1.12 subject to the requirements of subdivision 1:

1.13 (1) the total number of participants enrolled;

1.14 (2) the median pre-enrollment wages based on participant wages for the second through  
1.15 the fifth calendar quarters immediately preceding the quarter of enrollment excluding those  
1.16 with zero income;

1.17 (3) the total number of participants with zero income in the second through fifth calendar  
1.18 quarters immediately preceding the quarter of enrollment;

1.19 (4) the total number of participants enrolled in training;

1.20 (5) the total number of participants enrolled in training by occupational group;

1.21 (6) the total number of participants that exited the program and the average enrollment  
1.22 duration of participants that have exited the program during the year;

- 2.1 (7) the total number of exited participants who completed training;
- 2.2 (8) the total number of exited participants who attained a credential;
- 2.3 (9) the total number of participants employed during three consecutive quarters
- 2.4 immediately following the quarter of exit, by industry;
- 2.5 (10) the median wages of participants employed during three consecutive quarters
- 2.6 immediately following the quarter of exit;
- 2.7 (11) the total number of participants employed during eight consecutive quarters
- 2.8 immediately following the quarter of exit, by industry;
- 2.9 (12) the median wages of participants employed during eight consecutive quarters
- 2.10 immediately following the quarter of exit;
- 2.11 (13) the total cost of the program;
- 2.12 (14) the total cost of the program per participant;
- 2.13 (15) the cost per credential received by a participant; ~~and~~
- 2.14 (16) the administrative cost of the program;
- 2.15 (17) a list of the program's goals as defined in the grant agreement; and
- 2.16 (18) an analysis of the program's progress in achieving the goals as defined in the grant
- 2.17 agreement.
- 2.18 (b) The report to the legislature must contain participant information by education level,
- 2.19 race and ethnicity, gender, and geography, and a comparison of exited participants who
- 2.20 completed training and those who did not.
- 2.21 (c) The requirements of this section apply to programs administered directly by the
- 2.22 commissioner or administered by other organizations under a grant made by the department.
