1.7 Supplement, section 469.1763, subdivisions 2, 3, 4.

1.8 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

1.9 Section 1. Minnesota Statutes 2020, section 469.174, subdivision 14, is amended to read:

1.10 Subd. 14. **Administrative expenses.** (a) "Administrative expenses" or "administrative

1.11 costs" means all documented expenditures of an authority other than or municipality in

1.12 support of the development activities in a project, including but not limited to:

1.13 (1) amounts paid for services provided by bond counsel, fiscal consultants, and economic

1.14 development consultants;

1.15 (2) allocated expenses and staff time of the authority or municipality for administering

1.16 a project, including but not limited to preparing the tax increment financing plan, negotiating

1.17 and preparing agreements, accounting for segregated funds of the district, preparing and

1.18 submitting required reporting for the district, and reviewing and monitoring compliance

1.19 with sections 469.174 to 469.1794;

1.20 (3) amounts paid to publish annual disclosures and provide notices under section 469.175;

1.21 (4) amounts to provide for the usual and customary maintenance and operation of

1.22 properties purchased with tax increments, including necessary reserves for repairs and the

1.23 cost of any insurance;

2.1 (5) amounts allocated or paid to prepare a development action response plan for a soils
 2.2 condition district or hazardous substance subdistrict; and

2.3 (6) amounts used to pay bonds, interfund loans, or other financial obligations to the
 2.4 extent those obligations were used to finance costs described in clauses (1) to (5).

2.5 (b) Administrative expenses and administrative costs do not include:

2.6 (1) amounts paid for the purchase of land and buildings;

2.7 (2) amounts paid to contractors or others providing materials and services, ~~including~~
 2.8 ~~architectural and engineering services,~~ directly connected with the physical development
 2.9 of the real property in the project, including architectural and engineering services and
 2.10 materials and services for demolition, soil correction, and the construction or installation
 2.11 of public improvements;

2.12 (3) relocation benefits paid to or services provided for persons residing or businesses
 2.13 located in the project;

2.14 ~~(4) amounts used to pay principal or interest on, fund a reserve for, or sell at a discount~~
 2.15 ~~bonds issued pursuant to section 469.178; or~~

2.16 ~~(5)~~ (4) amounts paid for property taxes or payments in lieu of taxes; and

2.17 (5) amounts used to pay principal or interest on, fund a reserve for, or sell at a discount
 2.18 bonds issued pursuant to section 469.178 or other financial obligations to the extent those
 2.19 obligations were used to finance costs described in clauses (1) to (3) (4).

2.20 ~~For districts for which the requests for certifications were made before August 1, 1979,~~
 2.21 ~~or after June 30, 1982, "administrative expenses" includes amounts paid for services provided~~
 2.22 ~~by bond counsel, fiscal consultants, and planning or economic development consultants.~~

2.23 This definition does not apply to administrative expenses or administrative costs referenced
 2.24 under section 469.176, subdivision 4h.

2.25 **EFFECTIVE DATE.** This section is effective the day following final enactment and
 2.26 applies to all districts, regardless of when the request for certification was made.

2.27 Sec. 2. Minnesota Statutes 2020, section 469.174, is amended by adding a subdivision to
 2.28 read:

2.29 Subd. 30. **Pay-as-you-go contract and note.** "Pay-as-you-go contract and note" means
 2.30 a written note or contractual obligation under which all of the following apply:

3.1 (1) the note or contractual obligation evidences an authority's commitment to reimburse
3.2 a developer, property owner, or note holder for the payment of costs of activities, including
3.3 any interest on unreimbursed costs;

3.4 (2) the reimbursement is made from tax increment revenues identified in the note or
3.5 contractual obligation as received by a municipality or authority as taxes are paid; and

3.6 (3) the risk that available tax increments may be insufficient to fully reimburse the costs
3.7 is borne by the developer, property owner, or note holder.

3.8 **EFFECTIVE DATE.** This section is effective the day following final enactment.

3.9 Sec. 3. Minnesota Statutes 2020, section 469.176, subdivision 3, is amended to read:

3.10 **Subd. 3. Limitation on administrative expenses.** (a) For districts for which certification
3.11 was requested before August 1, 2001, no tax increment shall be used to pay any
3.12 administrative expenses for a project which exceed ten percent of the total estimated tax
3.13 increment expenditures authorized by the tax increment financing plan or ten percent of the
3.14 total tax increment expenditures for the project net of any amounts returned to the county
3.15 auditor as excess increment or as remedies under section 469.1771, subdivision 2, whichever
3.16 is less.

3.17 (b) For districts for which certification was requested after July 31, 2001, no tax increment
3.18 may be used to pay any administrative expenses for a project which exceed ten percent of
3.19 total estimated tax increment expenditures authorized by the tax increment financing plan
3.20 or ten percent of the total tax increments, as defined in section 469.174, subdivision 25,
3.21 clause (1), from received for the district net of any amounts returned to the county auditor
3.22 as excess increment or as remedies under section 469.1771, subdivision 2, whichever is
3.23 less.

3.24 (c) Increments used to pay the county's administrative expenses under subdivision 4h
3.25 are not subject to the percentage limits in this subdivision.

3.26 (d) Increments defined under section 469.174, subdivision 25, clause (2), used for
3.27 administrative expenses described under section 469.174, subdivision 14, clause (4), are
3.28 not subject to the percentage limits in this subdivision.

3.29 **EFFECTIVE DATE.** This section is effective the day following final enactment and
3.30 applies to all districts, regardless of when the request for certification was made.

4.1 Sec. 4. Minnesota Statutes 2020, section 469.176, subdivision 4, is amended to read:

4.2 Subd. 4. **Limitation on use of tax increment; general rule.** All revenues derived from
4.3 tax increment shall be used in accordance with the tax increment financing plan. The revenues
4.4 shall be used solely for the following purposes: (1) to pay the principal of and interest on
4.5 bonds issued to finance a project; (2) by a rural development financing authority for the
4.6 purposes stated in section 469.142₂; by a port authority or municipality exercising the powers
4.7 of a port authority to finance or otherwise pay the cost of redevelopment pursuant to sections
4.8 469.048 to 469.068₂; by an economic development authority to finance or otherwise pay
4.9 the cost of redevelopment pursuant to sections 469.090 to 469.108₂; by a housing and
4.10 redevelopment authority or economic development authority to finance or otherwise pay
4.11 public redevelopment costs pursuant to sections 469.001 to 469.047₂; by a municipality or
4.12 economic development authority to finance or otherwise pay the capital and administration
4.13 costs of a development district pursuant to sections 469.124 to 469.133₂; by a municipality
4.14 or authority to finance or otherwise pay the costs of developing and implementing a
4.15 development action response plan₂; by a municipality or redevelopment agency to finance
4.16 or otherwise pay premiums for insurance or other security guaranteeing the payment when
4.17 due of principal of and interest on the bonds pursuant to chapter 462C, sections 469.152 to
4.18 469.165, or both, or to accumulate and maintain a reserve securing the payment when due
4.19 of the principal of and interest on the bonds pursuant to chapter 462C, sections 469.152 to
4.20 469.165, or both, which revenues in the reserve shall not exceed, subsequent to the fifth
4.21 anniversary of the date of issue of the first bond issue secured by the reserve, an amount
4.22 equal to 20 percent of the aggregate principal amount of the outstanding and nondefeased
4.23 bonds secured by the reserve; and (3) to pay administrative expenses.

4.24 **EFFECTIVE DATE.** This section is effective the day following final enactment and
4.25 applies to all districts, regardless of when the request for certification was made.

4.26 Sec. 5. Minnesota Statutes 2021 Supplement, section 469.1763, subdivision 2, is amended
4.27 to read:

4.28 Subd. 2. **Expenditures outside district.** (a) For each tax increment financing district,
4.29 an amount equal to at least 75 percent of the total revenue derived from tax increments paid
4.30 by properties in the district must be expended on activities in the district or to pay bonds,
4.31 to the extent that the proceeds of the bonds were used to finance activities in the district or
4.32 to pay, or secure payment of, debt service on credit enhanced bonds. For districts, other
4.33 than redevelopment districts for which the request for certification was made after June 30,
4.34 1995, the in-district percentage for purposes of the preceding sentence is 80 percent. Not

5.1 more than 25 percent of the total revenue derived from tax increments paid by properties
5.2 in the district may be expended, through a development fund or otherwise, on activities
5.3 outside of the district but within the defined geographic area of the project except to pay,
5.4 or secure payment of, debt service on credit enhanced bonds. For districts, other than
5.5 redevelopment districts for which the request for certification was made after June 30, 1995,
5.6 the pooling percentage for purposes of the preceding sentence is 20 percent. The revenues
5.7 derived from tax increments paid by properties in the district that are expended on costs
5.8 under section 469.176, subdivision 4h, paragraph (b), may be deducted first before calculating
5.9 the percentages that must be expended within and without the district.

5.10 (b) In the case of a housing district, a housing project, as defined in section 469.174,
5.11 subdivision 11, is an activity in the district.

5.12 (c) All administrative expenses are considered to be expenditures for activities outside
5.13 of the district, except that if the only expenses for activities outside of the district under this
5.14 subdivision are for the purposes described in paragraph (d), administrative expenses will
5.15 be considered as expenditures for activities in the district.

5.16 (d) The authority may elect, in the tax increment financing plan for the district, to increase
5.17 by up to ten percentage points the permitted amount of expenditures for activities located
5.18 outside the geographic area of the district under paragraph (a). As permitted by section
5.19 469.176, subdivision 4k, the expenditures, including the permitted expenditures under
5.20 paragraph (a), need not be made within the geographic area of the project. Expenditures
5.21 that meet the requirements of this paragraph are legally permitted expenditures of the district,
5.22 notwithstanding section 469.176, subdivisions 4b, 4c, and 4j. To qualify for the increase
5.23 under this paragraph, the expenditures must:

5.24 (1) be used exclusively to assist housing that meets the requirement for a qualified
5.25 low-income building, as that term is used in section 42 of the Internal Revenue Code; and

5.26 (2) not exceed the qualified basis of the housing, as defined under section 42(c) of the
5.27 Internal Revenue Code, less the amount of any credit allowed under section 42 of the Internal
5.28 Revenue Code; and

5.29 (3) be used to:

5.30 (i) acquire and prepare the site of the housing;

5.31 (ii) acquire, construct, or rehabilitate the housing; or

5.32 (iii) make public improvements directly related to the housing; or

5.33 (4) be used to develop housing:

6.1 (i) if the market value of the housing does not exceed the lesser of:

6.2 (A) 150 percent of the average market value of single-family homes in that municipality;

6.3 or

6.4 (B) \$200,000 for municipalities located in the metropolitan area, as defined in section
6.5 473.121, or \$125,000 for all other municipalities; and

6.6 (ii) if the expenditures are used to pay the cost of site acquisition, relocation, demolition
6.7 of existing structures, site preparation, and pollution abatement on one or more parcels, if
6.8 the parcel contains a residence containing one to four family dwelling units that has been
6.9 vacant for six or more months and is in foreclosure as defined in section 325N.10, subdivision
6.10 7, but without regard to whether the residence is the owner's principal residence, and only
6.11 after the redemption period has expired; or

6.12 (5) to assist owner-occupied housing that meets the requirements of section 469.1761,
6.13 subdivision 2.

6.14 (e) The authority under paragraph (d), clause (4), expires on December 31, 2016.

6.15 Increments may continue to be expended under this authority after that date, if they are used
6.16 to pay bonds or binding contracts that would qualify under subdivision 3, paragraph (a), if
6.17 December 31, 2016, is considered to be the last date of the five-year period after certification
6.18 under that provision.

6.19 (f) For purposes of determining whether the minimum percentage of expenditures for
6.20 activities in the district and maximum percentages of expenditures allowed on activities
6.21 outside the district have been met under this subdivision, any amounts returned to the county
6.22 auditor as excess increment or as remedies under section 469.1771, subdivision 2, shall first
6.23 be subtracted from the total revenues derived from tax increments paid by properties in the
6.24 district. Any other amounts returned to the county auditor for purposes other than a remedy
6.25 under section 469.1771, subdivision 3, are considered to be expenditures for activities in
6.26 the district.

6.27 **EFFECTIVE DATE.** This section is effective the day following final enactment and
6.28 applies to all districts with a request for certification date after April 30, 1990, except that
6.29 paragraph (f) shall apply to districts decertifying beginning in the year following final
6.30 enactment.

7.1 Sec. 6. Minnesota Statutes 2021 Supplement, section 469.1763, subdivision 3, is amended
7.2 to read:

7.3 Subd. 3. **Five-year rule.** (a) Revenues derived from tax increments paid by properties
7.4 in the district that are considered to have been expended on an activity within the district
7.5 under will instead be considered to have been expended on an activity outside the district
7.6 for purposes of subdivision 2 only if one of the following occurs unless:

7.7 (1) before or within five years after certification of the district, the revenues are actually
7.8 paid to a third party with respect to the activity;

7.9 (2) bonds, the proceeds of which must be used to finance the activity, are issued and
7.10 sold to a third party before or within five years after certification of the district, the revenues
7.11 are spent to repay the bonds, and the proceeds of the bonds either are, on the date of issuance,
7.12 reasonably expected to be spent before the end of the later of (i) the five-year period, or (ii)
7.13 a reasonable temporary period within the meaning of the use of that term under section
7.14 148(c)(1) of the Internal Revenue Code, or are deposited in a reasonably required reserve
7.15 or replacement fund;

7.16 (3) binding contracts with a third party are entered into for performance of the activity
7.17 before or within five years after certification of the district and the revenues are spent under
7.18 the contractual obligation;

7.19 (4) costs with respect to the activity are paid before or within five years after certification
7.20 of the district and the revenues are spent to reimburse a party for payment of the costs,
7.21 including interest on unreimbursed costs; or

7.22 (5) ~~expenditures are made~~ revenues are spent for housing purposes as permitted described
7.23 by subdivision 2, paragraphs paragraph (b) and (d), or for public infrastructure purposes
7.24 within a zone as permitted by subdivision 2, paragraph (e).

7.25 (b) For purposes of this subdivision, bonds include subsequent refunding bonds if the
7.26 original refunded bonds meet the requirements of paragraph (a), clause (2).

7.27 (c) For a redevelopment district or a renewal and renovation district certified after June
7.28 30, 2003, and before April 20, 2009, the five-year periods described in paragraph (a) are
7.29 extended to ten years after certification of the district. For a redevelopment district certified
7.30 after April 20, 2009, and before June 30, 2012, the five-year periods described in paragraph
7.31 (a) are extended to eight years after certification of the district. This extension is provided
7.32 primarily to accommodate delays in development activities due to unanticipated economic
7.33 circumstances.

8.1 (d) For a redevelopment district that was certified after December 31, 2017, and before
 8.2 June 30, 2020, the five-year periods described in paragraph (a) are extended to eight years
 8.3 after certification of the district.

8.4 **EFFECTIVE DATE.** This section is effective the day following final enactment and
 8.5 applies to all districts with a request for certification date after April 30, 1990.

8.8 **Subd. 4. Use of revenues for decertification.** ~~(a) In each year beginning with the sixth~~

9.14 (b) For districts with an outstanding qualifying pay-as-you-go contract and note, the
9.15 required decertification under paragraph (a) is deferred until the earlier of the applicable
9.16 duration limit under section 469.176 or the remaining term of the last outstanding qualifying
9.17 pay-as-you-go contract and note, and the authority must annually, beginning at the time
9.18 paragraph (a) would otherwise require decertification without regard to the deferral in this
9.19 sentence, either:

9.20 (1) remove from the district, by the end of the year, all parcels that will no longer have
9.21 their tax increment revenue pledged or subject to a qualifying pay-as-you-go contract and
9.22 note or other costs and obligations described in subdivision 3, paragraphs (a) and (b), after

9.24 (2) use the applicable in-district percentage of revenues derived from tax increments
9.25 paid by those parcels to prepay an outstanding qualifying pay-as-you-go contract and note

9.28 The authority must remove any parcels as required by this paragraph by modification
9.29 of the tax increment financing plan and notify the county auditor of the removed parcels by

9.31 paragraphs (b), clause (1), and (e), the notice, discussion, public hearing, and findings
9.32 required for approval of the original plan are not required for such a modification.

10.1 (c) If decertification is required under paragraph (a), regardless of whether the

10.15 (e) For purposes of this subdivision, "applicable in-district percentage" means the
10.16 percentage of tax increment revenue that is restricted for expenditures within the district,
10.17 as determined under subdivision 2, paragraphs (a) and (d), for the district.

10.18 (f) For purposes of this subdivision, "qualifying pay-as-you-go contract and note" means
10.19 a pay-as-you-go contract and note that is considered to be for activities within the district
10.20 under subdivision 3, paragraph (a).

10.21 (g) For purposes of this subdivision, the reference in paragraph (a) to cumulative revenues
10.22 derived from tax increments paid by properties in the district through the end of the calendar
10.23 year shall include any final settlement distributions made in the following January. For
10.24 purposes of the calculation in paragraph (a), any amounts returned to the county auditor as
10.25 excess increment or as remedies under section 469.1771, subdivision 2, shall first be
10.26 subtracted from the cumulative revenues derived from tax increments paid by properties in
10.27 the district.

10.28 (h) The timing and implementation of a decertification pursuant to paragraphs (a) and

11.17 (j) Notwithstanding anything to the contrary in paragraphs (a), (b), or (c), if an authority
11.18 has made the election in the tax increment financing plan for the district under subdivision
11.19 2, paragraph (d), then the requirement to decertify under paragraph (a) or remove parcels
11.20 under paragraph (b) shall not apply prior to such time that the difference between the
11.21 cumulative revenues derived from tax increments paid by properties in the district and the
11.22 applicable in-district percentage of revenues derived from tax increments paid by properties
11.23 in the district equals the lesser of the amount the authority is permitted under subdivision
11.24 2, paragraph (d), to expend for housing purposes described in that provision, or the amount
