- (b) The deferred annuity must be computed under section 353.29, subdivision 3, on the basis of the law in effect on the date of termination of public service or termination of membership, whichever is later, and, if the later of termination of public service or termination of membership is on or before December 31, 2011, the deferred annuity must be augmented as provided in paragraphs (c) to (e).

- (c) The deferred annuity commences upon application after the person on deferred status attains at least the minimum age specified in section 354A.31, subdivision 1.

- (c) The executive director must offer a lump sum distribution to the former state employee of the difference between the monthly amount determined under section 1 or 2, as applicable, and the monthly amount being paid to the former state employee, multiplied by the number of monthly payments made to the former state employee before the annuity calculated under section 1 or 2, as applicable, begins. The lump sum must be adjusted to take into account any election of any optional annuity forms of payment and any postretirement increases. The former state employee may elect a distribution of the lump sum or a direct rollover under Minnesota Statutes, section 356.635, subdivisions 3 to 7, if the lump sum is an eligible rollover distribution as defined in section 356.635, subdivisions 4 and 5.

- (b) For each former teacher, the executive director must adjust the ongoing annuity amount so that it is the amount calculated under section 4, taking into account any election of any optional annuity forms of payment and any postretirement increases.
- (c) The executive director must offer a lump sum distribution to the former teacher of the difference between the monthly amount determined under section 4 and the monthly amount being paid to the former teacher, multiplied by the number of monthly payments made to the former teacher before the annuity calculated under section 4 begins.
