1.5	Section 1. Minnesota Statutes 2018, section 13.045, subdivision 1, is amended to read:
1.6	Subdivision 1. Definitions. As used in this section:
1.7	(1) "program participant" has the meaning given in section 5B.02, paragraph (g);
1.8	(2) "location data" means any data the participant specifies that may be used to physically
1.9	locate a program participant, including but not limited to such as the program participant's
1.10	residential address, work address, and or school address, and that is collected, received, or
1.11	maintained by a government entity prior to the date a program participant's certification
1.12	expires, or the date the entity receives notice that the program participant has withdrawn
1.13	from the program, whichever is earlier;
1.14	(3) "identity data" means data that may be used to identify a program participant,
1.15	including the program participant's name, phone number, e-mail address, address designated
1.16	under chapter 5B, Social Security number, or driver's license number, and that is collected,
1.17	received, or maintained by a government entity before the date a program participant's
1.18	certification expires, or the date the entity receives notice that the program participant has
1.19	withdrawn from the program, whichever is earlier;
1.20	(4) "county recorder" means the county official who performs the functions of the county
1.21	recorder or registrar of titles to record a document as part of the county real estate document

Subd. 2. Notification of certification. (a) A program participant may submit a notice, 2.5 in writing, to notify the responsible authority of any government entity other than the county 2.6 recorder in writing, on a form prescribed by the secretary of state, that the participant is 2.7 certified in the Safe at Home address confidentiality program pursuant to chapter 5B. The 2.8 notice must include the program participant's name, names of other program participants 2.9 in the household, date of birth, address designated under chapter 5B, program participant 2.10 signature, signature of the participant's parent or guardian if the participant is a minor, date 2.11 the program participant's certification in the program expires, and any other information 2.12 specified by the secretary of state. A program participant may submit a subsequent notice 2.13 of certification, if the participant's certification is renewed. The contents of the notification 2.14 of certification are private data on individuals. A notice provided pursuant to this paragraph 2.15 is a request to protect location data unless the participant requests that specific identity data 2.16 also be protected. 2.17

(b) To affect real property records, including but not limited to documents maintained 2.18 in a public recording system, data on assessments and taxation, and other data on real 2.19 property, a program participant must submit a real property notice in writing to the county 2.20 recorder in the county where the property identified in the real property notice is located. 2.21 To affect real property records maintained by any other government entity, a program 2.22 participant must also submit a real property notice in writing to the other government entity. 2.23 A real property notice must be on a form prescribed by the secretary of state and must 2.24 include: 2.25

2.26 (1) the full legal name of the program participant, including middle name;

4.16	in the written notice in the entity's real property records, unless:
4.17	(1) the program participant has consented to sharing or dissemination of the data for the
4.18	purpose identified in a writing acknowledged by the program participant;
4.19	(2) the data are subject to sharing or dissemination pursuant to court order under section

4.21	(3) the secretary of state authorizes the sharing or dissemination of the data under

The procedure must comply with the requirements of chapters 386, 507, 508, 5.2 and 508A and other laws as appropriate, to the extent these requirements do not conflict 5.3 with this section. The procedures must provide public notice of the existence of recorded 5.4 documents and certificates of title that are not publicly viewable and the provisions for 5.5 viewing them under this subdivision. Notice that a document or certificate is private and 5.6 viewable only under this subdivision or subdivision 4b is deemed constructive notice of the 5.7 document or certificate.

(b) A real property notice is notice only to the county recorder. A notice that does not
conform to the requirements of a real property notice under subdivision 2, paragraph (b),
is not effective as a notice to the county recorder. On receipt of a real property notice, the
county recorder shall provide a copy of the notice to the person who maintains the property
tax records in that county, and provide a copy to the secretary of state at the address specified
by the secretary of state in the notice.

(c) Paragraph (a) applies only to the records recorded or filed concurrently with the real
property notice specified in subdivision 2, paragraph (b), and real property records affecting
the same real property created or recorded subsequent to the county's entity's receipt of the
real property notice.

5.18 (d) The prohibition on disclosure in paragraph (a) continues until:

(1) the program participant has consented to the termination of the real property notice
in a writing acknowledged by the program participant. Notification under this paragraph
<u>must be given by the county to the secretary of state within 90 days of the termination;</u>

5.22 (2) the real property notice is terminated pursuant to a court order. Notification under
5.23 this paragraph must be given by the county to the secretary of state within 90 days of the
5.24 termination;

5.25 (3) the program participant no longer holds a record interest in the real property identified
5.26 in the real property notice. Notification under this paragraph must be given by the county
5.27 to the secretary of state within 90 days of the termination; or

(4) the secretary of state has given written notice to the county recorder who provided
the secretary of state with a copy of a participant's real property notice that the program
participant's certification has terminated. Notification under this paragraph must be given
by the secretary of state within 90 days of the termination.

- 6.1 Upon termination of the prohibition of disclosure, the county recorder shall make publicly
- 6.2 viewable all documents and certificates of title relative to the participant that were previously
- 6.3 partially or wholly private and not viewable.
