1.1 A bill for an act

1.2 relating to human services; modifying SNAP eligibility for students enrolled in

1.3 higher education; proposing coding for new law in Minnesota Statutes, chapter

1.4 256D.

1.5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

1.6 Section 1. **[256D.66] CAMPUS-BASED EMPLOYMENT AND TRAINING**

1.7 **PROGRAM FOR STUDENTS ENROLLED IN HIGHER EDUCATION.**

1.8 Subdivision 1. **Designation.** (a) Within six months of the effective date of this section,

1.9 the Board of Trustees of Minnesota State Colleges and Universities must, and the Board of

1.10 Regents of the University of Minnesota is requested to, submit an application to the

1.11 commissioner of human services verifying whether each of its institutions meets the

1.12 requirements to be a campus-based employment and training program that qualifies for the

1.13 student exemption for supplemental nutrition assistance program (SNAP) eligibility, as

1.14 described in the Code of Federal Regulations, title 7, section 273.5(b)(11)(iv).

1.15 (b) An institution of higher education must be designated as a campus-based employment

1.16 and training program by the commissioner of human services if that institution meets the

1.17 requirements set forth in the guidance under subdivision 3. The commissioner of human

1.18 services must maintain a list of approved programs on its website.

1.19 Subd. 2. **Student eligibility.** A student is eligible to participate in a campus-based

1.20 employment and training program under this section if they are enrolled in:

1.21 (1) a public two-year community or technical college and received a state grant under

1.22 section 136A.121, received a federal Pell grant, or has a student aid index of \$0 or less;

2.1 (2) a Tribal college as defined in section 136A.62 and received a state grant under section  
2.2 136A.121, received a federal Pell grant, or has a student aid index of \$0 or less; or

2.3 (3) a public four-year university and received a state grant under section 136A.121,  
2.4 received a federal Pell grant, or has a student aid index of \$0 or less.

2.5 Subd. 3. **Guidance.** Within three months of the effective date of this section and annually  
2.6 thereafter, the commissioner of human services, in consultation with the commissioner of  
2.7 higher education, must issue guidance to counties, Tribal Nations, Tribal colleges, and  
2.8 Minnesota public postsecondary institutions that:

2.9 (1) clarifies the state and federal eligibility requirements for campus-based employment  
2.10 and training programs for low-income households;

2.11 (2) clarifies the application process for campus-based employment and training programs  
2.12 for low-income households including, but not limited to, providing a list of the supporting  
2.13 documents required for program approval;

2.14 (3) clarifies how students in an institution of higher education approved as campus-based  
2.15 employment and training program for low-income households qualify for a SNAP student  
2.16 exemption; and

2.17 (4) clarifies the SNAP eligibility criteria for students that qualify for a SNAP student  
2.18 exemption under this section.

2.19 Subd. 4. **Application.** Within three months of the effective date of this section, the  
2.20 commissioner of human services, in consultation with the commissioner of higher education,  
2.21 must design an application for institutions of higher education to apply for a campus-based  
2.22 employment and training program designation.

2.23 Subd. 5. **Notice.** At the beginning of each academic semester, an institution of higher  
2.24 education with a designated campus-based employment and training program must send a  
2.25 letter to students eligible under this section to inform them that they may qualify for SNAP  
2.26 benefits and direct them to resources to apply. The letter under this subdivision shall serve  
2.27 as proof of a student's enrollment in a campus-based employment and training program.

2.28 **EFFECTIVE DATE.** This section is effective upon federal approval. The commissioner  
2.29 of human services must notify the revisor of statutes when federal approval is obtained.
