1.6	Subdivision 1. Grant program established. The commissioner of employment and
1.7	economic development shall establish an accessibility for the arts and cultural economy
1.8	grant program. The commissioner shall make a grant to an intermediary organization, to be
1.9	identified by the commissioner, to make grants to eligible grantees to fund necessary arts
1.10	or cultural facility building accessibility renovations to comply with Americans with
1.11	Disabilities Act (ADA) requirements and for capital projects at an arts or cultural facility.
1.12	Subd. 2. <b>Definitions.</b> (a) For the purposes of this section, the terms in this subdivision

2.6	(c) Up to 0.5 percent of a grant under this subdivision may be used by the CDFI
2.7	intermediary organization for administration and monitoring of the program.
2.8	(d) The intermediary organization shall convene and consult with a community advisory
2.9	group that reflects a balance of Minnesota's geographic, racial, disability, and gender diversity
2.10	along with other representatives who have experience with the creative economy, capital
2.11	projects, or rural revitalization.
2.12	Subd. 4. Eligible grantees; grant process. (a) An owner or operator of an arts or cultural
2.13	facility is eligible to receive a grant under this section if the entity operating the facility:
2.14	(1) is a 501(c)(3) or equivalent not-for-profit arts or cultural organization;
2.15	(2) is located in the state of Minnesota; and
2.16	(3) has organizational revenue for fiscal year 2019 of equal to or less than \$1,500,000,
2.17	as reported by the nonprofit on the federal IRS Form 990.
2.18	(b) Grants shall be awarded by the intermediary through a request for proposal process.
2.19	Selection shall be based on the significance of the project, financial need of the organization,
2.20	available matching funds, and number of people served by the improvements. Projects to
2.21	achieve compliance with the requirements of the ADA shall be given priority. Geographic
2.22	balance in awarding grants throughout Minnesota shall also be a priority.
2.23	(c) The maximum grant to an eligible grantee under this section is \$2,000,000.
2.24	Subd. 5. Report to the legislature. By January 15, 2023, the intermediary organization
2.25	must submit an initial report to the chairs and ranking minority members of the legislative
2.26	committees with jurisdiction over economic development on the use of funds under this
2.27	section and grant outcomes. A final report, with metrics to gauge geographic and diverse
2.28	impacts, is due to the legislature by the intermediary organization upon full expenditure of
2.29	the funds appropriated in section 2.
2.30	<b>EFFECTIVE DATE.</b> This section is effective the day following final enactment.

\$50,000,000 in fiscal year 2023 is appropriated from the general fund to the commissioner of employment and economic development for accessibility for arts and cultural economy grants under section 1. Of this amount, 0.1 percent is for the commissioner of employment and economic development to administer the program. This is a onetime appropriation and is available until December 31, 2024.
