(a) Resident trust means a trust, except a grantor type trust, 1.15 which either (1) was created by a will of a decedent who at death was domiciled in this state 1.16 or (2) is an irrevocable trust, the grantor of which was domiciled in this state at the time the 1.17 trust became irrevocable. For the purpose of this subdivision, a trust is considered irrevocable 1.18 to the extent the grantor is not treated as the owner thereof under sections 671 to 678 of the 1.19 Internal Revenue Code. The term "grantor type trust" means a trust where the income or 1.20 gains of the trust are taxable to the grantor or others treated as substantial owners under 1.21
