BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA: 1.4 Section 1. COVID-19 EMERGENCY COMMUNITY RELIEF GRANTS. 1.5 Subdivision 1. Establishment. The COVID-19 emergency community relief grants 1.6 program is established to award grants to eligible nonprofit organizations to make grants 1.7 to individuals experiencing financial hardship as a result of the COVID-19 outbreak. For 1.8 purposes of this section, "eligible nonprofit organizations" includes community intermediaries 1.9 such as local community foundations, Minnesota Initiative Foundations, tribal nations, 1.10 community development financial institutions, coalitions, networks, associations, or other 1.11 intermediaries that have an existing grant-making process in place, as directed by the 1.12 Minnesota Disaster Recovery Fund (MDRF) and determined by the St. Paul & Minnesota 1.13 Foundation. 1.14 Subd. 2. **Statewide grants.** To the extent practicable, grants shall be made so that an 1.15 approximately equal dollar amount of grants are made to individuals in the metropolitan 1.16 area and the nonmetropolitan area. 1.17 Subd. 3. Eligibility for individuals. In order to qualify for a grant, an individual must 1.18 be able to demonstrate financial hardship as a result of the COVID-19 outbreak. Financial 1.19 hardship includes but is not limited to showing that an individual: 1.20
