1.12	Subd. 3. Requirements. (a) In conducting the pilot program, the commissioner must:

1.15	district, including one at the intersection of marked Trunk Highway 55, also known as Olson
1.16	Memorial Highway, and Van White Memorial Boulevard in the city of Minneapolis; and
1.17	(ii) at least five art projects located outside the metropolitan district;
1.18	(2) locate the art projects in trunk highway rights-of-way;
1.19	(3) require that the artwork installation is primarily applied to the roadway or shoulder;
