1.7	Subdivision 1. <b>Issuance of plates.</b> The commissioner must issue waterfowl critical
1.8	habitat special license plates or a single motorcycle plate to an applicant who:
1.9	(1) is a registered owner of a passenger automobile, noncommercial one-ton pickup
1.10	truck, motorcycle, or recreational motor vehicle;
1.11	(2) pays a fee in the amount specified for special plates under section 168.12, subdivision
1.12	5, for each set of plates, along with any other fees required by this chapter;
1.13	(3) pays the registration tax required under section 168.013;
1.14	(4) contributes a minimum of \$30 annually to the Minnesota critical habitat private

2.5	(2) registered to the same individual to whom the special plates were originally issued.

2.8	Subd. 5. Contributions. Contributions collected under subdivision 1, clause (4), must

2.11	<b>EFFECTIVE DATE.</b> This section is effective January 1, 2025, for waterfowl critical
2.12	habitat special plates issued on or after that date.
