1.14 Section 1. 268B.001 CITATION.

1.15 This chapter may be cited as the "Minnesota Paid Leave Law."

1.16 EFFECTIVE DATE. This section is effective the day following final enactment.

1.17 Sec. 2. Minnesota Statutes 2023 Supplement, section 268B.01, subdivision 3, is amended

1.18 to read:

1.19 Subd. 3. **Applicant.** "Applicant" means an individual or the individual's authorized

1.20 representative applying for leave with benefits under this chapter.

1.21 EFFECTIVE DATE. This section is effective the day following final enactment.

2.1 Sec. 3. Minnesota Statutes 2023 Supplement, section 268B.01, is amended by adding a  
2.2 subdivision to read:

2.3 Subd. 4a. **Authorized representative.** "Authorized representative" means an individual  
2.4 designated by the person or the individual's legal representative to act on their behalf. This  
2.5 individual may be a family member, guardian, or other individual designated by the person  
2.6 or the individual's legal representative, if any, to assist in purchasing and arranging for  
2.7 supports. For the purposes of this chapter, an authorized representative must be at least 18  
2.8 years of age.

2.9 **EFFECTIVE DATE.** This section is effective the day following final enactment.

2.10 Sec. 4. Minnesota Statutes 2023 Supplement, section 268B.01, subdivision 5, is amended  
2.11 to read:

2.12 Subd. 5. **Base period.** (a) "Base period," unless otherwise provided in this subdivision,  
2.13 means the most recent four completed calendar quarters before the effective date of an  
2.14 applicant's application for family or medical leave benefits if the application has an effective  
2.15 date occurring after the month following the most recent completed calendar quarter. The  
2.16 base period under this paragraph is as follows:

2.17 If the application for family or medical leave	
2.18 benefits is effective on or between these	
2.19 dates:	The base period is the prior:
2.20 February 1 to March 31	January 1 to December 31
2.21 May 1 to June 30	April 1 to March 31
2.22 August 1 to September 30	July 1 to June 30
2.23 November 1 to December 31	October 1 to September 30

2.24 (b) If an application for family or medical leave benefits has an effective date that is  
2.25 during the month following the most recent completed calendar quarter, then the base period  
2.26 is the first four of the most recent five completed calendar quarters before the effective date  
2.27 of an applicant's application for family or medical leave benefits. The base period under  
2.28 this paragraph is as follows:

2.29 If the application for family or medical leave	
2.30 benefits is effective on or between these	
2.31 dates:	The base period is the prior:
2.32 January 1 to January 31	October 1 to September 30
2.33 April 1 to April 30	January 1 to December 31
2.34 July 1 to July 31	April 1 to March 31
2.35 October 1 to October 31	July 1 to June 30

3.1 (c) Regardless of paragraph (a), a base period of the first four of the most recent five  
3.2 completed calendar quarters must be used if the applicant would have more wage credits  
3.3 under that base period than under a base period of the four most recent completed calendar  
3.4 quarters.

3.5 (d) If the applicant has insufficient wage credits to establish a benefit account under a  
3.6 base period of the four most recent completed calendar quarters, or a base period of the first  
3.7 four of the most recent five completed calendar quarters, but during either base period the  
3.8 applicant received workers' compensation for temporary disability under chapter 176 or a  
3.9 similar federal law or similar law of another state, or if the applicant whose own serious  
3.10 illness caused a loss of work for which the applicant received compensation for loss of  
3.11 wages from some other source, the applicant may request a base period as follows:

3.12 (1) if an applicant was compensated for a loss of work of seven to 13 weeks during a  
3.13 base period referred to in paragraph (a) or (b), then the base period is the first four of the  
3.14 most recent six completed calendar quarters before the effective date of the application for  
3.15 family or medical leave benefits;

3.16 (2) if an applicant was compensated for a loss of work of 14 to 26 weeks during a base  
3.17 period referred to in paragraph (a) or (b), then the base period is the first four of the most  
3.18 recent seven completed calendar quarters before the effective date of the application for  
3.19 family or medical leave benefits;

3.20 (3) if an applicant was compensated for a loss of work of 27 to 39 weeks during a base  
3.21 period referred to in paragraph (a) or (b), then the base period is the first four of the most  
3.22 recent eight completed calendar quarters before the effective date of the application for  
3.23 family or medical leave benefits; and

3.24 (4) if an applicant was compensated for a loss of work of 40 ~~to 52~~ or more weeks during  
3.25 a base period referred to in paragraph (a) or (b), then the base period is the first four of the  
3.26 most recent nine completed calendar quarters before the effective date of the application  
3.27 for family or medical leave benefits.

3.28 (e) For an applicant under a private plan as provided in section 268B.10, the base period  
3.29 is those most recent four quarters in which wage credits were earned ~~with the current~~  
3.30 ~~employer as provided by the current employer~~. If an employer does not have four quarters  
3.31 of wage detail information, the employer must accept an employee's certification of wage  
3.32 credits, based on the employee's records. If the employee does not provide certification of  
3.33 additional wage credits, the employer may use a base period that consists of all available  
3.34 quarters.

4.1 (f) The base period is calculated once during the benefit year.

4.2 **EFFECTIVE DATE.** This section is effective the day following final enactment.

4.21 Employers are required to notify employees of their benefit year within 30 days of the  
4.22 private plan approval and first day of employment.

4.23 (d) For individuals with multiple employers with at least one employer participating in  
4.24 the state plan and at least one employer participating in a private plan:

4.25 (1) for the employer or employers participating in the state plan, "benefit year" means  
4.26 the period of 52 calendar weeks beginning the effective date of leave is effective for any  
4.27 employer; and

4.28 (2) the employer or employers participating in a private plan may define their benefit  
4.29 year according to paragraph (b).

4.30 **EFFECTIVE DATE.** This section is effective the day following final enactment.

5.4 of whatever nature, unlimited by the relationship of master and servant as known to the  
5.5 common law, or any other legal relationship performed for wages or under any contract  
5.6 calling for the performance of services, written or oral, express or implied.

5.7 (b) For the purposes of this chapter, covered employment means an employee's entire  
5.8 employment during a calendar ~~year~~ quarter if:

5.9 (1) 50 percent or more of the employment during the calendar ~~year~~ quarter is performed  
5.10 in Minnesota; or

5.11 (2) 50 percent or more of the employment during the calendar ~~year~~ quarter is not  
5.12 performed in Minnesota or any other single state within the United States, or ~~Canada~~ United  
5.13 States territory or foreign nation, but some of the employment is performed in Minnesota  
5.14 and the employee's residence is in Minnesota during 50 percent or more of the calendar  
5.15 ~~year quarter~~; or.

5.16 ~~(3) 50 percent or more of the employment during the calendar year is not performed in~~  
5.17 ~~Minnesota or any other state, or Canada, but the place from where the employee's~~  
5.18 ~~employment is controlled and directed is based in Minnesota.~~

5.19 (c) "Covered employment" does not include:

5.20 (1) a self-employed individual;

5.21 (2) an independent contractor; or

5.22 (3) employment by a seasonal employee, as defined in subdivision 35.

5.23 (d) Entities that are excluded under this section may opt in to coverage following a  
5.24 procedure determined by the commissioner. In such cases, services provided by employees  
5.25 are considered covered employment under subdivision 15.

5.26 (e) The commissioner may adopt rules in accordance with chapter 14 to:

5.27 (1) further define the application of this subdivision; and

5.28 (2) establish the criteria for covered employment for individuals that do not meet the  
5.29 criteria in paragraphs (a) and (b), but that perform services as an employee to a Minnesota  
5.30 employer.

6.23 (2) a child, including a biological child, adopted child, ~~or~~ foster child, a stepchild, child  
6.24 of a domestic partner, or a child to whom the applicant stands in loco parentis, is a legal  
6.25 guardian, or is a de facto ~~parent~~ custodian;

6.26 (3) a parent or legal guardian of the applicant;

6.27 (4) a sibling;

6.28 (5) a grandchild;

6.29 (6) a grandparent or spouse's grandparent;

7.1 (7) a son-in-law or daughter-in-law; and

7.10 spouse, or an individual who stood in loco parentis to an applicant when the applicant was  
7.11 a child.

7.20 Subd. 27a. **Initial paid week.** "Initial paid week," except as provided in section 268B.04,  
7.21 subdivision 6, means the first seven days of a leave, which must be paid and is a payable  
7.22 period for leave types including family care, medical care related to pregnancy, serious  
7.23 health condition, qualifying exigency, or safety leave. For intermittent leave, initial paid  
7.24 week means seven consecutive or nonconsecutive, or a combination of consecutive and  
7.25 nonconsecutive, calendar days from the effective date of leave, of which only days when  
7.26 leave is taken are payable.

8.8 **268B.04 BENEFIT ACCOUNT FINANCIAL ELIGIBILITY; BENEFITS.**

8.9 Subdivision 1. **Application for benefits; determination of benefit account financial**  
 8.10 **eligibility.** (a) An application for benefits may be filed up to 60 days before leave taken  
 8.11 under chapter 268B in person, by mail, or by electronic transmission as the commissioner  
 8.12 may require. The applicant must include certification supporting a request for leave under  
 8.13 this chapter. The applicant must meet eligibility requirements and must provide all requested  
 8.14 information in the manner required. If the applicant fails to provide all requested information;  
 8.15 ~~the communication is not an application for family and medical leave benefits~~ within a time  
 8.16 period to be specified by the commissioner, the application is considered closed and the  
 8.17 division must not further act on it.

8.18 (b) The commissioner must examine each application for benefits to determine the base  
 8.19 period and the benefit year, and based upon all the covered employment in the base period  
 8.20 the commissioner must determine the financial eligibility of the applicant, which includes  
 8.21 the weekly benefit amount available, if any, and the maximum amount of benefits available,  
 8.22 if any. ~~The determination, which is a document separate and distinct from a document titled~~  
 8.23 ~~a determination of eligibility or determination of ineligibility, must be titled determination~~  
 8.24 ~~of benefit account. A determination of benefit account must be sent to the applicant and all~~  
 8.25 ~~base period employers, by mail or electronic transmission.~~

8.26 (c) If a base period employer did not provide wage detail information for the applicant  
 8.27 as required under section 268B.12, the commissioner may accept an applicant certification  
 8.28 of wage credits, based upon the applicant's records, and ~~issue a determination of benefit~~  
 8.29 ~~account~~ determine the financial eligibility of the applicant.

8.30 (d) The commissioner may, at any time within 12 months from the establishment of a  
 8.31 ~~benefit account~~ leave, reconsider any determination of benefit account and make an amended  
 8.32 determination if the commissioner finds that the wage credits listed in the determination  
 8.33 were incorrect for any reason. An amended determination of benefit account must be



9.1 promptly sent to the applicant and ~~all~~ any impacted base period employers, by mail or  
 9.2 electronic transmission. This paragraph does not apply to ~~documents-titled~~ determinations  
 9.3 of eligibility or determinations of ineligibility issued.

9.4 (e) If an amended determination of benefit account reduces the weekly benefit amount  
 9.5 or maximum amount of benefits available, any benefits that have been paid greater than the  
 9.6 applicant was entitled is an overpayment of benefits. A determination or amended  
 9.7 determination issued under this section that results in an overpayment of benefits must set  
 9.8 out the amount of the overpayment and the requirement that the overpaid benefits must be  
 9.9 repaid according to section 268B.185.

9.10 Subd. 2. **Benefit account requirements.** To establish a benefit account, an applicant  
 9.11 must have wage credits of at least 5.3 percent of the state's average annual wage rounded  
 9.12 down to the next lower \$100.

9.13 Subd. 3. **Weekly benefit amount; maximum amount of benefits available; prorated**  
 9.14 **amount.** (a) Subject to the maximum weekly benefit amount, an applicant's weekly benefit  
 9.15 is calculated by adding the amounts obtained by applying the following percentage to an  
 9.16 applicant's average ~~typical workweek~~ and weekly wage during the high quarter of the base  
 9.17 period:

9.18 (1) 90 percent of wages that do not exceed 50 percent of the state's average weekly wage;  
 9.19 plus

9.20 (2) 66 percent of wages that exceed 50 percent of the state's average weekly wage but  
 9.21 not 100 percent; plus

9.22 (3) 55 percent of wages that exceed 100 percent of the state's average weekly wage.

9.23 (b) For applicants that have changed employers within the base period, the weekly benefit  
 9.24 amount is calculated based on the highest quarter of wages in the base period.

9.25 ~~(b)~~ (c) The state's average weekly wage is the average wage as calculated under section  
 9.26 268.035, subdivision 23, at the time a benefit amount is first determined.

9.27 ~~(c)~~ (d) The maximum weekly benefit amount is the state's average weekly wage as  
 9.28 calculated under section 268.035, subdivision 23.

9.29 ~~(d)~~ (e) The state's maximum weekly benefit amount, computed in accordance with section  
 9.30 268.035, subdivision 23, applies to a benefit account leaves established effective on or after  
 9.31 the last Sunday in October. Once established, an applicant's weekly benefit amount is not  
 9.32 affected by the last Sunday in October change in the state's maximum weekly benefit amount.

10.1 ~~(e)~~ (f) For an ~~employee~~ covered individual receiving family or medical leave, a weekly  
 10.2 benefit amount is prorated when:

10.3 (1) the ~~employee~~ covered individual works hours for wages;

10.4 (2) the ~~employee~~ covered individual uses paid sick leave, paid vacation leave, or other  
 10.5 paid time off that is not considered a supplemental benefit payment as defined in section  
 10.6 268B.01, subdivision 41; or

10.7 (3) leave is taken intermittently.

10.8 Subd. 4. **Timing of payment.** Except as otherwise provided for in this chapter, benefits  
 10.9 must be paid weekly.

10.10 Subd. 5. **Maximum length of benefits.** (a) The total number of weeks that an applicant  
 10.11 may take benefits in a single benefit year for a serious health condition is the lesser of 12  
 10.12 weeks, or 12 weeks minus the number of weeks within the same benefit year that the  
 10.13 applicant received benefits for bonding, safety leave, family care, ~~or~~ and qualifying exigency  
 10.14 plus eight weeks.

10.15 (b) The total number of weeks that an applicant may take benefits in a single benefit  
 10.16 year for bonding, safety leave, family care, ~~or~~ and qualifying exigency is the lesser of 12  
 10.17 weeks, or 12 weeks minus the number of weeks within the same benefit year that the  
 10.18 applicant received benefits for a serious health condition plus eight weeks.

10.19 Subd. 6. **Minimum period for which benefits payable.** (a) Except for a claim for  
 10.20 benefits for bonding leave, any claim for benefits must be based on a single qualifying event  
 10.21 of at least seven calendar days. ~~The minimum duration to receive benefits under this chapter~~  
 10.22 ~~is one work day in a work week.~~

10.23 (b) The initial paid week is only payable if the applicant submits documentation to the  
 10.24 commissioner's satisfaction demonstrating that the applicant does not have at least 80 hours  
 10.25 of paid vacation leave, paid sick leave, or other paid time off available to them from the  
 10.26 employer from whom they are taking leave at the earlier of the effective date of application  
 10.27 or the effective date of leave. For an applicant having an available leave balance of 80 hours  
 10.28 or less, the program pays the first week in its entirety.

10.29 (c) The initial paid week is partially payable if the applicant submits documentation to  
 10.30 the commissioner's satisfaction demonstrating that the applicant has more than 80 hours  
 10.31 and less than 120 hours of paid vacation leave, paid sick leave, or other paid time off available  
 10.32 to them from the employer from whom they are taking leave at the earlier of the effective  
 10.33 date of application or the effective date of leave. The department shall prorate the initial

11.1 paid week based on the applicant's leave balance, so as not to go below 80 available leave  
 11.2 hours remaining at the end of the initial paid week.

11.3 (d) The requirements in paragraphs (b) and (c) do not apply to bonding leave.

11.4 Subd. 6a. **Minimum increment of leave.** Intermittent leave must be taken in increments  
 11.5 consistent with the established policy of the employer to account for use of other forms of  
 11.6 leave, so long as such employer's policy permits a minimum increment of at most one  
 11.7 calendar day of intermittent leave. An applicant is not permitted to apply for payment for  
 11.8 benefits associated with intermittent leave until the applicant has eight hours of accumulated  
 11.9 leave time, unless more than 30 calendar days have lapsed since the initial taking of the  
 11.10 leave.

11.11 ~~Subd. 7. **Right of appeal.** (a) A determination or amended determination of benefit~~  
 11.12 ~~account is final unless an appeal is filed by the applicant within 60 calendar days after the~~  
 11.13 ~~sending of the determination or amended determination.~~

11.14 ~~(b) Any applicant may appeal from a determination or amended determination of benefit~~  
 11.15 ~~account on the issue of whether services performed constitute employment, whether the~~  
 11.16 ~~employment is covered employment, and whether money paid constitutes wages.~~

11.17 **Subd. 8. Limitations on applications and benefit accounts leaves.** (a) An application  
 11.18 for family or medical leave benefits is effective the Sunday of the calendar week that the  
 11.19 application was filed. An application for benefits may be backdated one calendar week  
 11.20 before the Sunday of the week the application was actually filed if the applicant requests  
 11.21 the backdating within seven calendar days of the ~~date the application is filed~~ effective date  
 11.22 of application. An application may be backdated only if the applicant was eligible for the  
 11.23 benefit during the period of the backdating. If an individual attempted to file an application  
 11.24 for benefits, but was prevented from filing an application by the department, the application  
 11.25 is effective the Sunday of the calendar week the individual first attempted to file an  
 11.26 application.

11.27 (b) If the applicant was unable to apply in a timely manner due to incapacitation or due  
 11.28 to no fault of their own, the commissioner may backdate the claim beyond one calendar  
 11.29 week to the effective date of leave. The commissioner may require the employee to prove  
 11.30 the circumstances that prevented timely filing.

11.31 **EFFECTIVE DATE.** This section is effective November 1, 2025.

23.19 (d) If the appellant failed to participate in the hearing, the hearing officer must issue an  
23.20 order setting aside the decision and ordering an additional hearing if the party who failed  
23.21 to participate had good cause for failing to do so. The appellant who failed to participate in  
23.22 the hearing must be informed of the requirement to show good cause for failing to participate.  
23.23 If the hearing officer determines that good cause for failure to participate has not been  
23.24 shown, the judge must state that determination in the decision issued under paragraph (f).  
23.25 Submission of a written statement at the hearing does not constitute participation for purposes  
23.26 of this paragraph. "Good cause" for purposes of this paragraph is a reason that would have  
23.27 prevented a reasonable person acting with due diligence from participating in the hearing.

23.28 (e) A request for reconsideration must be decided by the hearing officer who issued the  
23.29 decision under subdivision 5 unless that hearing officer:

23.30 (1) is no longer employed by the department as a hearing officer;

23.31 (2) is on an extended or indefinite leave; or

23.32 (3) has been removed from the proceedings by the department.

24.1 (f) If a request for reconsideration is timely filed, the hearing officer must issue:

24.2 (1) a decision affirming the findings of fact, reasons for the decision, and a decision  
24.3 issued under subdivision 5;

24.4 (2) a decision modifying the findings of fact, reasons for the decision, and a decision  
24.5 issued under subdivision 5; or

24.6 (3) an order setting aside the findings of fact, reasons for the decision, and a decision

**268B.06 ELIGIBILITY REQUIREMENTS; PAYMENTS THAT AFFECT BENEFITS.**

Subd. 7. **Separation, severance, or bonus payments.** (a) An applicant is not eligible to receive benefits for any week the applicant is receiving, has received, or will receive separation pay, severance pay, bonus pay, or any other payments paid by an employer because of, upon, or after separation from employment. This subdivision applies if the payment is:

(1) considered wages under section 268B.01, subdivision 47; or

(2) subject to the Federal Insurance Contributions Act (FICA) tax imposed to fund Social Security and Medicare.

(b) Payments under this subdivision are applied to the period immediately following the later of the date of separation from employment or the date the applicant first becomes aware that the employer will be making a payment. The date the payment is actually made or received, or that an applicant must agree to a release of claims, does not affect the application of this paragraph.

(c) This subdivision does not apply to vacation pay, sick pay, personal time off pay, or supplemental benefit payment under subdivision 4.

(d) This subdivision applies to all the weeks of payment.

(e) Under this subdivision, if the payment with respect to a week is equal to or more than the applicant's weekly benefit amount, the applicant is ineligible for benefits for that week. If the payment with respect to a week is less than the applicant's weekly benefit amount, benefits are reduced by the amount of the payment.

**268B.08 APPEAL PROCESS.**

Subdivision 1. **Hearing.** (a) The commissioner shall designate a chief hearing officer.

(b) Upon a timely appeal to a determination having been filed or upon a referral for direct hearing, the chief hearing officer must set a time and date for a de novo due-process hearing and send notice to an applicant and an employer, by mail or electronic transmission, not less than ten calendar days before the date of the hearing.

(c) The commissioner may adopt rules on procedures for hearings. The rules need not conform to common law or statutory rules of evidence and other technical rules of procedure.

(d) The chief hearing officer has discretion regarding the method by which the hearing is conducted.

(e) The chief hearing officer must assign a hearing officer to conduct a hearing and may transfer to another hearing officer any proceedings pending before another hearing officer.

Subd. 2. **Decision.** (a) After the conclusion of the hearing, upon the evidence obtained, the hearing officer must serve by mail or electronic transmission to all parties the decision, reasons for the decision, and written findings of fact.

(b) Decisions of a hearing officer are not precedential.

Subd. 3. **Request for reconsideration.** Any party, or the commissioner, may, within 30 calendar days after service of the hearing officer's decision, file a request for reconsideration asking the hearing officer to reconsider that decision.

Subd. 4. **Appeal to court of appeals.** Any final determination on a request for reconsideration may be appealed by any party directly to the Minnesota Court of Appeals.

Subd. 11. **Appeals.** (a) An employer may appeal any adverse action regarding that employer's application for private provision of the medical benefit or family benefit program, in a manner specified by the commissioner.

(b) An employee covered under a private plan has the same right to appeal to the state under section 268B.04, subdivision 7, as any other employee. An employee covered under a private plan has the right to request reconsideration of a decision under a private plan made by an insurer, private plan administrator, or employer prior to exercising appeal rights under section 268B.04.

Subd. 5. **Small business wage exclusion.** (a) For employers with fewer than 30 employees, the amount of wages upon which quarterly employer premium is required is reduced by the premium rate to be paid by the employer multiplied by the lesser of:

- (1) \$12,500 multiplied by the number of employees; or
- (2) \$120,000.

(b) For each employee over 20 employees, the exclusion is reduced by \$12,000.

(c) The premium paid by the employer as a result of the reduction allowed under this subdivision must not be less than zero.

(d) The reduction in premiums paid by the employer is for the sole benefit of the employer and does not relieve the employer from deducting the employee portion of the premium.
