1.9	more than 11 million jobs nationwide, including 172,900 total jobs and \$23 billion in gross domestic
1.10	income in Minnesota alone; and
1.11	WHEREAS, United States energy abundance has provided security that has historically led
1.12	to reliable, affordable energy for American consumers and our allies; and
1.13	WHEREAS, the world is looking to America for energy leadership and stability as current
1.14	geopolitical events pose potential economic disruptions when inflation already affects households,
1.15	both in the United States and across Europe; and
1.16	WHEREAS, operation and expansion of a key component of America's energy success, our
1.17	oil and natural gas pipelines, which provide the most efficient means of transporting those
1.18	commodities, are being blocked by the federal government and many state governments; and
1.19	WHEREAS, the Biden administration continues to increase costs and delay efforts to develop
1.20	oil and natural gas leasing on federal lands and waters despite the fact that the program provides
1.21	billions in revenues to federal, state, and local governments and supports conservation programs
1.22	throughout the country; and
1.23	WHEREAS, United States offshore production is one of the least carbon-intensive
1.24	energy-producing regions in the world, and halting offshore leasing and development will shift
1.25	production and capital investment overseas and undermine decades of environmental progress;
