2.11 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

2.12 ARTICLE 1

2.13 REGULATION OF ADULT-USE CANNABIS

2.14 Section 1. 342.01 DEFINITIONS.

2.15 Subdivision 1. Terms. For the purposes of this chapter, the following terms have the
 2.16 meanings given them.

2.17 Subd. 2. Adult-use cannabinoid product. "Adult-use cannabinoid product" means a
 2.18 cannabinoid product that is approved for sale by the office or is substantially similar to a
 2.19 product approved by the office. Adult-use cannabinoid product includes edible cannabinoid
 2.20 products but does not include medical cannabinoid products.

2.21 Subd. 3. Adult-use cannabis concentrate. "Adult-use cannabis concentrate" means
 2.22 cannabis concentrate that is approved for sale by the office or is substantially similar to a
 2.23 product approved by the office. Adult-use cannabis concentrate does not include artificially
 2.24 derived cannabinoids.

2.25 Subd. 4. Adult-use cannabis flower. "Adult-use cannabis flower" means cannabis
 2.26 flower that is approved for sale by the office or is substantially similar to a product approved
 2.27 by the office. Adult-use cannabis flower does not include medical cannabis flower, hemp
 2.28 plant parts, or hemp-derived consumer products.

2.29 Subd. 5. Advertisement. "Advertisement" means any written or oral statement,
 2.30 illustration, or depiction that is intended to promote sales of cannabis flower, cannabinoid
 2.31 products, lower potency edible products, hemp-derived consumer products, or sales at a
 2.32 specific cannabis business and includes any newspaper, radio, internet and electronic media,
 2.33 or television promotion; the distribution of fliers and circulars; and the display of window
 2.34 and interior signs in a cannabis business. Advertisement does not include a fixed outdoor
 2.35 sign that meets the requirements in section 342.66, subdivision 2, paragraph (b).

3.1 Subd. 6. **Artificially derived cannabinoid.** "Artificially derived cannabinoid" means a
3.2 cannabinoid extracted from a cannabis plant, cannabis flower, hemp plant, or hemp plant
3.3 parts with a chemical makeup that is changed after extraction to create a different cannabinoid
3.4 or other chemical compound by applying a catalyst other than heat or light. Artificially
3.5 derived cannabinoid includes but is not limited to any tetrahydrocannabinol created from
3.6 cannabidiol but does not include cannabis concentrate, cannabinoid products, or hemp-derived
3.7 consumer products.

3.8 Subd. 7. **Batch.** "Batch" means:

3.9 (1) a specific quantity of cannabis plants that are cultivated from the same seed or plant
3.10 stock, are cultivated together, are intended to be harvested together, and receive an identical
3.11 propagation and cultivation treatment; or

3.12 (2) a specific quantity of a specific cannabinoid product, lower potency edible product,
3.13 artificially derived cannabinoid, or hemp-derived consumer product that is manufactured
3.14 at the same time and using the same methods, equipment, and ingredients that is uniform
3.15 and intended to meet specifications for identity, strength, purity, and composition, and that
3.16 is manufactured, packaged, and labeled according to a single batch production record
3.17 executed and documented during the same cycle of manufacture and produced by a
3.18 continuous process.

3.19 Subd. 8. **Batch number.** "Batch number" means a unique numeric or alphanumeric
3.20 identifier assigned to a batch of cannabis flower or a batch of cannabinoid product, lower
3.21 potency edible product, artificially derived cannabinoid, or hemp-derived consumer product.

3.22 Subd. 9. **Bona fide labor organization.** "Bona fide labor organization" means a labor
3.23 union that represents or is actively seeking to represent cannabis workers.

3.24 Subd. 10. **Cannabinoid.** "Cannabinoid" means any of the chemical constituents of hemp
3.25 plants or cannabis plants that are naturally occurring, biologically active, and act on the
3.26 cannabinoid receptors of the brain. Cannabinoid includes but is not limited to
3.27 tetrahydrocannabinol and cannabidiol.

3.28 Subd. 11. **Cannabinoid extraction.** "Cannabinoid extraction" means the process of
3.29 extracting cannabis concentrate from cannabis plants or cannabis flower using water, lipids,
3.30 gases, solvents, or other chemicals or chemical processes, but does not include the process
3.31 of extracting concentrate from hemp plants or hemp plant parts or the process of creating
3.32 artificially derived cannabinoids.

3.33 Subd. 12. **Cannabinoid product.** (a) "Cannabinoid product" means any of the following:

4.1 (1) cannabis concentrate;

4.2 (2) a product infused with cannabinoids, including but not limited to tetrahydrocannabinol,
4.3 extracted or derived from cannabis plants or cannabis flower;

4.4 (3) any other product that contains cannabis concentrate; or

4.5 (4) a product infused with artificially derived cannabinoids.

4.6 (b) Cannabinoid product includes adult-use cannabinoid products, including but not
4.7 limited to edible cannabinoid products, and medical cannabinoid products. Cannabinoid
4.8 product does not include cannabis flower, artificially derived cannabinoids, or hemp-derived
4.9 consumer products.

4.10 Subd. 13. **Cannabinoid profile.** "Cannabinoid profile" means the amounts of each
4.11 cannabinoid that the office requires to be identified in testing and labeling, including but
4.12 not limited to delta-9 tetrahydrocannabinol, tetrahydrocannabinolic acid, cannabidiol, and
4.13 cannabidiolic acid in cannabis flower, a cannabinoid product, a batch of artificially derived
4.14 cannabinoid, or a hemp-derived consumer product, expressed as percentages measured by
4.15 weight and, in the case of cannabinoid products and hemp-derived consumer products,
4.16 expressed as milligrams in each serving and package.

4.17 Subd. 14. **Cannabis business.** "Cannabis business" means any of the following licensed
4.18 under this chapter:

4.19 (1) cannabis cultivator;

4.20 (2) cannabis manufacturer;

4.21 (3) cannabis retailer;

4.22 (4) cannabis wholesaler;

4.23 (5) cannabis transporter;

4.24 (6) cannabis testing facility;

4.25 (7) cannabis microbusiness;

4.26 (8) cannabis event organizer;

4.27 (9) cannabis delivery service;

4.28 (10) lower potency edible retailer;

4.29 (11) medical cannabis cultivator;

4.30 (12) medical cannabis processor; and

5.1 (13) medical cannabis retailer.

5.2 Subd. 15. **Cannabis concentrate.** (a) "Cannabis concentrate" means:

5.3 (1) the extracts and resins of a cannabis plant or cannabis flower;

5.4 (2) the extracts or resins of a cannabis plant or cannabis flower that are refined to increase
5.5 the presence of targeted cannabinoids; or

5.6 (3) a product that is produced by refining extracts or resins of a cannabis plant or cannabis
5.7 flower and is intended to be consumed by combustion or vaporization of the product and
5.8 inhalation of smoke, aerosol, or vapor from the product.

5.9 (b) Cannabis concentrate does not include industrial hemp, artificially derived
5.10 cannabinoids, or hemp-derived consumer products.

5.11 Subd. 16. **Cannabis flower.** "Cannabis flower" means the harvested flower, bud, leaves,
5.12 and stems of a cannabis plant. Cannabis flower includes adult-use cannabis flower and
5.13 medical cannabis flower. Cannabis flower does not include cannabis seed, industrial hemp,
5.14 or hemp-derived consumer products.

5.15 Subd. 17. **Cannabis industry.** "Cannabis industry" means every item, product, person,
5.16 process, action, business, or other thing subject to regulation under this chapter.

5.17 Subd. 18. **Cannabis paraphernalia.** "Cannabis paraphernalia" means all equipment,
5.18 products, and materials of any kind that are knowingly or intentionally used primarily in:

5.19 (1) cultivating or harvesting cannabis plants or cannabis flower;

5.20 (2) manufacturing cannabinoid products;

5.21 (3) ingesting, inhaling, or otherwise introducing cannabis flower or cannabinoid products
5.22 into the human body; and

5.23 (4) testing the strength, effectiveness, or purity of cannabis flower, cannabinoid products,
5.24 or hemp-derived consumer products.

5.25 Subd. 19. **Cannabis plant.** "Cannabis plant" means all parts of the plant of the genus
5.26 Cannabis that is growing or has not been harvested and has a delta-9 tetrahydrocannabinol
5.27 concentration of more than 0.3 percent on a dry weight basis.

5.28 Subd. 20. **Cannabis prohibition.** "Cannabis prohibition" means the system of state and
5.29 federal laws that prevented establishment of a legal market and instead established petty
5.30 offenses and criminal offenses punishable by fines, imprisonment, or both for the cultivation,
5.31 possession, and sale of all parts of the plant of any species of the genus Cannabis, including

6.1 all agronomical varieties, whether growing or not; the seeds thereof; the resin extracted
6.2 from any part of such plant; and every compound, manufacture, salt, derivative, mixture,
6.3 or preparation of such plant, its seeds, or resin.

6.4 Subd. 21. **Cannabis seed.** "Cannabis seed" means the viable seed of the plant of the
6.5 genus Cannabis that is reasonably expected to grow into a cannabis plant. Cannabis seed
6.6 does not include hemp seed.

6.7 Subd. 22. **Cannabis worker.** "Cannabis worker" means any individual employed by a
6.8 cannabis business and any individual who is a contractor of a cannabis business whose
6.9 scope of work involves the handling of cannabis plants, cannabis flower, artificially derived
6.10 cannabinoids, or cannabinoid products.

6.11 Subd. 23. **Child-resistant.** "Child-resistant" means packaging that meets the poison
6.12 prevention packaging standards in Code of Federal Regulations, title 16, section 1700.15.

6.13 Subd. 24. **Cooperative.** "Cooperative" means an association conducting business on a
6.14 cooperative plan that is organized or is subject to chapter 308A or 308B.

6.15 Subd. 25. **Council.** "Council" means the Cannabis Advisory Council.

6.16 Subd. 26. **Cultivation.** "Cultivation" means any activity involving the planting, growing,
6.17 harvesting, drying, curing, grading, or trimming of cannabis plants, cannabis flower, hemp
6.18 plants, or hemp plant parts.

6.19 Subd. 27. **Division of Medical Cannabis.** "Division of Medical Cannabis" means a
6.20 division housed in the Office of Cannabis Management that operates the medical cannabis
6.21 program.

6.22 Subd. 28. **Division of Social Equity** "Division of Social Equity" means a division housed
6.23 in the Office of Cannabis Management that promotes development, stability, and safety in
6.24 communities that have experienced a disproportionate, negative impact from cannabis
6.25 prohibition.

6.26 Subd. 29. **Edible cannabinoid product.** "Edible cannabinoid product" means any
6.27 product that is intended to be eaten or consumed as a beverage by humans; contains a
6.28 cannabinoid, including an artificially derived cannabinoid, in combination with food
6.29 ingredients; is not a drug; and is a type of product approved for sale by the office, or is
6.30 substantially similar to a product approved by the office including but not limited to products
6.31 that resemble nonalcoholic beverages, candy, and baked goods. Edible cannabinoid product
6.32 includes lower potency edible products.

7.1 Subd. 30. **Health care practitioner.** "Health care practitioner" means a
7.2 Minnesota-licensed doctor of medicine, a Minnesota-licensed physician assistant acting
7.3 within the scope of authorized practice, or a Minnesota-licensed advanced practice registered
7.4 nurse who has the primary responsibility for the care and treatment of the qualifying medical
7.5 condition of an individual diagnosed with a qualifying medical condition.

7.6 Subd. 31. **Health record.** "Health record" has the meaning given in section 144.291,
7.7 subdivision 2.

7.8 Subd. 32. **Hemp concentrate.** (a) "Hemp concentrate" means:

7.9 (1) the extracts and resins of a hemp plant or hemp plant parts;

7.10 (2) the extracts or resins of a hemp plant or hemp plant parts that are refined to increase
7.11 the presence of targeted cannabinoids; or

7.12 (3) a product that is produced by refining extracts or resins of a hemp plant or hemp
7.13 plant parts and is intended to be consumed by combustion or vaporization of the product
7.14 and inhalation of smoke, aerosol, or vapor from the product.

7.15 (b) Hemp concentrate does not include artificially derived cannabinoids or hemp-derived
7.16 consumer products.

7.17 Subd. 33. **Hemp-derived consumer product.** (a) "Hemp-derived consumer product"
7.18 means a product intended for human or animal consumption that:

7.19 (1) consists of hemp plant parts;

7.20 (2) is hemp concentrate; or

7.21 (3) contains hemp concentrate.

7.22 (b) Hemp-derived consumer product includes hemp-derived topical products, but does
7.23 not include edible cannabinoid products, artificially derived cannabinoids, hemp fiber
7.24 products, or hemp grain.

7.25 Subd. 34. **Hemp-derived topical product.** "Hemp-derived topical product" means a
7.26 product intended for human or animal consumption that contains hemp concentrate and is
7.27 intended for application externally to a part of the body of a human or animal.

7.28 Subd. 35. **Hemp fiber product.** "Hemp fiber product" means an intermediate or finished
7.29 product made from the fiber of hemp plant parts that is not intended for human or animal
7.30 consumption. Hemp fiber product includes but is not limited to cordage, paper, fuel, textiles,
7.31 bedding, insulation, construction materials, compost materials, and industrial materials.

8.1 Subd. 36. **Hemp grain.** "Hemp grain" means the harvested seeds of the hemp plant
8.2 intended for consumption as a food or part of a food product. Hemp grain includes oils
8.3 pressed or extracted from harvested hemp seeds.

8.4 Subd. 37. **Hemp plant.** "Hemp plant" means all parts of the plant of the genus Cannabis
8.5 that is growing or has not been harvested and has a delta-9 tetrahydrocannabinol
8.6 concentration of no more than 0.3 percent on a dry weight basis.

8.7 Subd. 38. **Hemp plant parts.** "Hemp plant parts" means any part of the harvested hemp
8.8 plant, including the flower, bud, leaves, stems, and stalk, but does not include derivatives,
8.9 extracts, cannabinoids, isomers, acids, salts, and salts of isomers that are separated from
8.10 the plant. Hemp plant parts does not include hemp fiber products, hemp grain, or hemp
8.11 seed.

8.12 Subd. 39. **Hemp seed.** "Hemp seed" means the viable seed of the plant of the genus
8.13 Cannabis that is intended to be planted and is reasonably expected to grow into a hemp
8.14 plant. Hemp seed does not include cannabis seed or hemp grain.

8.15 Subd. 40. **Industrial hemp.** "Industrial hemp" has the meaning given in section 18K.02,
8.16 subdivision 3.

8.17 Subd. 41. **Intoxicating cannabinoid.** "Intoxicating cannabinoid" means a cannabinoid,
8.18 including an artificially derived cannabinoid, that when introduced into the human body
8.19 impairs the central nervous system or impairs the human audio, visual, or mental processes.
8.20 Intoxicating cannabinoid includes but is not limited to any tetrahydrocannabinol.

8.21 Subd. 42. **Labor peace agreement.** "Labor peace agreement" means an agreement
8.22 between a cannabis business and a bona fide labor organization that protects the state's
8.23 interests by, at minimum, prohibiting the labor organization from engaging in picketing,
8.24 work stoppages, or boycotts against the cannabis business. This type of agreement shall not
8.25 mandate a particular method of election or certification of the bona fide labor organization.

8.26 Subd. 43. **License holder.** "License holder" means a person, cooperative, or business
8.27 that holds any of the following licenses:

8.28 (1) cannabis cultivator;

8.29 (2) cannabis manufacturer;

8.30 (3) cannabis retailer;

8.31 (4) cannabis wholesaler;

8.32 (5) cannabis transporter;

9.1 (6) cannabis testing facility;

9.2 (7) cannabis microbusiness;

9.3 (8) cannabis event organizer;

9.4 (9) cannabis delivery service;

9.5 (10) lower potency edible retailer;

9.6 (11) medical cannabis cultivator;

9.7 (12) medical cannabis processor; or

9.8 (13) medical cannabis retailer.

9.9 Subd. 44. **Local unit of government.** "Local unit of government" means a home rule
 9.10 charter or statutory city, county, town, or other political subdivision.

9.11 Subd. 45. **Lower potency edible product.** "Lower potency edible product" means any
 9.12 product that:

9.13 (1) is intended to be eaten or consumed as a beverage by humans;

9.14 (2) contains a cannabinoid, including an artificially derived cannabinoid, in combination
 9.15 with food ingredients;

9.16 (3) is not a drug;

9.17 (4) is packaged in servings that contain no more than five milligrams of delta-9
 9.18 tetrahydrocannabinol per serving, 25 milligrams of cannabidiol per serving, or both;

9.19 (5) does not contain more than a combined total of 0.5 milligrams of all other
 9.20 cannabinoids;

9.21 (6) does not contain an artificially derived cannabinoid other than delta-9
 9.22 tetrahydrocannabinol; and

9.23 (7) is a type of product approved for sale by the office or is substantially similar to a
 9.24 product approved by the office, including but not limited to products that resemble
 9.25 nonalcoholic beverages, candy, and baked goods.

9.26 Subd. 46. **Matrix barcode.** "Matrix barcode" means a code that stores data in a
 9.27 two-dimensional array of geometrically shaped dark and light cells capable of being read
 9.28 by the camera on a smartphone or other mobile device.

9.29 Subd. 47. **Medical cannabinoid product.** (a) "Medical cannabinoid product" means a
 9.30 cannabinoid product provided to a patient enrolled in the registry program; a registered

10.1 designated caregiver; or a parent, legal guardian, or spouse of an enrolled patient, by a
 10.2 cannabis retailer or medical cannabis retailer to treat or alleviate the symptoms of a qualifying
 10.3 medical condition. A medical cannabinoid product must be in the form of:

10.4 (1) liquid, including but not limited to oil;

10.5 (2) pill;

10.6 (3) liquid or oil for use with a vaporized delivery method;

10.7 (4) water-soluble cannabinoid multiparticulate, including granules, powder, and sprinkles;

10.8 (5) orally dissolvable product, including lozenges, gum, mints, buccal tablets, and
 10.9 sublingual tablets;

10.10 (6) topical formulation; or

10.11 (7) any allowable form or delivery method approved by the office.

10.12 (b) Medical cannabinoid product does not include adult-use cannabinoid products.

10.13 Subd. 48. **Medical cannabis business.** "Medical cannabis business" means an entity
 10.14 licensed under this chapter to engage in one or more of the following:

10.15 (1) the cultivation of cannabis plants for medical cannabis flower;

10.16 (2) the manufacture of medical cannabinoid products; and

10.17 (3) the retail sale of medical cannabis flower and medical cannabinoid products.

10.18 Subd. 49. **Medical cannabis flower.** "Medical cannabis flower" means cannabis flower
 10.19 provided to a patient enrolled in the registry program; a registered designated caregiver; or
 10.20 a parent, legal guardian, or spouse of an enrolled patient by a cannabis retailer or medical
 10.21 cannabis business to treat or alleviate the symptoms of a qualifying medical condition.

10.22 Medical cannabis flower does not include adult-use cannabis flower or hemp-derived
 10.23 consumer products.

10.24 Subd. 50. **Medical cannabis paraphernalia.** "Medical cannabis paraphernalia" means
 10.25 a delivery device, related supply, or educational material used by a patient enrolled in the
 10.26 registry program to administer medical cannabis and medical cannabinoid products.

10.27 Subd. 51. **Nonintoxicating cannabinoid.** "Nonintoxicating cannabinoid" means a
 10.28 cannabinoid that when introduced into the human body does not impair the central nervous
 10.29 system and does not impair the human audio, visual, or mental processes. Nonintoxicating
 10.30 cannabinoid includes but is not limited to cannabidiol but does not include any artificially
 10.31 derived cannabinoid.

11.1 Subd. 52. **Office.** "Office" means the Office of Cannabis Management.

11.2 Subd. 53. **Outdoor advertisement.** "Outdoor advertisement" means an advertisement
11.3 that is located outdoors or can be seen or heard by an individual who is outdoors and includes
11.4 billboards; advertisements on benches; advertisements at transit stations or transit shelters;
11.5 advertisements on the exterior or interior of buses, taxis, light rail transit, or business vehicles;
11.6 and print signs that do not meet the requirements in section 342.66, subdivision 2, paragraph
11.7 (b), but that are placed or located on the exterior property of a cannabis business.

11.8 Subd. 54. **Patient.** "Patient" means a Minnesota resident who has been diagnosed with
11.9 a qualifying medical condition by a health care practitioner and who has met all other
11.10 requirements for patients under this chapter to participate in the registry program.

11.11 Subd. 55. **Patient registry number.** "Patient registry number" means a unique
11.12 identification number assigned by the Division of Medical Cannabis to a patient enrolled
11.13 in the registry program.

11.14 Subd. 56. **Qualifying medical condition.** "Qualifying medical condition" means a
11.15 diagnosis of any of the following conditions:

11.16 (1) cancer, if the underlying condition or treatment produces one or more of the following:

11.17 (i) severe or chronic pain;

11.18 (ii) nausea or severe vomiting; or

11.19 (iii) cachexia or severe wasting;

11.20 (2) glaucoma;

11.21 (3) human immunodeficiency virus or acquired immune deficiency syndrome;

11.22 (4) Tourette's syndrome;

11.23 (5) amyotrophic lateral sclerosis;

11.24 (6) seizures, including those characteristic of epilepsy;

11.25 (7) severe and persistent muscle spasms, including those characteristic of multiple
11.26 sclerosis;

11.27 (8) inflammatory bowel disease, including Crohn's disease;

11.28 (9) irritable bowel syndrome;

11.29 (10) obsessive-compulsive disorder;

12.1 (11) terminal illness, with a probable life expectancy of under one year, if the illness or
12.2 its treatment produces one or more of the following:

12.3 (i) severe or chronic pain;

12.4 (ii) nausea or severe vomiting; or

12.5 (iii) cachexia or severe wasting; or

12.6 (12) any other medical condition or its treatment approved by the commissioner.

12.7 Subd. 57. **Registered designated caregiver.** "Registered designated caregiver" means
12.8 an individual who:

12.9 (1) is at least 18 years old;

12.10 (2) is not disqualified for a criminal offense according to section 342.20, subdivision 2;

12.11 (3) has been approved by the Division of Medical Cannabis to assist a patient with

12.12 obtaining medical cannabis flower and medical cannabinoid products from a cannabis

12.13 retailer or medical cannabis retailer and with administering medical cannabis flower and

12.14 medical cannabinoid products; and

12.15 (4) is authorized by the Division of Medical Cannabis to assist a patient with the use of

12.16 medical cannabis flower and medical cannabinoid products.

12.17 Subd. 58. **Registry or registry program.** "Registry" or "registry program" means the

12.18 patient registry established under this chapter listing patients authorized to obtain medical

12.19 cannabis flower, medical cannabinoid products, and medical cannabis paraphernalia from

12.20 cannabis retailers and medical cannabis retailers and administer medical cannabis flower

12.21 and medical cannabinoid products.

12.22 Subd. 59. **Registry verification.** "Registry verification" means the verification provided

12.23 by the Division of Medical Cannabis that a patient is enrolled in the registry program and

12.24 that includes the patient's name, patient registry number, and, if applicable, the name of the

12.25 patient's registered designated caregiver or parent, legal guardian, or spouse.

12.26 Subd. 60. **Restricted area.** "Restricted area" means an area where cannabis flower or

12.27 cannabinoid products are cultivated, manufactured, or stored by a cannabis business.

12.28 Subd. 61. **Statewide monitoring system.** "Statewide monitoring system" means the

12.29 system for integrated cannabis tracking, inventory, and verification established or adopted

12.30 by the office.

13.1 Subd. 62. **Synthetic cannabinoid.** "Synthetic cannabinoid" means a substance with a
13.2 similar chemical structure and pharmacological activity to a cannabinoid but is not extracted
13.3 or derived from cannabis plants, cannabis flower, hemp plants, or hemp plant parts and is
13.4 instead created or produced by chemical or biochemical synthesis.

13.5 Subd. 63. **Veteran.** "Veteran" means an individual who satisfies the requirements in
13.6 section 197.447.

13.7 Subd. 64. **Visiting designated caregiver.** "Visiting designated caregiver" means an
13.8 individual who is authorized under a visiting patient's jurisdiction of residence to assist the
13.9 visiting patient with the use of medical cannabis flower and medical cannabinoid products.
13.10 To be considered a visiting designated caregiver, the individual must possess a valid
13.11 verification card or its equivalent that is issued by the visiting patient's jurisdiction of
13.12 residence and that verifies that the individual is authorized to assist the visiting patient with
13.13 the administration of medical cannabis flower and medical cannabinoid products under the
13.14 laws or regulations of the visiting patient's jurisdiction of residence.

13.15 Subd. 65. **Visiting patient.** "Visiting patient" means an individual who is not a Minnesota
13.16 resident and who possesses a valid registration verification card or its equivalent that is
13.17 issued under the laws or regulations of another state, district, commonwealth, or territory
13.18 of the United States verifying that the individual is enrolled in or authorized to participate
13.19 in that jurisdiction's medical cannabis or medical marijuana program.

13.20 Subd. 66. **Volatile solvent.** "Volatile solvent" means any solvent that is or produces a
13.21 flammable gas or vapor that, when present in the air in sufficient quantities, will create
13.22 explosive or ignitable mixtures. Volatile solvent includes but is not limited to butane, hexane,
13.23 and propane.

13.24 **Sec. 2. [342.02] OFFICE OF CANNABIS MANAGEMENT.**

13.25 Subdivision 1. **Establishment.** The Office of Cannabis Management is created with the
13.26 powers and duties established by law. In making rules, establishing policy, and exercising
13.27 its regulatory authority over the cannabis industry, the office must:

13.28 (1) promote the public health and welfare;

13.29 (2) protect public safety;

13.30 (3) eliminate the illicit market for cannabis flower and cannabinoid products;

13.31 (4) meet the market demand for cannabis flower and cannabinoid products;

13.32 (5) promote a craft industry for cannabis flower and cannabinoid products; and

- 14.1 (6) prioritize growth and recovery in communities that have experienced a
14.2 disproportionate, negative impact from cannabis prohibition.
- 14.3 Subd. 2. Powers and duties. The office has the following powers and duties:
- 14.4 (1) to develop, maintain, and enforce an organized system of regulation for the cannabis
14.5 industry;
- 14.6 (2) to establish programming, services, and notification to protect, maintain, and improve
14.7 the health of citizens;
- 14.8 (3) to prevent unauthorized access to cannabis flower, cannabinoid products, and
14.9 hemp-derived consumer products by individuals under 21 years of age;
- 14.10 (4) to establish and regularly update standards for product testing, packaging, and
14.11 labeling;
- 14.12 (5) to promote economic growth with an emphasis on growth in areas that experienced
14.13 a disproportionate, negative impact from cannabis prohibition;
- 14.14 (6) to issue and renew licenses;
- 14.15 (7) to require fingerprints from individuals determined to be subject to fingerprinting,
14.16 including the submission of fingerprints to the Federal Bureau of Investigation where
14.17 required by law and to obtain criminal conviction data for individuals seeking a license
14.18 from the office on the individual's behalf or as a cooperative member or director, manager,
14.19 or general partner of a business entity;
- 14.20 (8) to receive reports required by this chapter and inspect the premises, records, books,
14.21 and other documents of license holders to ensure compliance with all applicable laws and
14.22 rules;
- 14.23 (9) to authorize the use of unmarked motor vehicles to conduct seizures or investigations
14.24 pursuant to the office's authority;
- 14.25 (10) to impose and collect civil and administrative penalties as provided in this chapter;
- 14.26 (11) to publish such information as may be deemed necessary for the welfare of cannabis
14.27 businesses, cannabis workers, and the health and safety of citizens;
- 14.28 (12) to make loans and grants in aid to the extent that appropriations are made available
14.29 for that purpose;
- 14.30 (13) to authorize research and studies on cannabis flower, cannabinoid products, and
14.31 the cannabis industry;

15.1 (14) to provide reports as required by law;

15.2 (15) to establish limits on the potency of cannabis flower and cannabinoid products that
15.3 can be sold to customers by licensed cannabis retailers and licensed cannabis microbusinesses
15.4 with an endorsement to sell cannabis flower and cannabinoid products to customers; and

15.5 (16) to exercise other powers and authority and perform other duties required by law.

15.6 Subd. 3. **Medical cannabis program.** The powers and duties of the Department of
15.7 Health with respect to the medical cannabis program under Minnesota Statutes 2022, sections
15.8 152.22 to 152.37, are transferred to the Office of Cannabis Management under section
15.9 15.039.

15.10 Subd. 4. **Interagency agreements.** (a) The office and the commissioner of agriculture
15.11 shall enter into interagency agreements to ensure that edible cannabinoid products are
15.12 handled, manufactured, and inspected in a manner that is consistent with the relevant food
15.13 safety requirements in chapters 28A, 31, and 34A and associated rules.

15.14 (b) The office may cooperate and enter into other agreements with the commissioner of
15.15 agriculture and may cooperate and enter into agreements with the commissioners and
15.16 directors of other state agencies and departments to promote the beneficial interests of the
15.17 state.

15.18 Subd. 5. **Rulemaking.** The office may adopt rules to implement any provisions in this
15.19 chapter. Rules for which notice is published in the State Register before July 1, 2025, may
15.20 be adopted using the expedited rulemaking process in section 14.389.

15.21 Subd. 6. **Director.** (a) The governor shall appoint a director of the office with the advice
15.22 and consent of the senate. The director must be in the unclassified service and must serve
15.23 at the pleasure of the governor.

15.24 (b) The salary of the director must not exceed the salary limit established under section
15.25 15A.0815, subdivision 3.

15.26 (c) While serving as the director and within two years after terminating service, the
15.27 director is prohibited from having a direct or an indirect financial interest in a cannabis
15.28 business licensed under this chapter.

15.29 Subd. 7. **Employees.** (a) The office may employ other personnel in the classified service
15.30 necessary to carry out the duties in this chapter.

15.31 (b) A prospective employee of the office must submit a completed criminal history
15.32 records check consent form, a full set of classifiable fingerprints, and the required fees to

16.1 the office. Upon receipt of this information, the office must submit the completed criminal
 16.2 history records check consent form, full set of classifiable fingerprints, and required fees
 16.3 to the Bureau of Criminal Apprehension. After receiving this information, the bureau must
 16.4 conduct a Minnesota criminal history records check of the license applicant. The bureau
 16.5 may exchange a license applicant's fingerprints with the Federal Bureau of Investigation to
 16.6 obtain the applicant's national criminal history record information. The bureau must return
 16.7 the results of the Minnesota and federal criminal history records checks to the director to
 16.8 determine if the applicant is disqualified under section 342.20.

16.9 (c) While employed by the office and within two years after terminating employment,
 16.10 an employee may not have a direct or an indirect financial interest in a cannabis business
 16.11 licensed under this chapter.

16.12 Subd. 8. **Division of Social Equity.** The office must establish a Division of Social Equity.
 16.13 At a minimum, the division must:

16.14 (1) administer grants to communities that experienced a disproportionate, negative impact
 16.15 from cannabis prohibition in order to promote economic development, provide services to
 16.16 prevent violence, support early intervention programs for youth and families, and promote
 16.17 community stability and safety;

16.18 (2) act as an ombudsperson for the office to provide information, investigate complaints
 16.19 under this chapter, and provide or facilitate dispute resolutions; and

16.20 (3) report to the office on the status of complaints and social equity in the cannabis
 16.21 industry.

16.22 **EFFECTIVE DATE.** This section is effective July 1, 2023, except for subdivision 3,
 16.23 which is effective January 1, 2024.

16.24 Sec. 3. **[342.03] CANNABIS ADVISORY COUNCIL.**

16.25 Subdivision 1. **Membership.** (a) The Cannabis Advisory Council is created consisting
 16.26 of the following members:

16.27 (1) the director of the Office of Cannabis Management or a designee;

16.28 (2) the commissioner of employment and economic development or a designee;

16.29 (3) the commissioner of revenue or a designee;

16.30 (4) the commissioner of health or a designee;

16.31 (5) the commissioner of public safety or a designee;

- 17.1 (6) the commissioner of human rights or a designee;
- 17.2 (7) the commissioner of labor or a designee;
- 17.3 (8) the commissioner of agriculture or a designee;
- 17.4 (9) the commissioner of the Pollution Control Agency or a designee;
- 17.5 (10) the superintendent of the Bureau of Criminal Apprehension or a designee;
- 17.6 (11) a representative from the League of Minnesota Cities appointed by the league;
- 17.7 (12) a representative from the Association of Minnesota Counties appointed by the
17.8 association;
- 17.9 (13) an expert in minority business development appointed by the governor;
- 17.10 (14) an expert in economic development strategies for under-resourced communities
17.11 appointed by the governor;
- 17.12 (15) an expert in farming or representing the interests of farmers appointed by the
17.13 governor;
- 17.14 (16) an expert representing the interests of cannabis workers appointed by the governor;
- 17.15 (17) an expert representing the interests of employers appointed by the governor;
- 17.16 (18) an expert in municipal law enforcement with advanced training in impairment
17.17 detection and evaluation appointed by the governor;
- 17.18 (19) an expert in social welfare or social justice appointed by the governor;
- 17.19 (20) an expert in criminal justice reform to mitigate the disproportionate impact of drug
17.20 prosecutions on communities of color appointed by the governor;
- 17.21 (21) an expert in the prevention and treatment of substance use disorders appointed by
17.22 the governor;
- 17.23 (22) an expert in minority business ownership appointed by the governor;
- 17.24 (23) an expert in women-owned businesses appointed by the governor;
- 17.25 (24) an expert in cannabis retailing appointed by the governor;
- 17.26 (25) an expert in cannabis product manufacturing appointed by the governor;
- 17.27 (26) an expert in laboratory sciences and toxicology appointed by the governor;
- 17.28 (27) an expert in providing legal services to cannabis businesses appointed by the
17.29 governor;

18.1 (28) an expert in cannabis cultivation appointed by the governor;

18.2 (29) two patient advocates, one who is a patient enrolled in the medical cannabis program
18.3 and one with experience in the mental health system or substance use disorder treatment
18.4 system appointed by the governor; and

18.5 (30) a veteran appointed by the governor.

18.6 (b) While serving on the Cannabis Advisory Council and within two years after
18.7 terminating service, a council member shall not serve as a lobbyist, as defined under section
18.8 10A.01, subdivision 21.

18.9 Subd. 2. **Terms; compensation; removal; vacancy; expiration.** The membership terms,
18.10 compensation, removal of members appointed by the governor, and filling of vacancies of
18.11 members are provided in section 15.059.

18.12 Subd. 3. **Officers; meetings.** (a) The director of the Office of Cannabis Management
18.13 or the director's designee must chair the Cannabis Advisory Council. The advisory council
18.14 must elect a vice-chair and may elect other officers as necessary.

18.15 (b) The advisory council shall meet quarterly or upon the call of the chair.

18.16 (c) Meetings of the advisory council are subject to chapter 13D.

18.17 Subd. 4. **Duties.** (a) The duties of the advisory council shall include:

18.18 (1) reviewing national cannabis policy;

18.19 (2) examining the effectiveness of state cannabis policy;

18.20 (3) reviewing developments in the cannabis industry;

18.21 (4) reviewing developments in the study of cannabis flower and cannabinoid products;

18.22 (5) taking public testimony; and

18.23 (6) making recommendations to the Office of Cannabis Management.

18.24 (b) At its discretion, the advisory council may examine other related issues consistent
18.25 with this section.

18.26 Sec. 4. **[342.04] STUDIES; REPORTS.**

18.27 (a) The office shall conduct a study to determine the expected size and growth of the
18.28 regulated cannabis industry, including an estimate of the demand for cannabis flower and
18.29 cannabinoid products, the number and geographic distribution of cannabis businesses needed
18.30 to meet that demand, and the anticipated business from residents of other states.

19.1 (b) The office shall conduct a study to determine the size of the illicit cannabis market,
19.2 the sources of illicit cannabis flower and illicit cannabinoid products in the state, the locations
19.3 of citations issued and arrests made for cannabis offenses, and the subareas, such as census
19.4 tracts or neighborhoods, that experience a disproportionately large amount of cannabis
19.5 enforcement.

19.6 (c) The office shall conduct a study on impaired driving to determine the number of
19.7 accidents involving one or more drivers who admitted to using cannabis flower or
19.8 cannabinoid products or who tested positive for cannabis or tetrahydrocannabinol, the
19.9 number of arrests of individuals for impaired driving in which the individual tested positive
19.10 for cannabis or tetrahydrocannabinol, and the number of convictions for driving under the
19.11 influence of cannabis flower, cannabinoid products, or tetrahydrocannabinol.

19.12 (d) The office shall provide preliminary reports on the studies conducted pursuant to
19.13 paragraphs (a) to (c) to the legislature by January 15, 2024, and shall provide final reports
19.14 to the legislature by January 15, 2025. The reports may be consolidated into a single report
19.15 by the office.

19.16 (e) The office shall conduct a study on the state's mental health system and substance
19.17 use disorder treatment system to determine the rates at which individuals access those
19.18 systems. At a minimum, the report shall include information about the number of people
19.19 admitted to emergency rooms for treatment of a mental illness or substance use disorder,
19.20 ordered by a court to participate in mental health or substance use programming, and who
19.21 voluntarily agreed to accept mental health or substance use treatment or admission to a
19.22 state-operated treatment program or treatment facility. The report must include summary
19.23 data disaggregated by the month of admission or order; age, race, and sex of the individuals;
19.24 whether the admission or order was for a mental illness or substance use disorder; and, to
19.25 the extent known, the substance of abuse that resulted in the admission or order. Data must
19.26 be obtained, retained, and reported in a way that prevents the unauthorized release of private
19.27 data on individuals as defined in section 13.02. The office shall submit the report by January
19.28 15, 2027, and the report may be combined with the annual report submitted by the office.

19.29 (f) The office shall submit an annual report to the legislature by January 15, 2024, and
19.30 each January 15 thereafter. The annual report shall include but not be limited to the following:

19.31 (1) the status of the regulated cannabis industry;

19.32 (2) the status of the illicit cannabis market;

20.1 (3) the number of accidents, arrests, and convictions involving drivers who admitted to
20.2 using cannabis flower or cannabinoid products or who tested positive for cannabis or
20.3 tetrahydrocannabinol;

20.4 (4) the change in potency, if any, of cannabis flower and cannabinoid products available
20.5 through the regulated market;

20.6 (5) progress on providing opportunities to individuals and communities that experienced
20.7 a disproportionate, negative impact from cannabis prohibition, including but not limited to
20.8 providing relief from criminal convictions and increasing economic opportunities;

20.9 (6) the status of racial and geographic diversity in the cannabis industry;

20.10 (7) proposed legislative changes; and

20.11 (8) recommendations for levels of funding for:

20.12 (i) a coordinated education program to address and raise public awareness about the top
20.13 three adverse health effects, as determined by the commissioner of health, associated with
20.14 the use of cannabis flower or cannabinoid products by individuals under 21 years of age;

20.15 (ii) a coordinated education program to educate pregnant women, breastfeeding women,
20.16 and women who may become pregnant on the adverse health effects of cannabis flower and
20.17 cannabinoid products;

20.18 (iii) training, technical assistance, and educational materials for home visiting programs
20.19 and Tribal home visiting programs regarding safe and unsafe use of cannabis flower and
20.20 cannabinoid products in homes with infants and young children;

20.21 (iv) model programs to educate middle school and high school students on the health
20.22 effects on children and adolescents of the use of cannabis flower, cannabinoid products,
20.23 and other intoxicating or controlled substances;

20.24 (v) grants issued through the CanTrain, CanNavigate, CanStartup, and CanGrow
20.25 programs;

20.26 (vi) grants to organizations for community development in social equity communities
20.27 through the CanRenew program;

20.28 (vii) training of peace officers and law enforcement agencies on changes to laws involving
20.29 cannabis flower, cannabinoid products, and hemp-derived consumer products, and the law's
20.30 impact on searches and seizures;

20.31 (viii) training of peace officers to increase the number of drug recognition experts;

21.1 (ix) training of peace officers on the cultural uses of sage and distinguishing use of sage
 21.2 from the use of cannabis flower, including whether the Board of Peace Officer Standards
 21.3 and Training should approve or develop training materials;

21.4 (x) the retirement and replacement of drug detection dogs; and

21.5 (xi) the Department of Human Services and county social service agencies to address
 21.6 any increase in demand for services.

21.7 (g) In developing the recommended funding levels under paragraph (f), clause 8, items
 21.8 (vii) to (xi), the office shall consult with local law enforcement agencies, the Minnesota
 21.9 Chiefs of Police Association, the Minnesota Sheriff's Association, the League of Minnesota
 21.10 Cities, the Association of Minnesota Counties, and county social services agencies.

21.11 **Sec. 5. [342.05] STATEWIDE MONITORING SYSTEM.**

21.12 Subdivision 1. **Statewide monitoring.** The office must contract with an outside vendor
 21.13 to establish a statewide monitoring system for integrated cannabis tracking, inventory, and
 21.14 verification to track all cannabis plants, cannabis flower, cannabinoid products, and artificially
 21.15 derived cannabinoids from seed, immature plant, or creation until disposal or sale to a patient
 21.16 or customer.

21.17 Subd. 2. **Data submission requirements.** The monitoring system must allow cannabis
 21.18 businesses to submit monitoring data to the office through the use of monitoring system
 21.19 software commonly used within the cannabis industry and may also permit cannabis
 21.20 businesses to submit monitoring data through manual data entry with approval from the
 21.21 office.

21.22 **Sec. 6. [342.06] APPROVAL OF CANNABIS FLOWER, PRODUCTS, AND**
 21.23 **CANNABINOIDS.**

21.24 (a) The office shall approve types of cannabis flower, cannabinoid products, and
 21.25 hemp-derived consumer products other than hemp-derived topical products for retail sale.

21.26 (b) The office shall not approve any cannabinoid product or hemp-derived consumer
 21.27 product that:

21.28 (1) is or appears to be a lollipop or ice cream;

21.29 (2) bears the likeness or contains characteristics of a real or fictional person, animal, or
 21.30 fruit;

22.1 (3) is modeled after a type or brand of products primarily consumed by or marketed to
 22.2 children;

22.3 (4) contains a synthetic cannabinoid;

22.4 (5) is made by applying a cannabinoid, including but not limited to an artificially derived
 22.5 cannabinoid, to a finished food product that does not contain cannabinoids and is sold to
 22.6 consumers, including but not limited to a candy or snack food; or

22.7 (6) if the product is an edible cannabinoid product, contains an ingredient, other than a
 22.8 cannabinoid, that is not approved by the United States Food and Drug Administration for
 22.9 use in food.

22.10 (c) The office must not approve any cannabis flower, cannabinoid product, or
 22.11 hemp-derived consumer product that:

22.12 (1) is intended to be consumed by combustion or vaporization of the product and
 22.13 inhalation of smoke, aerosol, or vapor from the product; and

22.14 (2) imparts a taste or smell, other than the taste or smell of cannabis flower, that:

22.15 (i) is distinguishable by an ordinary person before or during consumption of the product;
 22.16 and

22.17 (ii) is designed or likely to appeal to individuals under 21 years of age.

22.18 (d) The office may adopt rules to limit or prohibit ingredients in or additives to cannabis
 22.19 flower, cannabinoid products, or hemp-derived consumer products to ensure compliance
 22.20 with the limitations in paragraph (c).

22.21 **Sec. 7. [342.07] AGRICULTURAL AND FOOD SAFETY PRACTICES;**
 22.22 **RULEMAKING.**

22.23 Subdivision 1. **Plant propagation standards.** In consultation with the commissioner
 22.24 of agriculture, the office by rule must establish certification, testing, and labeling
 22.25 requirements for the methods used to grow new cannabis plants or hemp plants, including
 22.26 but not limited to growth from seed, clone, cutting, or tissue culture. The requirements must
 22.27 prohibit the cultivation of cannabis plants derived from genetic engineering, as defined in
 22.28 section 18F.02, subdivision 4.

22.29 Subd. 2. **Agricultural best practices.** In consultation with the commissioner of
 22.30 agriculture and representatives from the University of Minnesota Extension Service, the
 22.31 office shall establish best practices for:

23.1 (1) the cultivation and preparation of cannabis plants; and

23.4 Subd. 3. **Edible cannabinoid product handler endorsement.** (a) Any person seeking
23.5 to manufacture, process, sell, handle, or store an edible cannabinoid product, other than an
23.6 edible cannabinoid product that has been placed in its final packaging, must first obtain an
23.7 edible cannabinoid product handler endorsement.

23.8 (b) In consultation with the commissioner of agriculture, the office shall establish an
23.9 edible cannabinoid product handler endorsement.

23.10 (c) The office must regulate edible cannabinoid product handlers and assess penalties
23.11 in the same manner provided for food handlers under chapters 28A, 31, and 34A and
23.12 associated rules, with the following exceptions:

23.13 (1) the office must issue an edible cannabinoid product handler endorsement, rather than

23.26 for the limited production of edible products produced solely for product development,
23.27 sampling, or testing.

23.28 Sec. 8. **[342.08] ESTABLISHMENT OF ENVIRONMENTAL STANDARDS.**

23.29 Subdivision 1. **Water standards.** In consultation with the commissioner of the Pollution
23.30 Control Agency, the office by rule must establish appropriate water standards for cannabis
23.31 businesses.

24.1 Subd. 2. **Energy use.** In consultation with the commissioner of commerce, the office
24.2 by rule must establish appropriate energy standards for cannabis businesses.

24.3 Subd. 3. **Solid waste.** In consultation with the commissioner of the Pollution Control
24.4 Agency, the office by rule must establish appropriate solid waste standards for the disposal
24.5 of:

24.6 (1) cannabis flower and cannabinoid products;

24.7 (2) packaging;

24.8 (3) recyclable materials, including minimum requirements for the use of recyclable
24.9 materials; and

24.10 (4) other solid waste.

24.11 Subd. 4. **Odor.** The office by rule must establish appropriate standards and requirements
24.12 to limit odors produced by cannabis businesses.

24.13 Subd. 5. **Applicability; federal, state, and local laws.** A cannabis business must comply
24.14 with all applicable federal, state, and local laws related to the subjects of subdivisions 1 to
24.15 4.

24.16 Subd. 6. **Rulemaking.** (a) The office may only adopt a rule under this section if the rule
24.17 is consistent with and at least as stringent as applicable state and federal laws related to the
24.18 subjects of subdivisions 1 to 4.

24.19 (b) The office must coordinate and consult with a department or agency of the state
24.20 regarding the development and implementation of a rule under this section if the department
24.21 or agency has expertise or a regulatory interest in the subject matter of the rule.

24.22 Sec. 9. **[342.09] PERSONAL ADULT USE OF CANNABIS.**

24.23 Subdivision 1. **Personal adult use, possession, and transportation of cannabis flower**
24.24 **and cannabinoid products.** (a) An individual 21 years of age or older may:

24.25 (1) use, possess, or transport cannabis paraphernalia;

24.26 (2) possess or transport two ounces or less of adult-use cannabis flower in a public place;

24.27 (3) possess five pounds or less of adult-use cannabis flower in the individual's private
24.28 residence;

24.29 (4) possess or transport eight grams or less of adult-use cannabis concentrate;

- 25.1 (5) possess or transport edible cannabinoid products infused with a combined total of
25.2 800 milligrams or less of tetrahydrocannabinol;
- 25.3 (6) give for no remuneration two ounces or less of adult-use cannabis flower, eight grams
25.4 or less of adult-use cannabis concentrate, or an edible cannabinoid product infused with
25.5 800 milligrams or less of tetrahydrocannabinol to an individual who is at least 21 years of
25.6 age; and
- 25.7 (7) use adult-use cannabis flower and adult-use cannabinoid products in the following
25.8 locations:
- 25.9 (i) a private residence, including the individual's curtilage or yard;
- 25.10 (ii) on private property, not generally accessible by the public, unless the individual is
25.11 explicitly prohibited from consuming cannabis flower or cannabinoid products on the
25.12 property by the owner of the property; or
- 25.13 (iii) on the premises of an establishment or event licensed to permit on-site consumption.
- 25.14 (b) Except as provided in paragraph (c), an individual may not:
- 25.15 (1) use, possess, or transport cannabis flower or cannabinoid products if the individual
25.16 is under 21 years of age;
- 25.17 (2) use cannabis flower or cannabinoid products in a motor vehicle as defined in section
25.18 169A.03, subdivision 15;
- 25.19 (3) use cannabis flower or cannabinoid products at any location where smoking is
25.20 prohibited under section 144.414;
- 25.21 (4) use or possess cannabis flower or cannabinoid products in a public school, as defined
25.22 in section 120A.05, subdivisions 9, 11, and 13, or in a charter school governed by chapter
25.23 124E, including all facilities, whether owned, rented, or leased, and all vehicles that a school
25.24 district owns, leases, rents, contracts for, or controls;
- 25.25 (5) use or possess cannabis flower or cannabinoid products in a state correctional facility;
- 25.26 (6) operate a motor vehicle while under the influence of cannabis flower or cannabinoid
25.27 products;
- 25.28 (7) give for no remuneration cannabis flower or cannabinoid products to an individual
25.29 under 21 years of age; or
- 25.30 (8) give for no remuneration cannabis flower or cannabinoid products as a sample or
25.31 promotional gift if the giver is in the business of selling goods or services.

26.1 (c) The prohibitions under paragraph (b), clauses (1) to (4), do not apply to use other
26.2 than by smoking or by a vaporized delivery method, possession, or transportation of medical
26.3 cannabis flower or medical cannabinoid products by a patient; a registered designated
26.4 caregiver; or a parent, legal guardian, or spouse of a patient.

26.5 (d) A proprietor of a family or group family day care program must disclose to parents
26.6 or guardians of children cared for on the premises of the family or group family day care
26.7 program, if the proprietor permits the smoking or use of cannabis flower or cannabinoid

27.6 (2) if the person sells more than eight ounces but not more than one pound of cannabis

27.15 (c) The office may assess the following civil penalties on a person who sells cannabis
27.16 concentrate without a license issued under this chapter that authorizes the sale:

27.18 concentrate, up to \$1,000;

27.19 (2) if the person sells more than 40 grams but not more than 80 grams of cannabis

28.1 (1) if the person imports or sells products infused with a total of more than 800 milligrams
 28.2 but not more than four grams of tetrahydrocannabinol, up to \$1,000;

28.3 (2) if the person imports or sells products infused with a total of more than four grams
 28.4 but not more than eight grams of tetrahydrocannabinol, up to \$5,000;

28.5 (3) if the person imports or sells products infused with a total of more than eight grams
 28.6 but not more than 40 grams of tetrahydrocannabinol, up to \$25,000;

28.7 (4) if the person imports or sells products infused with a total of more than 40 grams
 28.8 but not more than 200 grams of tetrahydrocannabinol, up to \$100,000;

28.9 (5) if the person imports or sells products infused with a total of more than 200 grams
 28.10 but not more than 400 grams of tetrahydrocannabinol, up to \$250,000; and

28.11 (6) if the person imports or sells products infused with a total of more than 400 grams
 28.12 of tetrahydrocannabinol, up to \$1,000,000.

28.13 (e) The office may assess a civil penalty of up to \$500 for each plant grown in excess
 28.14 of the limit on a person who grows more than eight cannabis plants or more than four mature,
 28.15 flowering plants, without a license to cultivate cannabis issued under this chapter.

28.16 Sec. 10. [342.10] LICENSES; TYPES.

28.17 The office shall issue the following types of license:

28.18 (1) cannabis cultivator, including:

28.19 (i) craft cultivator; and

28.20 (ii) bulk cultivator;

28.21 (2) cannabis manufacturer;

28.22 (3) cannabis retailer;

28.23 (4) cannabis wholesaler;

28.24 (5) cannabis transporter;

28.25 (6) cannabis testing facility;

28.26 (7) cannabis microbusiness;

28.27 (8) cannabis event organizer;

28.28 (9) cannabis delivery service;

28.29 (10) lower potency edible retailer;

29.1 (11) medical cannabis cultivator;

29.2 (12) medical cannabis processor; and

29.3 (13) medical cannabis retailer.

29.4 **Sec. 11. [342.11] LICENSES; FEES.**

29.5 Except for the application fees authorized under sections 342.12, paragraph (d), and
29.6 342.15, subdivision 4, the office shall not charge a fee for annual licenses issued under this
29.7 chapter.

29.8 **Sec. 12. [342.12] LICENSES; TRANSFERS; ADJUSTMENTS.**

29.9 (a) Licenses issued under this chapter may not be transferred. A new license must be
29.10 obtained when:

29.11 (1) the form of the licensee's legal business structure converts or changes to a different
29.12 type of legal business structure;

29.13 (2) the licensee dissolves, consolidates, or merges with another legal organization;

29.14 (3) within the previous 24 months, 50 percent or more of the licensee is transferred by
29.15 a single transaction or multiple transactions to:

29.16 (i) another person or legal organization; or

29.17 (ii) a person or legal organization who had less than a five percent ownership interest

30.2 (a) A local unit of government may not prohibit the possession, transportation, or use
30.3 of cannabis flower or cannabinoid products authorized under this chapter.

30.4 (b) A local unit of government may not prohibit the establishment or operation of a
30.5 cannabis business licensed under this chapter.

30.6 (c) A local unit of government may adopt reasonable restrictions on the time, place, and

31.11 Subdivision 1. **Application; contents.** (a) The office by rule shall establish forms and
 31.12 procedures for the processing of licenses issued under this chapter. At a minimum, any
 31.13 application to obtain or renew a license shall include the following information, if applicable:

31.15 (2) the disclosure of ownership and control required under paragraph (b);

31.23 (8) proof of trade name registration;

 31.25 anticipated growth; the methods of record keeping; the knowledge and experience of the
 31.26 applicant and any officer, director, manager, and general partner of the business; the
 31.27 environmental plan; and other relevant financial and operational components;

31.28 (10) an attestation signed by a bona fide labor organization stating that the applicant has
 31.29 entered into a labor peace agreement;

31.30 (11) certification that the applicant will comply with the requirements of this chapter
 31.31 relating to the ownership and operation of a cannabis business;

32.1 (12) identification of one or more controlling persons or managerial employees as agents
32.2 who shall be responsible for dealing with the office on all matters; and

32.3 (13) a statement that the applicant agrees to respond to the office's supplemental requests
32.4 for information.

32.5 (b) An applicant must file and update as necessary a disclosure of ownership and control.
32.6 The office by rule shall establish the contents and form of the disclosure. At a minimum,
32.7 the disclosure shall include the following:

32.8 (1) the management structure, ownership, and control of the applicant or license holder,
32.9 including the name of each cooperative member, officer, director, manager, general partner
32.10 or business entity; the office or position held by each person; each person's percentage
32.11 ownership interest, if any; and, if the business has a parent company, the name of each
32.12 owner, board member, and officer of the parent company and the owner's, board member's,
32.13 or officer's percentage ownership interest in the parent company and the cannabis business;

32.14 (2) a statement from the applicant and, if the applicant is a business, from every officer,
32.15 director, manager, and general partner of the business, indicating whether that person has
32.16 previously held, or currently holds, an ownership interest in a cannabis business in Minnesota,
32.17 any other state or territory of the United States, or any other country;

32.18 (3) if the applicant is a corporation, copies of its articles of incorporation and bylaws
32.19 and any amendments to its articles of incorporation or bylaws;

32.20 (4) copies of any partnership agreement, operating agreement, or shareholder agreement;

32.21 (5) copies of any promissory notes, security instruments, or other similar agreements;

32.22 (6) explanation detailing the funding sources used to finance the business;

32.23 (7) a list of operating and investment accounts for the business, including any applicable
32.24 financial institution and account number; and

32.25 (8) a list of each outstanding loan and financial obligation obtained for use in the business,
32.26 including the loan amount, loan terms, and name and address of the creditor.

32.27 (c) An application may include:

32.28 (1) proof that the applicant is a social equity applicant;

32.29 (2) a diversity plan that establishes a goal of diversity in ownership, management,
32.30 employment, and contracting;

33.1 (3) a description of the training and education that will be provided to any employee;
33.2 or

33.3 (4) a copy of business policies governing operations to ensure compliance with this
33.4 chapter.

33.5 (d) Commitments made by an applicant in its application, including but not limited to
33.6 the maintenance of a labor peace agreement, shall be an ongoing material condition of
33.7 maintaining and renewing the license.

33.8 (e) An application on behalf of a corporation or association shall be signed by at least
33.9 two officers or managing agents of that entity.

33.10 Subd. 2. **Application; process.** (a) An applicant must submit all required information
33.11 to the office on the forms and in the manner prescribed by the office.

33.12 (b) If the office receives an application that fails to provide the required information,
33.13 the office shall issue a deficiency notice to the applicant. The applicant shall have ten
33.14 business days from the date of the deficiency notice to submit the required information.

33.15 (c) Failure by an applicant to submit all required information will result in the application
33.16 being rejected.

33.17 (d) Upon receipt of a completed application and fee, the office shall forward a copy of
33.18 the application to the local unit of government in which the business operates or intends to
33.19 operate with a form for certification as to whether a proposed cannabis business complies
33.20 with local zoning ordinances and, if applicable, whether the proposed business complies
33.21 with the state fire code and building code.

33.22 (e) Within 90 days of receiving a completed application, the office shall issue the
33.23 appropriate license or send the applicant a notice of rejection setting forth specific reasons
33.24 that the office did not approve the application.

33.25 Subd. 3. **Criminal history check.** A license applicant or, in the case of a business entity,
33.26 every cooperative member or director, manager, and general partner of the business entity,
33.27 must submit a completed criminal history records check consent form, a full set of classifiable
33.28 fingerprints, and the required fees to the office. Upon receipt of this information, the office
33.29 must submit the completed criminal history records check consent form, full set of classifiable
33.30 fingerprints, and required fees to the Bureau of Criminal Apprehension. After receiving this
33.31 information, the bureau must conduct a Minnesota criminal history records check of the
33.32 license applicant. The bureau may exchange a license applicant's fingerprints with the
33.33 Federal Bureau of Investigation to obtain the applicant's national criminal history record

34.1 information. The bureau must return the results of the Minnesota and federal criminal history
34.2 records checks to the director to determine if the applicant is disqualified under section

34.4 Subd. 4. **Application; fees.** The office may charge a nonrefundable fee, not to exceed
34.5 \$250, to cover the costs associated with reviewing and processing applications.

34.6 **Sec. 15. [342.16] SOCIAL EQUITY APPLICANTS.**

34.7 An individual qualifies as a social equity applicant if the individual is:

34.8 (1) a military veteran who lost honorable status due to a cannabis-related offense;

34.9 (2) a resident for the last five years of one or more subareas, such as census tracts or
34.10 neighborhoods, that experienced a disproportionately large amount of cannabis enforcement
34.11 as determined by the study conducted by the office pursuant to section 342.04, paragraph
34.12 (b), and reported in the preliminary report, final report, or both; or

34.13 (3) a resident for the last five years of one or more census tracts where, as reported in
34.14 the most recently completed decennial census published by the United States Bureau of the
34.15 Census, either:

34.17 (ii) the median family income did not exceed 80 percent of statewide median family
34.18 income or, if in a metropolitan area, did not exceed the greater of 80 percent of the statewide

34.21 **Sec. 16. [342.17] LICENSE SELECTION CRITERIA.**

34.22 Subdivision 1. **Market stability.** The office shall issue the necessary number of licenses
34.23 in order to ensure the sufficient supply of cannabis flower and cannabinoid products to meet
34.24 demand, provide market stability, and limit the sale of unregulated cannabis flower and
34.25 cannabinoid products.

34.26 Subd. 2. **Craft cultivation priority.** (a) The office shall prioritize issuance of
34.27 microbusiness licenses with an endorsement to cultivate cannabis flower and craft cultivator
34.28 licenses.

34.29 (b) Unless the office determines that the issuance of bulk cultivator licenses is necessary
34.30 to ensure a sufficient supply of cannabis flower and cannabinoid products, the office shall
34.31 not issue a bulk cultivator license before July 1, 2028.

35.1 Subd. 3. **Vertical integration prohibited; exceptions.** (a) Except as otherwise provided

35.9 more applicants to be fully vertically integrated. Regardless of when the licenses were
35.10 issued, licenses issued under the terms of this paragraph expire one year after the first day
35.11 on which cannabis flower and cannabinoid products are lawfully sold to customers and the
35.12 office may not issue multiple licenses resulting in a single applicant being vertically
35.13 integrated after that date.

35.14 Subd. 4. **Application score; license priority.** (a) The office shall award points to each
35.15 completed application in the following categories:

35.16 (1) status as a social equity applicant or as an applicant who is substantially similar to
35.17 a social equity applicant as described in paragraph (c);

35.18 (2) status as a veteran applicant;

35.19 (3) security and record keeping;

35.20 (4) employee training plan;

35.21 (5) business plan and financial situation;

35.22 (6) diversity plan;

35.23 (7) labor and employment practices;

35.24 (8) knowledge and experience; and

35.25 (9) environmental plan.

35.26 (b) The office may award additional points to an application if the license holder would
35.27 expand service to an underrepresented market including but not limited to participation in
35.28 the medical cannabis program.

35.29 (c) The office shall establish application materials permitting individual applicants to
35.30 demonstrate the impact that cannabis prohibition has had on that applicant including but
35.31 not limited to the arrest or imprisonment of the applicant or a member of the applicant's

36.1 immediate family, and the office may award points to such applicants in the same manner
36.2 as points are awarded to social equity applicants.

36.3 (d) The office shall establish policies and guidelines, which shall be made available to
36.4 the public, regarding the number of points available in each category and the basis for
36.5 awarding those points. Status as a social equity applicant must account for at least 20 percent
36.6 of the total available points. In determining the number of points to award to a cooperative
36.7 or business applying as a social equity applicant, the office shall consider the number or
36.8 ownership percentage of cooperative members, officers, directors, managers, and general
36.9 partners who qualify as social equity applicants.

36.10 (e) Consistent with the goals identified in subdivision 1, the office shall issue licenses
36.11 in each license category, giving priority to applicants who receive the highest score under
36.12 paragraphs (a) and (b). If there are insufficient licenses available for entities that receive
36.13 identical scores, the office shall utilize a lottery to randomly select license recipients from
36.14 among those entities.

36.15 **Sec. 17. [342.18] INSPECTION; LICENSE VIOLATIONS; PENALTIES.**

36.16 Subdivision 1. **Authority to inspect.** (a) In order to carry out the purposes of this chapter,
36.17 the office, upon presenting appropriate credentials to the owner, operator, or agent in charge,
36.18 is authorized to:

36.19 (1) enter any cannabis business without delay and at reasonable times;

36.20 (2) inspect and investigate during regular working hours and at other reasonable times,
36.21 within reasonable limits and in a reasonable manner, any cannabis business and all relevant
36.22 conditions, equipment, records, and materials therein; and

36.23 (3) question privately any employer, owner, operator, agent, or employee of a cannabis
36.24 business.

36.25 (b) An employer, owner, operator, agent, or employee must not refuse the office entry
36.26 or otherwise deter or prohibit the office from taking action under paragraph (a).

36.27 Subd. 2. **Powers of office.** (a) In making inspections and investigations under this chapter,
36.28 the office shall have the power to administer oaths, certify as to official acts, take and cause
36.29 to be taken depositions of witnesses, issue subpoenas, and compel the attendance of witnesses
36.30 and production of papers, books, documents, records, and testimony. In case of failure of
36.31 any person to comply with any subpoena lawfully issued, or on the refusal of any witness
36.32 to produce evidence or to testify to any matter regarding which the person may be lawfully
36.33 interrogated, the district court shall, upon application of the office, compel obedience

37.1 proceedings for contempt, as in the case of disobedience of the requirements of a subpoena
37.2 issued by the court or a refusal to testify therein.

37.3 (b) If the office finds probable cause to believe that any cannabis plant, cannabis flower,
37.4 artificially derived cannabinoid, or cannabinoid product is being distributed in violation of
37.5 this chapter or rules adopted under this chapter, the office shall affix to the cannabis plant,
37.6 cannabis flower, artificially derived cannabinoid, or cannabinoid product a tag, withdrawal
37.7 from distribution order, or other appropriate marking providing notice that the cannabis
37.8 plant, cannabis flower, artificially derived cannabinoid, or cannabinoid product is, or is
37.9 suspected of being, distributed in violation of this chapter, and has been detained or
37.10 embargoed, and warning all persons not to remove or dispose of the cannabis plant, cannabis
37.11 flower, artificially derived cannabinoid, or cannabinoid product by sale or otherwise until
37.12 permission for removal or disposal is given by the office or the court. It is unlawful for a
37.13 person to remove or dispose of detained or embargoed cannabis plant, cannabis flower,
37.14 artificially derived cannabinoid, or cannabinoid product by sale or otherwise without the
37.15 office's or a court's permission and each transaction is a separate violation of this section.

37.16 (c) If any cannabis plant, cannabis flower, artificially derived cannabinoid, or cannabinoid
37.17 product has been found by the office to be in violation of this chapter, the office shall petition
37.18 the district court in the county in which the cannabis plant, cannabis flower, artificially
37.19 derived cannabinoid, or cannabinoid product is detained or embargoed for an order and
37.20 decree for the condemnation of the cannabis plant, cannabis flower, artificially derived
37.21 cannabinoid, or cannabinoid product. The office shall release the cannabis plant, cannabis
37.22 flower, artificially derived cannabinoid, or cannabinoid product when this chapter and rules
37.23 adopted under this chapter have been complied with or the cannabis plant, cannabis flower,
37.24 artificially derived cannabinoid, or cannabinoid product is found not to be in violation of
37.25 this chapter or rules adopted under this chapter.

37.26 (d) If the court finds that detained or embargoed cannabis plant, cannabis flower,
37.27 artificially derived cannabinoid, or cannabinoid product is in violation of this chapter or
37.28 rules adopted under this chapter, the following remedies are available:

37.29 (1) after entering a decree, the cannabis plant, cannabis flower, artificially derived
37.30 cannabinoid, or cannabinoid product may be destroyed at the expense of the claimant under
37.31 the supervision of the office, and all court costs, fees, storage, and other proper expenses
37.32 must be assessed against the claimant of the cannabis plant, cannabis flower, artificially
37.33 derived cannabinoid, or cannabinoid product or the claimant's agent; and

38.1 (2) if the violation can be corrected by proper labeling or processing of the cannabis
38.2 plant, cannabis flower, artificially derived cannabinoid, or cannabinoid product, the court,
38.3 after entry of the decree and after costs, fees, and expenses have been paid, and a good and
38.4 sufficient bond conditioned that the cannabis plant, cannabis flower, artificially derived
38.5 cannabinoid, or cannabinoid product must be properly labeled or processed has been
38.6 executed, may by order direct that the cannabis plant, cannabis flower, artificially derived
38.7 cannabinoid, or cannabinoid product be delivered to the claimant for proper labeling or
38.8 processing under the supervision of the office. The office's supervision expenses must be
38.9 paid by the claimant. The cannabis plant, cannabis flower, artificially derived cannabinoid,
38.10 or cannabinoid product must be returned to the claimant and the bond must be discharged
38.11 on representation to the court by the office that the cannabis plant, cannabis flower, artificially
38.12 derived cannabinoid, or cannabinoid product is no longer in violation and that the office's
38.13 supervision expenses have been paid.

38.14 (e) If the office finds in any room, building, piece of equipment, vehicle of transportation,
38.15 or other structure any cannabis plant, cannabis flower, artificially derived cannabinoid, or
38.16 cannabinoid product that is unsound or contains any filthy, decomposed, or putrid substance,
38.17 or that may be poisonous or deleterious to health or otherwise unsafe, the office shall
38.18 condemn or destroy the item or in any other manner render the item as unsalable, and no
38.19 one has any cause of action against the office on account of the office's action.

38.20 (f) The office may enter into an agreement with the commissioner of agriculture to
38.21 analyze and examine samples or other articles furnished by the office for the purpose of
38.22 determining whether the sample or article violates this chapter or rules adopted under this
38.23 chapter. A copy of the examination or analysis report for any such article, duly authenticated
38.24 under oath by the laboratory analyst making the determination or examination, shall be
38.25 prima facie evidence in all courts of the matters and facts contained in the report.

38.26 Subd. 3. **Aiding of inspection.** Subject to rules issued by the office, a representative of
38.27 a cannabis business shall be given an opportunity to accompany the office during the physical
38.28 inspection of any cannabis business for the purpose of aiding such inspection.

38.29 Subd. 4. **Complaints and reports; priority of inspection.** (a) The office may conduct
38.30 inspections of any licensed cannabis business at any time to ensure compliance with the
38.31 ownership and operation requirements of this chapter.

38.32 (b) Any person may report a suspected violation of a safety or health standard. If upon
38.33 receipt of such notification the office determines that there are reasonable grounds to believe

39.1 that such violation or danger exists, the office shall make a special inspection as soon as
39.2 practicable to determine if such danger or violation exists.

39.3 (c) The office shall prioritize inspections of cannabis businesses where there are
39.4 reasonable grounds to believe that a violation poses imminent danger to the public or
39.5 customers.

39.6 (d) The office shall promptly inspect cannabis businesses that are the subject of complaint
39.7 by a local unit of government.

39.8 **Subd. 5. Violations; administrative orders and penalties.** (a) The office may issue an
39.9 administrative order to any licensed cannabis business that the office determines has
39.10 committed a violation of this chapter or rules adopted pursuant to this chapter. The
39.11 administrative order may require the business to correct the violation or to cease and desist
39.12 from committing the violation. The order must state the deficiencies that constitute the
39.13 violation and the time by which the violation must be corrected. If the business believes
39.14 that the information in the administrative order is in error, the person may ask the office to
39.15 consider the parts of the order that are alleged to be in error. The request must be in writing,
39.16 delivered to the office by certified mail within seven days after receipt of the order, and
39.17 provide documentation to support the allegation of error. The office must respond to a
39.18 request for reconsideration within 15 days after receiving the request. A request for
39.19 reconsideration does not stay the correction order unless the office issues a supplemental
39.20 order granting additional time. The office's disposition of a request for reconsideration is
39.21 final.

39.22 (b) For each violation of this chapter or rules adopted pursuant to this chapter, the office
39.23 may issue to each business a monetary penalty of up to \$10,000, an amount that deprives
39.24 the business of any economic advantage gained by the violation, or both.

39.25 (c) An administrative penalty may be recovered in a civil action in the name of the state
39.26 brought in the district court of the county where the violation is alleged to have occurred
39.27 or the district court where the office is housed.

39.28 (d) In addition to penalties listed in this subdivision, a person or business who violates
39.29 the provisions of this chapter is subject to any applicable criminal penalty.

39.30 **Subd. 6. Nonpublic data.** (a) The following data collected, created, or maintained by
39.31 the office is classified as private, pursuant to section 13.02, subdivision 9:

39.32 (1) data submitted by an applicant for a cannabis business license, other than the
39.33 applicant's name and designated address;

40.1 (2) the identity of a complainant who has made a report concerning a license holder or
 40.2 applicant that appears in inactive complaint data unless the complainant consents to the
 40.3 disclosure;

40.4 (3) the nature or content of unsubstantiated complaints when the information is not
 40.5 maintained in anticipation of legal action;

40.6 (4) inactive investigative data relating to violations of statutes or rules;

40.7 (5) the record of any disciplinary proceeding except as limited by paragraph (b);

40.8 (6) data identifying retail or wholesale customers of a cannabis business; and

40.9 (7) data identifying cannabis workers.

40.10 (b) Minutes, application data on license holders except nondesignated addresses, orders
 40.11 for hearing, findings of fact, conclusions of law, and specification of the final disciplinary
 40.12 action contained in the record of the disciplinary action are classified as public, pursuant to
 40.13 section 13.02, subdivision 15. If there is a public hearing concerning the disciplinary action,
 40.14 the entire record concerning the disciplinary proceeding is public data pursuant to section
 40.15 13.02, subdivision 15. If the license holder and the office agree to resolve a complaint
 40.16 without a hearing, the agreement and the specific reasons for the agreement are public data.

40.17 (c) The office must establish written procedures to ensure that only individuals authorized
 40.18 by law may enter, update, or access the data classified as nonpublic or private data on
 40.19 individuals in this subdivision. An authorized individual's ability to enter, update, or access
 40.20 data in the system must correspond to the official duties or training level of the individual
 40.21 and to the statutory authorization granting access for that purpose. All queries and responses,
 40.22 and all actions in which not public data are entered, updated, accessed, shared, or
 40.23 disseminated, must be recorded in a data audit trail. Data contained in the audit trail have
 40.24 the same classification as the underlying data tracked by the audit trail.

40.25 (d) The office must not share data classified as private under this subdivision or other
 40.26 data identifying an individual applicant or license holder with any federal agency, federal
 40.27 department, or federal entity unless specifically ordered to do so by a state or federal court.

40.28 **Sec. 18. [342.19] LICENSE SUSPENSION OR REVOCATION; HEARING.**

40.29 Subdivision 1. **License revocation and nonrenewal.** The office may revoke or not
 40.30 renew a license when the office has cause to believe that a cannabis business has violated
 40.31 an ownership or operational requirement in this chapter or rules adopted pursuant to this
 40.32 chapter. The office must notify the license holder in writing, specifying the grounds for

41.1 revocation or nonrenewal and fixing a time of at least 20 days thereafter for a hearing on
 41.2 the matter.

41.3 Subd. 2. **Hearing; written findings.** (a) Before the office revokes or does not renew a
 41.4 license, the office must provide the license holder with a statement of the complaints made
 41.5 against the license holder, and the office must hold a hearing to determine whether the office
 41.6 should revoke the license or deny renewal of the license. The license holder shall receive
 41.7 notice at least 20 days before the date of the hearing and notice may be served either by
 41.8 certified mail addressed to the address of the license holder as shown in the license
 41.9 application or in the manner provided by law for the service of a summons. At the time and
 41.10 place fixed for the hearing, the office, or any office employee or agent authorized by the
 41.11 office to conduct the hearing, shall receive evidence, administer oaths, and examine witnesses.

41.16 Subd. 3. **Temporary suspension.** The office may temporarily, without hearing, suspend
 41.17 the license and operating privilege of any business licensed under this chapter for up to 90
 41.18 days if continuing the operation of the business would threaten the health or safety of any
 41.19 person. The office may extend the period for an additional 90 days if the office notified the
 41.20 business that the office intends to revoke or not renew a license and the hearing required
 41.21 under subdivision 2 has not taken place.

41.22 Sec. 19. **[342.20] ADULT-USE CANNABIS BUSINESS; GENERAL OWNERSHIP**
 41.23 **DISQUALIFICATIONS AND REQUIREMENTS.**

41.24 Subdivision 1. **Criminal history check.** Every license applicant and prospective cannabis
 41.25 worker must submit a completed criminal history records check consent form, a full set of
 41.26 classifiable fingerprints, and the required fees to the office. Upon receipt of this information,
 41.27 the office must submit the completed criminal history records check consent form, full set
 41.28 of classifiable fingerprints, and required fees to the Bureau of Criminal Apprehension. After
 41.29 receiving this information, the bureau must conduct a Minnesota criminal history records
 41.30 check of the license applicant. The bureau may exchange a license applicant's fingerprints
 41.31 with the Federal Bureau of Investigation to obtain the applicant's national criminal history
 41.32 record information. The bureau must return the results of the Minnesota and federal criminal
 41.33 history records checks to the director to determine if the applicant is disqualified under this
 41.34 section.

42.1 Subd. 2. **Criminal offenses; disqualifications.** (a) No person may hold or receive a
42.2 license issued under this chapter or work for a cannabis business if the person has been
42.3 convicted of, or received a stay of adjudication for, a violation of a state or federal controlled
42.4 substance law that is a felony under Minnesota law or would be a felony if committed in
42.5 Minnesota, regardless of the sentence imposed, unless the office determines that the person's
42.6 conviction was for the possession or sale of cannabis.

42.7 (b) A person who has been convicted of, or received a stay of adjudication for, a violation
42.8 of Minnesota Statutes 2022, section 152.023, subdivision 1, clause (3), or a state or federal
42.9 law in conformity with that provision, for the sale of cannabis to a person under the age of
42.10 18 may hold or receive a license issued under this chapter, or work for a cannabis business,
42.11 if 20 years have passed since the date the person was convicted or adjudication was stayed.

42.12 (c) Except as provided in paragraph (a), (b), or (d), a person who has been convicted of,
42.13 or received a stay of adjudication for, a violation of a state or federal law that is a felony
42.14 under Minnesota law or would be a felony if committed in Minnesota, regardless of the
42.15 sentence imposed, may hold or receive a license issued under this chapter, or work for a
42.16 cannabis business, if five years have passed since the discharge of the sentence.

42.17 (d) No license holder or applicant may hold or receive a license issued under this chapter,
42.18 or work for a cannabis business, if the person has been convicted of a sale of cannabis in
42.19 the first degree under section 152.0264, subdivision 2.

42.20 (e) A person who has been convicted of sale of cannabis in the second degree under
42.21 section 152.0264, subdivision 3, may hold or receive a license issued under this chapter or
42.22 work for a cannabis business if ten years have passed since the discharge of the sentence.

42.23 (f) A person who has been convicted of sale of cannabis in the third degree under section
42.24 152.0264, subdivision 4, may hold or receive a license issued under this chapter or work
42.25 for a cannabis business if five years have passed since the discharge of the sentence.

42.26 (g) A person who has been convicted of sale of cannabis in the fourth degree under
42.27 section 152.0264, subdivision 5, may hold or receive a license issued under this chapter or
42.28 work for a cannabis business if one year has passed since the discharge of the sentence.

42.29 (h) If the license holder or applicant is a business entity, the disqualifications under this
42.30 subdivision apply to every cooperative member or every director, manager, and general
42.31 partner of the business entity.

42.32 Subd. 3. **Risk of harm; set aside.** The office may set aside a disqualification under
42.33 subdivision 2 if the office finds that the person has submitted sufficient information to

43.1 demonstrate that the person does not pose a risk of harm to any person served by the
43.2 applicant, license holder, or other entities as provided in this chapter.

43.3 Subd. 4. General requirements. (a) A license holder or applicant must meet each of
43.4 the following requirements, if applicable, to hold or receive a license issued under this
43.5 chapter:

43.6 (1) be at least 21 years of age;

43.7 (2) have completed an application for licensure or application for renewal;

43.8 (3) have paid the applicable application fee;

43.9 (4) reside in the state;

43.16 (8) not be a licensed peace officer, as defined in section 626.84, subdivision 1, paragraph
43.17 (c);

43.18 (9) never have had a license previously issued under this chapter revoked;

43.19 (10) have filed any previously required tax returns for a cannabis business;

43.20 (11) have paid and remitted any business taxes, gross receipts taxes, interest, or penalties
43.21 due relating to the operation of a cannabis business;

43.22 (12) have fully and truthfully complied with all information requests of the office relating
43.23 to license application and renewal;

43.24 (13) not be disqualified under subdivision 2;

43.25 (14) not employ an individual who is disqualified from working for a cannabis business
43.26 under this chapter; and

43.27 (15) meet the ownership and operational requirements for the type of license and, if
43.28 applicable, endorsement sought or held.

43.29 (b) If the license holder or applicant is a business entity, every officer, director, manager,
43.30 and general partner of the business entity must meet each of the requirements of this section.

44.1 Sec. 20. **[342.21] CANNABIS BUSINESS; GENERAL OPERATIONAL**
44.2 **REQUIREMENTS AND PROHIBITIONS.**

44.3 **Subdivision 1. Individuals under 21 years of age.** (a) A cannabis business may not
44.4 employ an individual under 21 years of age and may not contract with an individual under
44.5 21 years of age if the individual's scope of work involves the handling of cannabis plants,
44.6 cannabis flower, artificially derived cannabinoids, or cannabinoid products.

44.7 (b) A cannabis business may not permit an individual under 21 years of age to enter the
44.8 business premises other than entry into an area that solely dispenses medical cannabis flower
44.9 or medical cannabinoid products.

44.10 (c) A cannabis business may not sell or give cannabis flower or cannabinoid products
44.11 to an individual under 21 years of age unless the individual is a patient; registered designated
44.12 caregiver; or a parent, legal guardian, or spouse of a patient who is authorized to use, possess,
44.13 or transport medical cannabis or medical cannabinoid products.

44.14 **Subd. 2. Use of cannabis flower and cannabinoid products within a licensed cannabis**
44.15 **business.** (a) A cannabis business may not permit an individual who is not an employee to
44.16 consume cannabis flower or cannabinoid products within its licensed premises unless the
44.17 business is licensed to permit on-site consumption or the business has an on-site endorsement
44.18 to a license authorizing the sale of lower potency edible products.

44.19 (b) Except as otherwise provided in this subdivision, a cannabis business may not permit
44.20 an employee to consume cannabis flower or cannabinoid products within its licensed premises
44.21 or while the employee is otherwise engaged in activities within the course and scope of
44.22 employment.

44.23 (c) A cannabis business may permit an employee to use medical cannabis flower and
44.24 medical cannabinoid products if that individual is a patient.

44.25 (d) For quality control, employees of a licensed cannabis business may sample cannabis
44.26 flower or cannabinoid products. Employees may not interact directly with customers for at
44.27 least three hours after sampling a product. Employees may not consume more than three
44.28 samples in a single 24-hour period. All samples must be recorded in the statewide monitoring
44.29 system.

44.30 **Subd. 3. Restricted access.** (a) Except as otherwise provided in this subdivision, a
44.31 cannabis business may not permit any individual to enter a restricted area unless the cannabis
44.32 business records the individual's name, time of entry, time of exit, and authorization to enter
44.33 the restricted area through use of an electronic or manual entry log and the individual:

45.1 (1) is a cannabis worker employed by or contracted with the cannabis business;

45.2 (2) is an employee of the office or another enforcement agency;

45.3 (3) is a contractor of the cannabis business, including but not limited to an electrician,
45.4 a plumber, an engineer, or an alarm technician, whose scope of work will not involve the
45.5 handling of cannabis flower or cannabinoid products and, if the individual is working in an
45.6 area with immediate access to cannabis flower or cannabinoid products, the individual is
45.7 supervised at all times by a cannabis worker employed by or contracted with the cannabis
45.8 business; or

45.9 (4) has explicit authorization from the office to enter a restricted area and, if the individual
45.10 is in an area with immediate access to cannabis flower or cannabinoid products, the individual
45.11 is supervised at all times by a cannabis worker employed by or contracted with the cannabis
45.12 business.

45.13 (b) A cannabis business shall ensure that all areas of entry to restricted areas within its
45.14 licensed premises are conspicuously marked and cannot be entered without recording the
45.15 individual's name, time of entry, time of exit, and authorization to enter the restricted area.

45.16 Subd. 4. **Ventilation and filtration.** A cannabis business must maintain a ventilation
45.17 and filtration system sufficient to meet the requirements for odor control established by the
45.18 office.

45.19 Subd. 5. **Records.** (a) A cannabis business must retain financial records for the current
45.20 and previous tax year at the primary business location and must make those records available
45.21 for inspection by the office at any time during regular business hours.

45.22 (b) When applicable, a cannabis business must maintain financial records for the previous
45.23 ten tax years and must make those records available for inspection within one business day
45.24 of receiving a request for inspection by the office.

45.25 (c) The office may require a cannabis business to submit to an audit of its business
45.26 records. The office may select or approve the auditor and the cannabis business must provide
45.27 the auditor with access to all business records. The cost of the audit must be paid by the
45.28 cannabis business.

45.29 Subd. 6. **Diversity report.** A cannabis business shall provide an annual report on the
45.30 status of diversity in the business ownership, management, and employment and in services
45.31 for which the business contracts.

45.32 Subd. 7. **Use of statewide monitoring system.** (a) A cannabis business must use the
45.33 statewide monitoring system for integrated cannabis tracking, inventory, and verification

46.1 to track all cannabis plants, cannabis flower, cannabinoid products, and artificially derived
46.2 cannabinoids the cannabis business has in its possession to the point of disposal, transfer,
46.3 or sale.

46.4 (b) For the purposes of this subdivision, a cannabis business possesses the cannabis
46.5 plants and cannabis flower that the business cultivates from seed or immature plant, if
46.6 applicable, or receives from another cannabis business, possesses the artificially derived
46.7 cannabinoids that the business creates or receives from another cannabis business, and
46.8 possesses the cannabinoid products that the business manufactures or receives from another
46.9 cannabis business.

46.10 (c) Sale and transfer of cannabis plants, cannabis flower, cannabinoid products, and
46.11 artificially derived cannabinoids must be recorded in the statewide monitoring system within
46.12 the time established by rule.

46.13 Subd. 8. **Disposal; loss documentation.** (a) A cannabis business must dispose of cannabis
46.14 plants, cannabis flower, cannabinoid products, and artificially derived cannabinoids that
46.15 are damaged, have a broken seal, have been contaminated, or have not been sold by the
46.16 expiration date on the label.

46.17 (b) Disposal must be conducted in a manner approved by the office.

46.18 (c) Disposed products must be documented in the statewide monitoring system.

46.19 (d) Any lost or stolen products must be reported to local law enforcement and a cannabis
46.20 business must log any lost or stolen products in the statewide monitoring system as soon
46.21 as the loss is discovered.

46.22 Subd. 9. **Sale of approved products.** A cannabis business may only sell cannabis plants,
46.23 cannabis flower, cannabinoid products, and artificially derived cannabinoids that are approved
46.24 by the office and that comply with this chapter and rules adopted pursuant to this chapter
46.25 regarding the testing, packaging, and labeling of cannabis plants, cannabis flower,
46.26 cannabinoid products, and artificially derived cannabinoids.

46.27 Subd. 10. **Security.** A cannabis business must maintain and follow a security plan to
46.28 deter and prevent the theft or diversion of cannabis plants, cannabis flower, cannabinoid
46.29 products, and artificially derived cannabinoids, unauthorized entry into the cannabis business,
46.30 and the theft of currency.

46.31 Subd. 11. **Financial relationship.** (a) Except for the lawful sale of cannabis plants,
46.32 cannabis flower, cannabinoid products, and artificially derived cannabinoids in the ordinary
46.33 course of business and as otherwise provided in this subdivision, no cannabis business may

47.1 offer, give, accept, receive, or borrow money or anything else of value or accept or receive
47.2 credit from any other cannabis business. This prohibition applies to offering or receiving a
47.3 benefit in exchange for preferential placement by a cannabis retailer, including preferential
47.4 placement on the cannabis retailer's shelves, display cases, or website. This prohibition
47.5 applies to every cooperative member or every director, manager, and general partner of a
47.6 cannabis business.

47.7 (b) This prohibition does not apply to merchandising credit in the ordinary course of
47.8 business for a period not to exceed 30 days.

47.9 (c) This prohibition does not apply to free samples of useable cannabis flower or
47.10 cannabinoid products packaged in a sample jar protected by a plastic or metal mesh screen
47.11 to allow customers to smell the cannabis flower or cannabinoid product before purchase.
47.12 A sample jar may not contain more than eight grams of useable cannabis flower, eight grams
47.13 of a cannabis concentrate, or an edible cannabinoid product infused with 100 milligrams of
47.14 tetrahydrocannabinol.

47.15 (d) This prohibition does not apply to free samples of cannabis flower or cannabinoid
47.16 products provided to a cannabis retailer or cannabis wholesaler for the purposes of quality
47.17 control and to allow cannabis retailers to determine whether to offer a product for sale. A
47.18 sample provided for these purposes may not contain more than eight grams of useable
47.19 cannabis flower, eight grams of a cannabis concentrate, or an edible cannabinoid product
47.20 infused with 100 milligrams of tetrahydrocannabinol.

47.21 (e) This prohibition does not apply to any fee charged by a licensed cannabis event
47.22 organizer to a cannabis business for participation in a cannabis event.

47.23 Subd. 12. **Customer privacy.** A cannabis business must not share data on retail or
47.24 wholesale customers with any federal agency, federal department, or federal entity unless
47.25 specifically ordered by a state or federal court.

47.26 Sec. 21. **[342.22] CANNABIS CULTIVATOR LICENSING.**

47.27 Subdivision 1. **Authorized actions.** (a) A cannabis cultivator license entitles the license
47.28 holder to grow cannabis plants within the approved amount of space from seed or immature
47.29 plant to mature plant, harvest cannabis flower from a mature plant, package and label
47.30 cannabis flower for sale to other cannabis businesses, transport cannabis flower to a cannabis
47.31 manufacturer located on the same premises, and perform other actions approved by the
47.32 office.

47.33 (b) The office may issue an applicant either of the following types of cultivator licenses:

48.1 (1) a craft cultivator license, which allows cultivation by a license holder of not more
48.2 than 10,000 feet of plant canopy unless the office, by rule, increases that limit; or

48.3 (2) a bulk cultivator license, which allows cultivation by a license holder of not more
48.4 than 30,000 feet of plant canopy.

48.5 (c) The office may, by rule, increase the limit on craft cultivator plant canopy to no more
48.6 than 15,000 square feet if the office determines that expansion is consistent with the goals

48.8 Subd. 2. **Additional information required.** In addition to the information required to
48.9 be submitted under section 342.15, subdivision 1, and rules adopted pursuant to that section,
48.10 a person, cooperative, or business seeking a cannabis cultivator license must submit the
48.11 following information in a form approved by the office:

48.12 (1) an operating plan demonstrating the proposed size and layout of the cultivation
48.13 facility; plans for wastewater and waste disposal for the cultivation facility; plans for
48.14 providing electricity, water, and other utilities necessary for the normal operation of the
48.15 cultivation facility; and plans for compliance with the applicable building code and federal
48.16 and state environmental and workplace safety requirements;

48.17 (2) a cultivation plan demonstrating the proposed size and layout of the cultivation
48.18 facility that will be used exclusively for cultivation including the total amount of plant
48.19 canopy; and

48.20 (3) evidence that the business will comply with the applicable operation requirements
48.21 for the license being sought.

48.22 Subd. 3. **Multiple licenses; limits.** (a) A person, cooperative, or business holding a
48.23 cannabis cultivator license may also hold a cannabis manufacturing license, medical cannabis
48.24 cultivator license, medical cannabis manufacturing license, license to grow industrial hemp,
48.25 and cannabis event organizer license.

48.26 (b) Except as provided in paragraph (a), no person, cooperative, or business holding a
48.27 cannabis cultivator license may own or operate any other cannabis business. This prohibition
48.28 does not prevent the transportation of cannabis flower from a cannabis cultivator to a cannabis
48.29 manufacturer licensed to the same person, cooperative, or business and located on the same
48.30 premises.

48.31 (c) The office by rule may limit the number of cannabis cultivator licenses a person,
48.32 cooperative, or business may hold.

49.1 (d) For purposes of this subdivision, a restriction on the number or type of license a
49.2 business may hold applies to every cooperative member or every director, manager, and
49.3 general partner of a cannabis business.

49.4 Subd. 4. **Limitations on health care practitioners.** A health care practitioner who
49.5 certifies qualifying medical conditions for patients is prohibited from:

49.6 (1) holding a direct or indirect economic interest in a cannabis cultivator;

49.7 (2) serving as a cooperative member, director, manager, general partner, or employee
49.8 of a cannabis cultivator; or

49.9 (3) advertising with a cannabis cultivator in any way.

49.10 Subd. 5. **Remuneration.** A cannabis cultivator is prohibited from:

49.11 (1) accepting or soliciting any form of remuneration from a health care practitioner who
49.12 certifies qualifying medical conditions for patients; or

49.13 (2) offering any form of remuneration to a health care practitioner who certifies qualifying
49.14 medical conditions for patients.

49.15 Sec. 22. **[342.23] CANNABIS CULTIVATOR OPERATIONS.**

49.16 Subdivision 1. **Cultivation records.** A cannabis cultivator must prepare a cultivation
49.17 record for each batch of cannabis plants and cannabis flower in the form required by the
49.18 office and must maintain each record for at least five years. The cultivation record must
49.19 include the quantity and timing, where applicable, of each pesticide, fertilizer, soil
49.20 amendment, or plant amendment used to cultivate the batch, as well as any other information
49.21 required by the office in rule. A licensed cultivator must present cultivation records to the
49.22 office, the commissioner of agriculture, or the commissioner of health upon request.

49.23 Subd. 2. **Agricultural chemicals and other inputs.** A cannabis cultivator is subject to

49.30 (2) recycling;

49.31 (3) solid waste disposal; and

50.1 (4) a pest management protocol that incorporates integrated pest management principles
50.2 to control or prevent the introduction of pests to the cultivation site.

50.3 Subd. 4. **Pesticides; pollinator protection.** (a) A cannabis cultivator must comply with
50.4 chapters 18B, 18D, 18E, and any other pesticide laws and rules enforced by the commissioner
50.5 of agriculture.

50.6 (b) A cannabis cultivator must not apply pesticides when pollinators are present or allow
50.7 pesticides to drift to flowering plants that are attractive to pollinators.

50.8 Subd. 5. **Adulteration prohibited.** A cannabis cultivator must not treat or otherwise
50.9 adulterate cannabis plants or cannabis flower with any substance or compound that has the
50.10 effect or intent of altering the color, appearance, weight, or smell of the cannabis.

50.11 Subd. 6. **Indoor, outdoor cultivation authorized; security.** A cannabis cultivator may
50.12 cultivate cannabis plants indoors or outdoors, subject to the security, fencing, lighting, and
50.13 any other requirements imposed by the office in rule.

50.14 Subd. 7. **Seed limitation.** The commissioner of agriculture must not issue a genetically
50.15 engineered agriculturally related organism permit under chapter 18F for cannabis seed or
50.16 cannabis plants. A cannabis cultivator must not cultivate a cannabis plant that is a genetically
50.17 engineered organism as defined in section 18F.02, subdivision 5.

50.18 Sec. 23. **[342.24] CANNABIS MANUFACTURER LICENSING.**

50.19 Subdivision 1. **Authorized actions.** A cannabis manufacturer license, consistent with
50.20 the specific license endorsement or endorsements, entitles the license holder to:

50.21 (1) purchase cannabis flower, cannabinoid products, hemp plant parts, hemp concentrate,
50.22 and artificially derived cannabinoids from cannabis cultivators, other cannabis manufacturers,
50.23 cannabis microbusinesses, and industrial hemp growers;

50.24 (2) accept cannabis from unlicensed persons who are at least 21 years of age provided
50.25 that the cannabis manufacturer does not accept more than two ounces from an individual
50.26 on a single occasion;

50.27 (3) make cannabis concentrate;

50.28 (4) make hemp concentrate, including hemp concentrate with a delta-9
50.29 tetrahydrocannabinol concentration of more than 0.3 percent as measured by weight;

50.30 (5) manufacture artificially derived cannabinoids;

51.1 (6) manufacture cannabinoid products and hemp-derived consumer products for public
51.2 consumption;

51.3 (7) package and label cannabinoid products and hemp-derived consumer products for
51.4 sale to other cannabis businesses;

51.5 (8) sell cannabis concentrate, hemp concentrate, artificially derived cannabinoids,
51.6 cannabinoid products, and hemp-derived consumer products to other cannabis businesses;
51.7 and

51.8 (9) perform other actions approved by the office.

51.9 Subd. 2. **Additional information required.** In addition to the information required to
51.10 be submitted under section 342.15, subdivision 1, and rules adopted pursuant to that section,
51.11 a person, cooperative, or business seeking a cannabis manufacturer license must submit the
51.12 following information in a form approved by the office:

51.13 (1) an operating plan demonstrating the proposed layout of the facility, including a
51.14 diagram of ventilation and filtration systems; plans for wastewater and waste disposal for
51.15 the manufacturing facility; plans for providing electricity, water, and other utilities necessary
51.16 for the normal operation of the manufacturing facility; and plans for compliance with
51.17 applicable building code and federal and state environmental and workplace safety

51.19 (2) evidence that the business will comply with the applicable operation requirements
51.20 for the endorsement being sought.

51.21 Subd. 3. **Multiple licenses; limits.** (a) A person, cooperative, or business holding a

51.23 cultivator license, a medical cannabis processor license, and a cannabis event organizer
51.24 license.

51.25 (b) Except as provided in paragraph (a), no person, cooperative, or business holding a
51.26 cannabis manufacturer license may own or operate any other cannabis business. This
51.27 prohibition does not prevent transportation of cannabis flower from a cannabis cultivator
51.28 to a cannabis manufacturer licensed to the same person, cooperative, or business and located
51.29 on the same premises.

51.30 (c) The office by rule may limit the number of cannabis manufacturer licenses that a
51.31 person or business may hold.

52.1 (d) For purposes of this subdivision, a restriction on the number or type of license that
 52.2 a business may hold applies to every cooperative member or every director, manager, and
 52.3 general partner of a cannabis business.

52.4 Subd. 4. **Limitations on health care practitioners.** A health care practitioner who
 52.5 certifies qualifying medical conditions for patients is prohibited from:

52.6 (1) holding a direct or indirect economic interest in a cannabis manufacturer;

52.7 (2) serving as a cooperative member, director, manager, general partner, or employee
 52.8 of a cannabis manufacturer; or

52.10 Subd. 5. **Remuneration.** A cannabis manufacturer is prohibited from:

52.13 (2) offering any form of remuneration to a health care practitioner who certifies qualifying
 52.14 medical conditions for patients.

52.15 Sec. 24. **[342.25] CANNABIS MANUFACTURER OPERATIONS.**

52.16 Subdivision 1. **All manufacturer operations.** (a) Cannabis manufacturing must take
 52.17 place in an enclosed, locked facility that is used exclusively for the manufacture of
 52.18 cannabinoid products, creation of hemp concentrate, or creation of artificially derived
 52.19 cannabinoids except that a business that also holds a cannabis cultivator license may operate
 52.20 in a facility that shares general office space, bathrooms, entryways, and walkways.

52.21 (b) Cannabis manufacturing must take place on equipment that is used exclusively for
 52.22 the manufacture of cannabinoid products, creation of hemp concentrate, or creation of
 52.23 artificially derived cannabinoids.

52.24 (c) A cannabis manufacturer must comply with all applicable packaging, labeling, and
 52.25 health and safety requirements.

52.26 Subd. 2. **Extraction and concentration.** (a) A cannabis manufacturer that creates
 52.27 cannabis concentrate, hemp concentrate, or artificially derived cannabinoids must obtain
 52.28 an endorsement from the office.

52.29 (b) A cannabis manufacturer must inform the office of all methods of extraction and
 52.30 concentration that the manufacturer intends to use and identify the volatile chemicals, if
 52.31 any, that will be involved in the creation of cannabis concentrate or hemp concentrate. A

53.1 cannabis manufacturer may not use a method of extraction and concentration or a volatile
53.2 chemical without approval by the office.

53.3 (c) A cannabis manufacturer must inform the office of all methods of conversion that
53.4 the manufacturer will use, including any specific catalysts that the manufacturer will employ,
53.5 to create artificially derived cannabinoids and the molecular nomenclature of all cannabinoids
53.6 or other chemical compound that the manufacturer will create. A cannabis manufacturer
53.7 may not use a method of conversion or a catalyst without approval by the office.

53.8 (d) A cannabis manufacturer must obtain a certification from an independent third-party
53.9 industrial hygienist or professional engineer approving:

53.10 (1) all electrical, gas, fire suppression, and exhaust systems; and

53.11 (2) the plan for safe storage and disposal of hazardous substances, including but not
53.12 limited to any volatile chemicals.

53.13 (e) A cannabis manufacturer that manufactures cannabis concentrate from cannabis
53.14 flower received from an unlicensed person who is at least 21 years of age must comply with
53.15 all health and safety requirements established by the office. At a minimum, the office shall
53.16 require a cannabis manufacturer to:

53.17 (1) store the cannabis flower in an area that is segregated from cannabis flower and hemp
53.18 plant parts received from a licensed cannabis business;

53.19 (2) perform the extraction and concentration on equipment that is used exclusively for
53.20 extraction or concentration of cannabis flower received from unlicensed individuals;

53.21 (3) store any cannabis concentrate in an area that is segregated from cannabis concentrate,
53.22 hemp concentrate, or artificially derived cannabinoids derived or manufactured from cannabis
53.23 flower or hemp plant parts received from a licensed cannabis business; and

53.24 (4) provide any cannabis concentrate only to the person who provided the cannabis.

53.25 (f) Upon the sale of cannabis concentrate, hemp concentrate, or artificially derived
53.26 cannabinoids to any person, cooperative, or business, a cannabis manufacturer must provide
53.27 a statement to the buyer that discloses the method of extraction and concentration or
53.28 conversion used and any solvents, gases, or catalysts, including but not limited to any volatile
53.29 chemicals, involved in that method.

53.30 **Subd. 3. Production of consumer products.** (a) A cannabis manufacturer that produces
53.31 edible cannabinoid products must obtain an edible cannabinoid product handler endorsement
53.32 from the office.

54.1 (b) A cannabis manufacturer must obtain an endorsement from the office to produce:

54.2 (1) cannabinoid products other than edible cannabinoid products; or

54.3 (2) hemp-derived consumer products other than hemp-derived topical products.

54.4 (c) All areas within the licensed premises of a cannabis manufacturer producing
 54.5 cannabinoid products or hemp-derived consumer products must meet the sanitary standards

54.7 (d) A cannabis manufacturer may only add chemicals or compounds approved by the

 54.10 cannabis business, a cannabis manufacturer must provide a statement to the buyer that
 54.11 discloses the product's ingredients, including but not limited to any chemicals or compounds
 54.12 and any major food allergens declared by name.

54.13 (f) A cannabis manufacturer shall not add any cannabis flower, cannabis concentrate,
 54.14 artificially derived cannabinoid, hemp plant part, or hemp concentrate to a product where
 54.15 the manufacturer of the product holds a trademark to the product's name, except that a
 54.16 cannabis manufacturer may use a trademarked food product if the manufacturer uses the
 54.17 product as a component or as part of a recipe and where the cannabis manufacturer does
 54.18 not state or advertise to the customer that the final retail cannabinoid product or hemp-derived
 54.19 consumer product contains a trademarked food product.

54.20 **Sec. 25. [342.26] CANNABIS RETAILER LICENSING.**

54.21 Subdivision 1. **Authorized actions.** A cannabis retailer license entitles the license holder
 54.22 to:

54.23 (1) purchase immature cannabis plants and seedlings, cannabis flower, cannabinoid
 54.24 products, and hemp-derived consumer products from cannabis cultivators, cannabis
 54.25 manufacturers, cannabis microbusinesses, cannabis wholesalers, and industrial hemp growers;

54.26 (2) sell immature cannabis plants and seedlings, adult-use cannabis flower, adult-use
 54.27 cannabinoid products, hemp-derived consumer products, and other products authorized by
 54.28 law to customers; and

54.29 (3) perform other actions approved by the office.

54.30 Subd. 2. **Additional information required.** In addition to the information required to
 54.31 be submitted under section 342.15, subdivision 1, and rules adopted pursuant to that section,

55.1 a person, cooperative, or business seeking a cannabis retail license must submit the following
55.2 information in a form approved by the office:

55.3 (1) a list of every retail license held by the applicant and, if the applicant is a business,
55.4 every retail license held, either as an individual or as part of another business, by each
55.5 officer, director, manager, and general partner of the cannabis business;

55.6 (2) an operating plan demonstrating the proposed layout of the facility, including a
55.7 diagram of ventilation and filtration systems; policies to avoid sales to individuals who are
55.8 under 21 years of age; identification of a restricted area for storage; and plans to prevent
55.9 the visibility of cannabis flower, cannabinoid products, and hemp-derived consumer products
55.10 to individuals outside the retail location; and

55.11 (3) evidence that the business will comply with the applicable operation requirements
55.12 for the license being sought.

55.13 Subd. 3. **Multiple licenses; limits.** (a) A person, cooperative, or business holding a
55.14 cannabis retailer license may also hold a cannabis delivery service license, a medical cannabis
55.15 retailer license, and a cannabis event organizer license.

55.16 (b) Except as provided in paragraph (a), no person, cooperative, or business holding a
55.17 cannabis retailer license may own or operate any other cannabis business.

55.18 (c) No person, cooperative, or business may hold a license to own or operate more than
55.19 one cannabis retail business in one city or county.

55.20 (d) The office by rule may limit the number of cannabis retailer licenses a person,
55.21 cooperative, or business may hold.

55.22 (e) For purposes of this subdivision, a restriction on the number or type of license a
55.23 business may hold applies to every cooperative member or every director, manager, and
55.24 general partner of a cannabis business.

55.25 Subd. 4. **Municipal or county cannabis store.** A city or county may establish, own,
55.26 and operate a municipal cannabis store subject to the restrictions in this chapter.

55.27 Subd. 5. **Limitations on health care practitioners.** A health care practitioner who
55.28 certifies qualifying medical conditions for patients is prohibited from:

55.29 (1) holding a direct or indirect economic interest in a cannabis retailer;

56.1 Subd. 6. Remuneration. A cannabis retailer is prohibited from:

56.4 (2) offering any form of remuneration to a health care practitioner who certifies qualifying
56.5 medical conditions for patients.

56.6 Sec. 26. [342.27] CANNABIS RETAILER OPERATIONS.

56.7 Subdivision 1. Sale of cannabis and cannabinoid products. (a) A cannabis retailer
56.8 may only sell immature cannabis plants and seedlings, adult-use cannabis flower, adult-use
56.9 cannabinoid products, and hemp-derived consumer products to individuals who are at least
56.10 21 years of age.

56.11 (b) A cannabis retailer may sell immature cannabis plants and seedlings, adult-use
56.12 cannabis flower, adult-use cannabinoid products, and hemp-derived consumer products
56.13 other than hemp-derived topical products that:

56.14 (1) are obtained from a licensed Minnesota cannabis cultivator, cannabis manufacturer,
56.15 cannabis microbusiness, or cannabis wholesaler; and

56.16 (2) meet all applicable packaging and labeling requirements.

56.17 (c) A cannabis retailer may sell up to two ounces of adult-use cannabis flower, eight
56.18 grams of adult-use cannabis concentrate, and edible cannabinoid products infused with 800
56.19 milligrams of tetrahydrocannabinol during a single transaction to a customer.

56.20 (d) Edible cannabinoid products may not include more than ten milligrams per serving
56.21 and a single package may not include more than a total of 100 milligrams of
56.22 tetrahydrocannabinol. A package may contain multiple servings of ten milligrams of
56.23 tetrahydrocannabinol provided that each serving is indicated by scoring, wrapping, or other
56.24 indicators designating the individual serving size.

56.25 Subd. 2. Sale of other products. (a) A cannabis retailer may sell cannabis paraphernalia,
56.26 including but not limited to childproof packaging containers and other devices designed to
56.27 ensure the safe storage and monitoring of cannabis flower and cannabinoid products in the
56.28 home to prevent access by individuals under 21 years of age.

56.29 (b) A cannabis retailer may sell hemp-derived topical products.

56.30 (c) A cannabis retailer may sell the following products that do not contain cannabis
56.31 flower, cannabis concentrate, hemp concentrate, artificially derived cannabinoids, or
56.32 tetrahydrocannabinol:

57.1 (1) drinks that do not contain alcohol and are packaged in sealed containers labeled for
57.2 retail sale;

57.3 (2) books and videos on the cultivation and use of cannabis flower and cannabinoid
57.4 products;

57.5 (3) magazines and other publications published primarily for information and education
57.6 on cannabis plants, cannabis flower, and cannabinoid products;

57.7 (4) multiple-use bags designed to carry purchased items;

57.8 (5) clothing marked with the specific name, brand, or identifying logo of the cannabis
57.9 retailer; and

57.10 (6) hemp fiber products and products that contain hemp grain.

57.11 Subd. 3. **Age verification.** (a) Prior to initiating a sale, an employee of a cannabis retailer
57.12 must verify that the customer is at least 21 years of age.

57.13 (b) Proof of age may be established only by one of the following:

57.14 (1) a valid driver's license or identification card issued by Minnesota, another state, or
57.15 a province of Canada, and including the photograph and date of birth of the licensed person;

57.16 (2) a valid Tribal identification card as defined in section 171.072, paragraph (b);

57.17 (3) a valid passport issued by the United States;

57.18 (4) a valid instructional permit issued under section 171.05 to a person of legal age to
57.19 purchase adult-use cannabis or adult-use cannabinoid products, which includes a photograph
57.20 and the date of birth of the person issued the permit; or

57.21 (5) in the case of a foreign national, by a valid passport.

57.22 (c) A cannabis retailer may seize a form of identification listed under paragraph (b) if
57.23 the cannabis retailer has reasonable grounds to believe that the form of identification has
57.24 been altered or falsified or is being used to violate any law. A cannabis retailer that seizes
57.25 a form of identification as authorized under this paragraph must deliver it to a law
57.26 enforcement agency within 24 hours of seizing it.

57.27 Subd. 4. **Display of cannabis flower and cannabinoid products.** (a) A cannabis retailer
57.28 must designate a retail area where customers are permitted. The retail area shall include the
57.29 portion of the premises where samples of cannabis flower and cannabinoid products available
57.30 for sale are displayed. All other cannabis flower and cannabinoid products must be stored
57.31 in the secure storage area.

58.1 (b) A cannabis retailer may display one sample of each type of cannabis flower or
58.2 cannabinoid product available for sale. Samples of cannabis flower and cannabinoid products

58.10 (c) A cannabis retailer may not sell cannabis flower or cannabinoid products used as a
58.11 sample for display.

58.12 Subd. 5. **Posting of notices.** A cannabis retailer must post all notices as required by the
58.13 office, including but not limited to:

58.14 (1) information about any product recall;

58.15 (2) a statement that operating a motor vehicle under the influence of intoxicating
58.16 cannabinoids is illegal; and

58.17 (3) a statement that cannabis flower, cannabinoid products, and hemp-derived consumer
58.18 products are only intended for consumption by individuals who are at least 21 years of age.

58.19 Subd. 6. **Hours of operation.** (a) Except as provided by paragraph (b), a cannabis retailer
58.20 may not sell cannabis flower, cannabinoid products, or hemp-derived consumer products

58.24 a.m. on the days of Monday through Saturday, or between 2:00 a.m. and 10:00 a.m. on
58.25 Sunday.

58.26 Subd. 7. **Building conditions.** (a) A cannabis retailer shall maintain compliance with
58.27 state and local building, fire, and zoning requirements or regulations.

58.28 (b) A cannabis retailer shall ensure that the licensed premises is maintained in a clean
58.29 and sanitary condition, free from infestation by insects, rodents, or other pests.

58.30 Subd. 8. **Security.** A cannabis retailer shall maintain compliance with security
58.31 requirements established by the office including but not limited to requirements for
58.32 maintaining video surveillance records, use of specific locking mechanisms, establishment
58.33 of secure entries, and the number of employees working at all times.

59.1 Subd. 9. **Lighting.** A cannabis retailer must keep all lighting outside and inside the
59.2 dispensary in good working order and wattage sufficient for security cameras.

59.3 Subd. 10. **Deliveries.** Cannabis retailers may only accept deliveries of cannabis flower,
59.4 cannabinoid products, and hemp-derived consumer products into a limited access area.
59.5 Deliveries may not be accepted through the public access areas unless otherwise approved
59.6 by the office.

59.7 Subd. 11. **Prohibitions.** A cannabis retailer shall not:

59.8 (1) sell cannabis flower or cannabinoid products to a person who is visibly intoxicated;

59.9 (2) knowingly sell more cannabis flower or cannabinoid products than a customer is
59.10 legally permitted to possess;

59.11 (3) give away immature cannabis plants or seedlings, cannabis flower, cannabinoid
59.12 products, or hemp-derived consumer products;

59.13 (4) operate a drive-through window;

59.14 (5) allow for the dispensing of cannabis plants, cannabis flower, cannabinoid products,
59.15 or hemp-derived consumer products in vending machines; or

59.16 (6) sell cannabis plants, cannabis flower, or cannabinoid products if the cannabis retailer
59.17 knows that any required security or statewide monitoring systems are not operational.

59.18 Subd. 12. **Retail location; physical separation required.** (a) A licensed cannabis retailer
59.19 that is also a licensed medical cannabis retailer may sell medical cannabis flower and medical
59.20 cannabinoid products on a portion of its premises.

59.21 (b) The portion of the premises in which medical cannabis flower and medical
59.22 cannabinoid products are sold must be definite and distinct from all other areas of the
59.23 cannabis retailer, must be accessed through a distinct entrance, and must provide an
59.24 appropriate space for a pharmacist employee of the medical cannabis retailer to consult with
59.25 the patient to determine the proper type of medical cannabis flower and medical cannabinoid
59.26 products and proper dosage for the patient.

59.27 Sec. 27. **[342.28] CANNABIS WHOLESALER LICENSING.**

59.28 Subdivision 1. **Authorized actions.** A cannabis wholesaler license entitles the license
59.29 holder to:

60.1 (1) purchase immature cannabis plants and seedlings, cannabis flower, cannabinoid
 60.2 products, and hemp-derived consumer products from cannabis cultivators, cannabis
 60.3 manufacturers, cannabis microbusinesses, and industrial hemp growers;

60.4 (2) sell immature cannabis plants and seedlings, cannabis flower, cannabinoid products,
 60.5 and hemp-derived consumer products to cannabis manufacturers and cannabis retailers;

60.6 (3) import hemp-derived consumer products and lower potency edible products that
 60.7 contain hemp concentrate or artificially derived cannabinoids that are derived from hemp

60.9 (4) perform other actions approved by the office.

60.10 Subd. 2. **Additional information required.** In addition to the information required to

 60.13 following information in a form approved by the office:

60.30 Subdivision 1. **Separation of products.** A cannabis wholesaler must ensure that cannabis

61.1 products, including hemp-derived consumer products, in a manner that prevents any

61.3 Subd. 2. **Records and labels.** A cannabis wholesaler must maintain accurate records

61.6 Subd. 3. **Building conditions.** (a) A cannabis wholesaler shall maintain compliance

62.1 includes information regarding the cultivation, processing, and testing of the industrial hemp
62.2 used in the manufacture of the product and information regarding the testing of the lower
62.3 potency edible product or hemp-derived consumer product. If information regarding the
62.4 industrial hemp, lower potency edible product, or hemp-derived consumer product was
62.5 submitted to a statewide monitoring system used in another state, the office may require
62.6 submission of any information provided to that statewide monitoring system and shall assist
62.7 in the transfer of data from another state as needed and in compliance with any data
62.8 classification established by either state.

62.9 (d) The office may suspend, revoke, or cancel the endorsement of a distributor who is

62.17 (e) Notwithstanding any law to the contrary, it shall not be a defense in any civil or
62.18 criminal action that a licensed wholesaler relied on information on a product label or
62.19 otherwise provided by a manufacturer who is not licensed in this state.

62.20 **Sec. 29. [342.30] CANNABIS TRANSPORTER LICENSING.**

62.21 Subdivision 1. **Authorized actions.** A cannabis transporter license entitles the license
62.22 holder to transport immature cannabis plants and seedlings, cannabis flower, cannabinoid
62.23 products, artificially derived cannabinoids, hemp plant parts, hemp concentrate, and
62.24 hemp-derived consumer products from cannabis cultivators, cannabis manufacturers, cannabis
62.25 wholesalers, cannabis microbusinesses, medical cannabis retailers, medical cannabis
62.26 processors, and industrial hemp growers to cannabis manufacturers, cannabis testing facilities,
62.27 cannabis wholesalers, cannabis retailers, lower potency edible product retailers, medical
62.28 cannabis processors, and medical cannabis retailers and perform other actions approved by

62.30 Subd. 2. **Additional information required.** In addition to the information required to
62.31 be submitted under section 342.15, subdivision 1, and rules adopted pursuant to that section,
62.32 a person, cooperative, or business seeking a cannabis transporter license must submit the
62.33 following information in a form approved by the office:

63.1 (1) an appropriate surety bond, certificate of insurance, qualifications as a self-insurer,
 63.2 or other securities or agreements, in the amount of not less than \$300,000, for loss of or
 63.3 damage to cargo;

63.4 (2) an appropriate surety bond, certificate of insurance, qualifications as a self-insurer,

66.5 Subdivision 1. **Testing services.** A cannabis testing facility shall provide some or all
66.6 testing services required under section 342.60 and rules adopted pursuant to that section.

66.7 Subd. 2. **Testing protocols.** A cannabis testing facility shall follow all testing protocols,

68.15 Subd. 2. **Extraction and concentration endorsement.** A cannabis microbusiness that
68.16 creates cannabis concentrate must comply with the requirements in section 342.25,

68.18 Subd. 3. **Production of customer products endorsement.** A cannabis microbusiness
68.19 that manufacturers edible cannabinoid products must comply with the requirements in
68.20 section 342.25, subdivisions 1 and 3.

68.21 Subd. 4. **Retail operations endorsement.** A cannabis microbusiness that operates a
68.22 retail location must comply with the requirements in section 342.27.

68.23 Subd. 5. **On-site consumption endorsement.** (a) A cannabis microbusiness may permit
68.24 on-site consumption of edible cannabinoid products on a portion of its premises.

68.25 (b) The portion of the premises in which on-site consumption is permitted must be
68.26 definite and distinct from all other areas of the microbusiness and must be accessed through
68.27 a distinct entrance.

68.28 (c) Edible cannabinoid products sold for on-site consumption must comply with this
68.29 chapter and rules adopted pursuant to this chapter regarding the testing, packaging, and
68.30 labeling of cannabinoid products.

69.1 (d) Edible cannabinoid products sold for on-site consumption must be served in the
69.2 required packaging, but may be removed from the products' packaging by customers and
69.3 consumed on site.

69.4 (e) Food and beverages not otherwise prohibited by this subdivision may be prepared
69.5 and sold on site provided that the cannabis microbusiness complies with all relevant state
69.6 and local laws, ordinances, licensing requirements, and zoning requirements.

69.7 (f) A cannabis microbusiness shall ensure that the display and consumption of any edible
69.8 cannabinoid product is not visible from outside of the licensed premises of the business.

69.9 (g) A cannabis microbusiness may offer recorded or live entertainment provided that
69.10 the cannabis microbusiness complies with all relevant state and local laws, ordinances,
69.11 licensing requirements, and zoning requirements.

69.12 (h) A cannabis microbusiness may not:

69.13 (1) sell edible cannabinoid products to an individual who is under 21 years of age;

69.26 (9) distribute or allow free samples of adult-use cannabis flower, adult-use cannabinoid

69.29 Subdivision 1. **Authorized actions.** A cannabis event organizer license entitles the

70.21 (b) A person, cooperative, or business seeking a cannabis event organizer license may
70.22 also disclose whether the person or any officer, director, manager, and general partner of a
70.23 cannabis business is serving or has previously served in the military.

70.24 Subd. 3. **Multiple licenses; limits.** (a) A person, cooperative, or business holding a
70.25 cannabis event organizer license may not hold a cannabis testing facility license.

70.26 (b) The office by rule may limit the number of cannabis event licenses that a person or
70.27 business may hold.

70.28 (c) For purposes of this subdivision, restrictions on the number or type of license that a
70.29 business may hold apply to every cooperative member or every director, manager, and
70.30 general partner of a cannabis business.

71.2 **Subdivision 1. Local approval.** A cannabis event organizer must receive local approval,

73.23 (b) Access to areas where consumption of adult-use cannabis flower or adult-use
 73.24 cannabinoid products is allowed shall be restricted to individuals who are at least 21 years

73.26 (c) The cannabis event organizer shall ensure that consumption of adult-use cannabis
 73.27 flower or adult-use cannabinoid products within a designated consumption area is not visible
 73.28 from any public place.

73.29 (d) The cannabis event organizer shall not permit consumption of alcohol or tobacco.

73.30 Sec. 37. **[342.38] CANNABIS DELIVERY SERVICE LICENSING.**

73.31 Subdivision 1. **Authorized actions.** A cannabis delivery service license entitles the
 73.32 license holder to purchase cannabis flower, cannabinoid products, and hemp-derived

74.1 consumer products from licensed cannabis retailers, licensed cannabis microbusinesses with
 74.2 an endorsement to sell adult-use cannabis flower and adult-use cannabinoid products to
 74.3 customers, and medical cannabis retailers; transport and deliver cannabis flower, cannabinoid
 74.4 products, and hemp-derived consumable products to customers; and perform other actions
 74.5 approved by the office.

74.6 Subd. 2. **Additional information required.** In addition to the information required to

 74.9 the following information in a form approved by the office:

75.2 Subdivision 1. Age or registry verification. Prior to completing a delivery, a cannabis
75.3 delivery service shall verify that the customer is at least 21 years of age or is enrolled in the
75.4 registry program. Section 342.27, subdivision 3, applies to the verification of a customer's
75.5 age. Registry verification issued by the Division of Medical Cannabis may be considered
75.6 evidence that the person is enrolled in the registry program.

75.7 Subd. 2. Records. The office by rule shall establish record-keeping requirements for a

76.6 entitles the license holder to:

76.7 (1) purchase lower potency edible products from cannabis manufacturers, cannabis
76.8 wholesalers, and cannabis microbusinesses;

76.9 (2) sell lower potency edible products to customers; and

76.10 (3) perform other actions approved by the office.

76.11 Subd. 2. **Licensing exceptions; requirements.** (a) Except as otherwise provided in this
76.12 subdivision, the provisions of this chapter relating to license applications, license selection
76.13 criteria, general ownership disqualifications and requirements, and general operational
76.14 requirements do not apply to a lower potency edible product license or licensee.

76.15 (b) A license applicant or, in the case of a business entity, every cooperative member
76.16 or director, manager and general partner of the business entity must submit a completed
76.17 criminal history records check consent form, a full set of classifiable fingerprints, and the
76.18 required fees to the office. Upon receipt of this information, the office must submit the

77.8 Subd. 3. **Multiple licenses; limits.** (a) A person, cooperative, or business holding a
 77.9 lower potency edible product license may not own, operate, or be employed by any other
 77.10 cannabis business.

77.11 (b) A person, cooperative, or business holding a lower potency edible product license
 77.12 may hold an off-sale or on-sale license for the sale of 3.2 percent malt liquor, an on-sale
 77.13 intoxicating liquor license, an off-sale intoxicating liquor license, or a combination off-sale
 77.14 and on-sale intoxicating liquor license.

77.15 Sec. 40. **[342.41] LOWER POTENCY EDIBLE PRODUCT RETAILER**
 77.16 **OPERATIONS.**

77.17 Subdivision 1. **Sale of lower potency edible products.** (a) A lower potency edible
 77.18 product retailer may only sell lower potency edible products to individuals who are at least
 77.19 21 years of age.

77.20 (b) A lower potency edible product retailer may sell lower potency edible products that:

77.21 (1) are obtained from a licensed Minnesota cannabis manufacturer, cannabis
 77.22 microbusiness, or cannabis wholesaler; and

77.23 (2) meet all applicable packaging and labeling requirements.

77.24 Subd. 2. **Sale of other products.** A lower potency edible product retailer may sell other
 77.25 products or items for which the cannabis wholesaler has a license or authorization or that
 77.26 do not require a license or authorization.

77.27 Subd. 3. **Age verification.** Prior to initiating a sale, an employee of the lower potency
 77.28 edible product retailer must verify that the customer is at least 21 years of age. Section
 77.29 342.27, subdivision 3, applies to the verification of a customer's age.

77.30 Subd. 4. **Display and storage of lower potency edible products.** A lower potency
 77.31 edible product retailer shall ensure that all lower potency edible products are displayed

78.1 behind a checkout counter where the public is not permitted. All lower potency edible
78.2 products that are not displayed must be stored in a secure area.

78.3 Subd. 5. **Compliant products.** A lower potency edible product retailer shall ensure that
78.4 all lower potency edible products offered for sale comply with the limits on the amount and
78.5 types of cannabinoids that a lower potency edible product can contain, including but not
78.6 limited to the requirement that lower potency edible products:

78.20 (b) lower potency edible products sold for on-site consumption must comply with this
78.21 chapter and rules adopted pursuant to this chapter regarding the testing, packaging, and
78.22 labeling of cannabinoid products.

78.23 (c) lower potency edible products sold for on-site consumption must be served in the
78.24 required packaging, but may be removed from the products' packaging by customers and
78.25 consumed on site.

78.26 (d) Food and beverages not otherwise prohibited by this subdivision may be prepared
78.27 and sold on site provided that the lower potency edible product retailer complies with all
78.28 relevant state and local laws, ordinances, licensing requirements, and zoning requirements.

78.29 (e) A lower potency edible product retailer may offer recorded or live entertainment
78.30 provided that the lower potency edible product retailer complies with all relevant state and
78.31 local laws, ordinances, licensing requirements, and zoning requirements.

78.32 (f) A lower potency edible product retailer may not:

79.1 (1) sell lower potency edible products to an individual who is under 21 years of age;

79.2 (2) sell lower potency edible products to a customer who the lower potency edible product
 79.3 retailer knows or reasonably should know has consumed alcohol sold or provided by the
 79.4 lower potency edible product retailer within the previous five hours;

79.5 (3) sell a lower potency edible product to a person who is visibly intoxicated;

79.6 (4) sell cannabis flower, hemp-derived consumer products, or any cannabinoid product
 79.7 other than lower potency edible products that are intended to be consumed as a beverage;

79.8 (5) permit lower potency edible products that have been removed from the products'
 79.9 packaging to be removed from the premises of the lower potency edible product retailer;

79.10 (6) allow for the dispensing of lower potency edible products in vending machines;

79.14 Subd. 7. **Statewide monitoring system.** (a) A lower potency edible product retailer
 79.15 shall record all lower potency edible products it receives in the statewide monitoring system.

79.16 (b) A lower potency edible product retailer shall record all lower potency edible products
 79.17 sold, damaged, or destroyed in the statewide monitoring system.

79.18 Subd. 8. **Posting of notices.** A lower potency edible product retailer must post all notices
 79.19 as provided in section 342.27, subdivision 5.

79.20 Subd. 9. **Building conditions.** (a) A lower potency edible product retailer shall maintain
 79.21 compliance with state and local building, fire, and zoning requirements or regulations.

79.22 (b) A lower potency edible product retailer shall ensure that the licensed premises is
 79.23 maintained in a clean and sanitary condition, free from infestation by insects, rodents, or
 79.24 other pests.

79.25 Subd. 10. **Enforcement.** The office shall inspect lower potency cannabinoid product
 79.26 retailers and take enforcement action as provided in sections 342.18 and 342.19.

79.27 Sec. 41. **[342.42] MEDICAL CANNABIS BUSINESS LICENSES.**

79.28 Subdivision 1. **License types.** (a) The office shall issue the following types of medical
 79.29 cannabis business licenses:

79.30 (1) medical cannabis cultivator;

80.1 (2) medical cannabis processor; and

80.2 (3) medical cannabis retailer.

80.3 (b) The Division of Medical Cannabis may oversee the licensing and regulation of
80.4 medical cannabis businesses.

80.5 Subd. 2. **Multiple licenses; limits.** (a) A person, cooperative, or business holding:

80.6 (1) a medical cannabis cultivator license may also hold a medical cannabis processor
80.7 license, a cannabis cultivator license, a cannabis manufacturer license, and a cannabis event
80.8 organizer license subject to the ownership limitations that apply to those licenses;

80.9 (2) a medical cannabis processor license may also hold a medical cannabis cultivator
80.10 license, a cannabis cultivator license, a cannabis manufacturer license, and a cannabis event
80.11 organizer license subject to the ownership limitations that apply to those licenses; or

80.12 (3) a medical cannabis retailer license may also hold a cannabis retailer license, a cannabis
80.13 delivery service license, and a cannabis event organizer license subject to the ownership

80.15 (b) Except as provided in paragraph (a), no person, cooperative, or business holding a
80.16 medical cannabis license may own or operate any other cannabis business.

80.17 (c) The office by rule may limit the number of medical cannabis business licenses that
80.18 a person or business may hold.

80.19 (d) For purposes of this subdivision, a restriction on the number of licenses or type of
80.20 license that a business may hold applies to every cooperative member or every director,
80.21 manager, and general partner of a medical cannabis business.

80.22 Subd. 3. **Registered medical cannabis manufacturers.** (a) As used in this subdivision,
80.23 "medical cannabis manufacturer" means either of the two in-state manufacturers of medical
80.24 cannabis registered with the commissioner of health pursuant to section 152.25 as of July
80.25 1, 2023.

80.26 (b) Notwithstanding any law to the contrary, the registration or reregistration period of
80.27 a medical cannabis manufacturer expires on July 1, 2024.

80.28 Subd. 4. **Limitations on health care practitioners.** A health care practitioner who
80.29 certifies qualifying medical conditions for patients is prohibited from:

80.30 (1) holding a direct or indirect economic interest in a medical cannabis business;

81.4 Subd. 5. **Remuneration.** A medical cannabis business is prohibited from:

81.8 medical conditions for patients.

81.10 Sec. 42. **[342.43] MEDICAL CANNABIS BUSINESS APPLICATIONS.**

81.11 Subdivision 1. **Information required.** In addition to information required to be submitted
81.12 under section 342.15, subdivision 1, and rules adopted pursuant to that section, a person,
81.13 cooperative, or business seeking a medical cannabis business license must submit the
81.14 following information in a form approved by the office:

81.15 (1) for medical cannabis cultivator license applicants:

81.18 electricity, water, and other utilities necessary for the normal operation of the cultivation

81.21 (ii) a cultivation plan demonstrating the proposed size and layout of the cultivation
81.22 facility that will be used exclusively for cultivation for medical cannabis, including the total

81.24 (iii) evidence that the business will comply with the applicable operation requirements
81.25 for the license being sought;

81.26 (2) for medical cannabis processor license applicants:

81.27 (i) an operating plan demonstrating the proposed layout of the facility, including a
81.28 diagram of ventilation and filtration systems; plans for wastewater and waste disposal for
81.29 the manufacturing facility; plans for providing electricity, water, and other utilities necessary
81.30 for the normal operation of the manufacturing facility; and plans for compliance with

82.1 applicable building code and federal and state environmental and workplace safety
 82.2 requirements;

82.3 (ii) all methods of extraction and concentration that the applicant intends to use and the
 82.4 volatile chemicals, if any, that are involved in extraction or concentration;

82.5 (iii) if the applicant is seeking an endorsement to manufacture products infused with
 82.6 cannabinoids for consumption by patients enrolled in the registry program, proof of an
 82.7 edible cannabinoid product handler endorsement from the office; and

 82.22 from all other areas of the cannabis retailer, accessed through a distinct entrance, and contains
 82.23 an appropriate space for a pharmacist employee of the medical cannabis retailer to consult
 82.24 with the patient to determine the proper type of medical cannabis flower and medical
 82.25 cannabinoid products and proper dosage for the patient; and

82.26 (iv) evidence that the applicant will comply with the applicable operation requirements

82.28 Subd. 2. Segregation of medical cannabis. A person, cooperative, or business seeking

83.1 Sec. 43. **[342.44] MEDICAL CANNABIS CULTIVATORS.**

83.2 (a) A medical cannabis cultivator license entitles the license holder to grow cannabis
83.3 plants within the approved amount of space from seed or immature plant to mature plant,
83.4 harvest cannabis flower from a mature plant, package and label cannabis flower as medical
83.5 cannabis flower, sell medical cannabis flower to medical cannabis processors and medical
83.6 cannabis retailers, transport medical cannabis flower to a medical cannabis processor located
83.7 on the same premises, and perform other actions approved by the office.

83.8 (b) A medical cannabis cultivator license holder must comply with all requirements of
83.9 section 342.23.

83.10 (c) A medical cannabis cultivator license holder must verify that every batch of medical
83.11 cannabis flower has passed safety, potency, and consistency testing at a cannabis testing
83.12 facility approved by the office for the testing of medical cannabis flower before the medical
83.13 cannabis cultivator may package, label, or sell the medical cannabis flower to any other
83.14 entity.

83.15 **EFFECTIVE DATE.** This section is effective January 1, 2024.

83.16 Sec. 44. **[342.45] MEDICAL CANNABIS PROCESSORS.**

83.17 (a) A medical cannabis processor license, consistent with the specific license endorsement
83.18 or endorsements, entitles the license holder to:

83.19 (1) purchase medical cannabis flower, medical cannabinoid products, hemp plant parts,
83.20 and hemp concentrate from medical cannabis cultivators, other medical cannabis processors,
83.21 and industrial hemp growers;

83.22 (2) make cannabis concentrate from medical cannabis flower;

83.23 (3) make hemp concentrate, including hemp concentrate with a delta-9
83.24 tetrahydrocannabinol concentration of more than 0.3 percent as measured by weight;

83.25 (4) manufacture medical cannabinoid products;

83.26 (5) package and label medical cannabinoid products for sale to other medical cannabis
83.27 processors and to medical cannabis retailers; and

83.28 (6) perform other actions approved by the office.

83.29 (b) A medical cannabis cultivator license holder must comply with all requirements of
83.30 section 342.23, including requirements to obtain specific license endorsements.

84.1 (c) A medical cannabis processor license holder must verify that every batch of medical
84.2 cannabinoid product has passed safety, potency, and consistency testing at a cannabis testing
84.3 facility approved by the office for the testing of medical cannabinoid products before the
84.4 medical cannabis processor may package, label, or sell the medical cannabinoid product to
84.5 any other entity.

84.6 **EFFECTIVE DATE.** This section is effective January 1, 2024.

84.7 Sec. 45. **[342.46] MEDICAL CANNABIS RETAILERS.**

84.8 Subdivision 1. **Authorized actions.** (a) A medical cannabis retailer license entitles the
84.9 license holder to purchase medical cannabis flower and medical cannabinoid products from
84.10 medical cannabis cultivators and medical cannabis processors and sell or distribute medical
84.11 cannabis flower and medical cannabinoid products to any person authorized to receive
84.12 distribution.

84.13 (b) A medical cannabis retailer license holder must verify that all medical cannabis
84.14 flower and medical cannabinoid products have passed safety, potency, and consistency
84.15 testing at a cannabis testing facility approved by the office for the testing of medical cannabis
84.16 flower and medical cannabinoid products before the medical cannabis retailer may distribute
84.17 the medical cannabis flower or medical cannabis product to any person authorized to receive
84.18 distribution.

84.19 Subd. 2. **Distribution requirements.** (a) Prior to distribution of medical cannabis flower
84.20 or medical cannabinoid products, a medical cannabis retailer licensee must:

84.21 (1) review and confirm the patient's registry verification;

84.22 (2) verify that the person requesting the distribution of medical cannabis flower or
84.23 medical cannabinoid products is the patient, the patient's registered designated caregiver,
84.24 or the patient's parent, legal guardian, or spouse using the procedures specified in section
84.25 152.11, subdivision 2d;

84.26 (3) ensure that a pharmacist employee of the medical cannabis retailer has consulted
84.27 with the patient if required according to subdivision 3; and

84.28 (4) apply a patient-specific label on the medical cannabis flower or medical cannabinoid
84.29 product that includes recommended dosage requirements and other information as required
84.30 by rules adopted by the office.

84.31 (b) A medical cannabis retailer may not deliver medical cannabis flower or medical
84.32 cannabinoid products unless the medical cannabis retailer also holds a cannabis delivery

85.1 service license. Delivery of medical cannabis flower and medical cannabinoid products are
85.2 subject to the provisions of section 342.39.

85.3 Subd. 3. **Final approval for distribution of medical cannabis flower and medical**
85.4 **cannabinoid products.** (a) A cannabis worker who is employed by a medical cannabis
85.5 retailer and who is licensed as a pharmacist pursuant to chapter 151 shall be the only person
85.6 who may give final approval for the distribution of medical cannabis flower and medical
85.7 cannabinoid products. Prior to the distribution of medical cannabis flower or medical
85.8 cannabinoid products, a pharmacist employed by the medical cannabis retailer must consult
85.9 with the patient to determine the proper type of medical cannabis flower, medical cannabinoid

85.29 Subd. 5. **Distribution to recipient in a motor vehicle.** A medical cannabis retailer may

86.9 guardian, or spouse has arrived in the designated zone;

86.10 (4) the payment and distribution of medical cannabis flower and medical cannabinoid
86.11 products take place only after a pharmacist consultation takes place, if required under

86.13 (5) immediately following distribution of medical cannabis flower or medical cannabinoid
86.14 products, staff enter the transaction in the statewide monitoring system; and

86.17 Subd. 6. **Physical separation required.** A medical cannabis retailer that is also a cannabis
86.18 retailer must distribute medical cannabis flower and medical cannabinoid products provided
86.19 that the portion of the premises in which medical cannabis flower and medical cannabinoid
86.20 products are sold is definite and distinct from all other areas of the cannabis retailer, is
86.21 accessed through a distinct entrance, and provides an appropriate space for a pharmacist
86.22 employee of the medical cannabis retailer to consult with the patient to determine the proper
86.23 type of medical cannabis flower and medical cannabinoid products and proper dosage for
86.24 the patient.

86.25 **EFFECTIVE DATE.** This section is effective January 1, 2024.

86.26 Sec. 46. **[342.47] PATIENT REGISTRY PROGRAM.**

86.27 Subdivision 1. **Administration.** The Division of Medical Cannabis must administer the
86.28 medical cannabis registry program.

86.29 Subd. 2. **Application procedure for patients.** (a) A patient seeking to enroll in the
86.30 registry program must submit to the Division of Medical Cannabis an application established
86.31 by the Division of Medical Cannabis and a copy of the certification specified in paragraph
86.32 (b) or, if the patient is a veteran who receives care from the United States Department of

87.1 Veterans Affairs, the information required pursuant to subdivision 3. The patient must
87.2 provide at least the following information in the application:

87.3 (1) the patient's name, mailing address, and date of birth;

87.4 (2) the name, mailing address, and telephone number of the patient's health care
87.5 practitioner;

87.6 (3) the name, mailing address, and date of birth of the patient's registered designated
87.7 caregiver, if any, or the patient's parent, legal guardian, or spouse if the parent, legal guardian,
87.8 or spouse will be acting as the patient's caregiver;

87.9 (4) a disclosure signed by the patient that includes:

87.10 (i) a statement that, notwithstanding any law to the contrary, the Office of Cannabis
87.11 Management, the Division of Medical Cannabis, or an employee of the Office of Cannabis
87.12 Management or Division of Medical Cannabis may not be held civilly or criminally liable
87.13 for any injury, loss of property, personal injury, or death caused by an act or omission while
87.14 acting within the employee's scope of office or employment under this section; and

87.15 (ii) the patient's acknowledgment that enrollment in the registry program is conditional
87.16 on the patient's agreement to meet all other requirements of this section; and

87.17 (5) all other information required by the Division of Medical Cannabis.

87.18 (b) As part of the application under this subdivision, a patient must submit a copy of a
87.19 certification from the patient's health care practitioner that is dated within 90 days prior to
87.20 the submission of the application and that certifies that the patient has been diagnosed with
87.21 a qualifying medical condition.

87.22 (c) A patient's health care practitioner may submit a statement to the Division of Medical
87.23 Cannabis declaring that the patient is no longer diagnosed with a qualifying medical
87.24 condition. Within 30 days after receipt of a statement from a patient's health care practitioner,
87.25 the Division of Medical Cannabis must provide written notice to a patient stating that the
87.26 patient's enrollment in the registry program will be revoked in 30 days unless the patient
87.27 submits a certification from a health care practitioner that the patient is currently diagnosed
87.28 with a qualifying medical condition or, if the patient is a veteran, the patient submits
87.29 confirmation that the patient is currently diagnosed with a qualifying medical condition in

87.32 registry program pursuant to this paragraph, the division must provide notice to the patient
87.33 and to the patient's health care practitioner.

88.1 Subd. 3. **Application procedure for veterans.** (a) The Division of Medical Cannabis
88.2 shall establish an alternative certification procedure for veterans who receive care from the
88.3 United States Department of Veterans Affairs to confirm that the veteran has been diagnosed
88.4 with a qualifying medical condition.

88.5 (b) A patient who is also a veteran and is seeking to enroll in the registry program must
88.6 submit to the Division of Medical Cannabis an application established by the Division of
88.7 Medical Cannabis that includes the information identified in subdivision 2, paragraph (a),
88.8 and the additional information required by the Division of Medical Cannabis to certify that
88.9 the patient has been diagnosed with a qualifying medical condition.

88.10 Subd. 4. **Enrollment; denial of enrollment; revocation.** (a) Within 30 days after the
88.11 receipt of an application and certification or other documentation of a diagnosis with a
88.12 qualifying medical condition, the Division of Medical Cannabis must approve or deny a
88.13 patient's enrollment in the registry program. If the Division of Medical Cannabis approves
88.14 a patient's enrollment in the registry program, the office must provide notice to the patient
88.15 and to the patient's health care practitioner.

88.16 (b) A patient's enrollment in the registry program must only be denied if the patient:

88.17 (1) does not submit a certification from a health care practitioner or, if the patient is a
88.18 veteran, the documentation required under subdivision 3 that the patient has been diagnosed
88.19 with a qualifying medical condition;

88.20 (2) has not signed the disclosure required in subdivision 2;

88.21 (3) does not provide the information required by the Division of Medical Cannabis;

88.22 (4) provided false information on the application; or

88.23 (5) at the time of application, is also enrolled in a federally approved clinical trial for
88.24 the treatment of a qualifying medical condition with medical cannabis.

88.25 (c) If the Division of Medical Cannabis denies a patient's enrollment in the registry
88.26 program, the Division of Medical Cannabis must provide written notice to a patient of all
88.27 reasons for denying enrollment. Denial of enrollment in the registry program is considered
88.28 a final decision of the office and is subject to judicial review under chapter 14.

88.29 (d) A patient's enrollment in the registry program may be revoked only:

88.30 (1) pursuant to subdivision 2, paragraph (c);

88.31 (2) upon the death of the patient;

89.1 (3) if the patient's certifying health care practitioner has filed a declaration under
89.2 subdivision 2, paragraph (c), that the patient's qualifying diagnosis no longer exists and the
89.3 patient does not submit another certification within 30 days;

89.4 (4) if the patient does not comply with subdivision 6; or

89.5 (5) if the patient intentionally sells or diverts medical cannabis flower or medical
89.6 cannabinoid products in violation of this chapter.

89.7 If a patient's enrollment in the registry program has been revoked due to a violation of
89.8 subdivision 6, the patient may apply for enrollment 12 months after the date on which the
89.9 patient's enrollment was revoked. The office must process such an application in accordance
89.10 with this subdivision.

89.11 Subd. 5. **Registry verification.** When a patient is enrolled in the registry program, the
89.12 Division of Medical Cannabis must assign the patient a patient registry number and must
89.13 issue the patient and the patient's registered designated caregiver, parent, legal guardian, or
89.14 spouse, if applicable, a registry verification. The Division of Medical Cannabis must also
89.15 make the registry verification available to medical cannabis retailers. The registry verification
89.16 must include:

89.17 (1) the patient's name and date of birth;

89.18 (2) the patient registry number assigned to the patient; and

89.26 (2) report changes in the patient's qualifying medical condition to the patient's health
89.27 care practitioner.

89.28 Subd. 7. **Enrollment period.** Enrollment in the registry program is valid for one year.
89.29 To re-enroll, a patient must submit the information required in subdivision 2 and a patient
89.30 who is also a veteran must submit the information required in subdivision 3.

90.1 Subd. 8. **Medical cannabis flower and medical cannabinoid products; allowable**
90.2 **delivery methods.** Medical cannabis flower and medical cannabinoid products may be
90.3 delivered in the form of:

- 90.4 (1) a liquid, including but not limited to oil;
90.5 (2) a pill;
90.6 (3) a vaporized delivery method with the use of liquid or oil;
90.7 (4) combustion with the use of dried raw cannabis; or
90.8 (5) any other method approved by the commissioner.

90.9 Subd. 9. **Registered designated caregiver.** (a) The Division of Medical Cannabis must
90.10 register a designated caregiver for a patient if the patient requires assistance in administering
90.11 medical cannabis flower or medical cannabinoid products or in obtaining medical cannabis
90.12 flower, medical cannabinoid products, or medical cannabis paraphernalia from a medical
90.13 cannabis retailer.

90.14 (b) In order to serve as a designated caregiver, a person must:

- 90.15 (1) be at least 18 years of age;
90.16 (2) agree to only possess the patient's medical cannabis flower and medical cannabinoid
90.17 products for purposes of assisting the patient; and
90.18 (3) agree that if the application is approved, the person will not serve as a registered
90.19 designated caregiver for more than six registered patients at one time. Patients who reside
90.20 in the same residence count as one patient.

90.21 (c) The office shall conduct a criminal background check on the designated caregiver
90.22 prior to registration to ensure that the person does not have a conviction for a disqualifying
90.23 felony offense. Any cost of the background check shall be paid by the person seeking

90.29 Subd. 10. **Parents, legal guardians, spouses.** A parent, legal guardian, or spouse of a
90.30 patient may act as the caregiver for a patient. The parent, legal guardian, or spouse who is
90.31 acting as a caregiver must follow all requirements for parents, legal guardians, and spouses

91.1 under this chapter. Nothing in this section limits any legal authority that a parent, legal
 91.2 guardian, or spouse may have for the patient under any other law.

92.3 Subdivision 1. Duties related to health care practitioners. The Division of Medical

92.5 (1) provide notice of the registry program to health care practitioners in the state;

92.6 (2) allow health care practitioners to participate in the registry program if they request
 92.7 to participate and meet the program's requirements;

92.8 (3) provide explanatory information and assistance to health care practitioners to

 92.10 requirements;

92.11 (4) make available to participating health care practitioners a certification form in which

 99.22 flower or medical cannabinoid products, or who issues certifications while holding a financial

99.28 Subdivision 1. **Data classification.** Patient health records maintained by the Office of
 99.29 Cannabis Management or the Division of Medical Cannabis and government data in patient
 99.30 health records maintained by a health care practitioner are classified as private data on
 99.31 individuals, as defined in section 13.02, subdivision 12, or nonpublic data, as defined in
 99.32 section 13.02, subdivision 9.

100.1 Subd. 2. Allowable use; prohibited use. Data specified in subdivision 1 may be used
100.2 to comply with chapter 13, to comply with a request from the legislative auditor or the state
100.3 auditor in the performance of official duties, and for purposes specified in sections 342.42
100.4 to 342.56. Data specified in subdivision 1 and maintained by the Office of Cannabis
100.5 Management or Division of Medical Cannabis must not be used for any purpose not specified

101.31 (b) A cannabis cultivator, cannabis manufacturer, cannabis wholesaler with an
101.32 endorsement to import products, cannabis microbusiness, or medical cannabis business
101.33 must disclose all known information regarding pesticides, fertilizers, solvents, or other
101.34 foreign materials, including but not limited to catalysts used in creating artificially derived

102.1 cannabinoids, applied or added to the batch of cannabis flower, cannabinoid products,
102.2 artificially derived cannabinoids, or hemp-derived consumer products subject to testing.
102.3 Disclosure must be made to the cannabis testing facility and must include information about
102.4 all applications by any person, whether intentional or accidental.

102.5 (c) The cannabis testing facility shall select one or more representative samples from
102.6 each batch, test the samples for the presence of contaminants, and test the samples for
102.7 potency and homogeneity and to allow the cannabis flower, cannabinoid product, artificially

103.9 consumer products sold to customers or patients must be packaged as required by this section
103.10 and rules adopted under this chapter.

103.11 Subd. 2. Packaging requirements. (a) Except as provided in paragraph (b), all cannabis
103.12 flower, cannabinoid products, and hemp-derived consumer products sold to customers or
103.13 patients must be:

103.14 (1) prepackaged in packaging or a container that is plain, child-resistant, tamper-evident,
103.15 and opaque; or

104.18 Subd. 2. **Content of label; cannabis.** All cannabis flower and hemp-derived consumer
104.19 products that consist of hemp plant parts sold to customers or patients must have affixed
104.20 on the packaging or container of the cannabis flower or hemp-derived consumer product a
104.21 label that contains at least the following information:

104.22 (1) the name and license number of the cannabis cultivator, cannabis microbusiness,

107.31 Subdivision 1. **Limitations applicable to all advertisements.** No cannabis business or
107.32 other person shall publish or cause to be published an advertisement for cannabis flower, a

108.1 cannabis business, a cannabinoid product, or a hemp-derived consumer product in a manner
108.2 that:

108.3 (1) contains false or misleading statements;

108.4 (2) contains unverified claims about the health or therapeutic benefits or effects of
108.5 consuming cannabis or a cannabis product;

108.6 (3) promotes the overconsumption of cannabis flower, cannabinoid products, or
108.7 hemp-derived consumer products;

108.8 (4) depicts a person under 21 years of age consuming cannabis flower, cannabinoid
108.9 products, or hemp-derived consumer products; or

108.10 (5) includes an image designed or likely to appeal to individuals under 21 years of age,
108.11 including cartoons, toys, animals, or children, or any other likeness to images, characters,

110.2 Nothing in this chapter shall limit the ability of a person licensed under chapter 18K to
110.3 grow industrial hemp for commercial or research purposes, process industrial hemp for
110.4 commercial purposes, sell hemp fiber products and hemp grain, manufacture hemp-derived
110.5 topical products, or perform any other actions authorized by the commissioner of agriculture.
110.6 For purposes of this section, "processing" has the meaning given in section 18K.02,
110.7 subdivision 5, and does not include the process of creating artificially derived cannabinoids.

110.8 Sec. 60. **[342.69] HEMP-DERIVED TOPICAL PRODUCTS.**

110.9 Subdivision 1. **Scope.** This section applies to the manufacture, marketing, distribution,
110.10 and sale of hemp-derived topical products.

110.11 Subd. 2. **Approved cannabinoids.** (a) Products manufactured, marketed, distributed,
110.12 and sold under this section may contain cannabidiol. Except as provided in paragraph (c),

110.17 (c) A product manufactured, marketed, distributed, and sold under this section may
110.18 contain cannabinoids other than cannabidiol or any other cannabinoid approved by the

110.20 hemp plant parts and the total of all other cannabinoids present in a product does not exceed
110.21 one milligram per package.

110.22 Subd. 3. **Approved products.** Products sold to consumers under this section may only
110.23 be manufactured, marketed, distributed, intended, or generally expected to be used by
110.24 applying the product externally to a part of the body of a human or animal.

110.25 Subd. 4. **Prohibitions.** (a) A product sold to consumers under this section must not be

111.6 (2) have been produced, prepared, packed, or held under unsanitary conditions where
111.7 the product may have been rendered injurious to health, or where the product may have
111.8 been contaminated with filth;

111.9 (3) be packaged in a container that is composed, in whole or in part, of any poisonous
111.10 or deleterious substance that may render the contents injurious to health;

111.11 (4) contain any additives or excipients that have been found by the United States Food
111.12 and Drug Administration to be unsafe for human or animal consumption;

111.13 (5) contain a cannabinoid or an amount or percentage of cannabinoids that is different
111.14 than the information stated on the label;

111.15 (6) contain a cannabinoid, other than cannabidiol, cannabigerol, or a cannabinoid

111.22 Subd. 5. **Enforcement.** The office may enforce this section under the relevant provisions

111.24 Sec. 61. **[342.71] CANNABIS INDUSTRY COMMUNITY RENEWAL GRANTS.**

111.25 Subdivision 1. **Establishment.** The Office of Cannabis Management shall establish
111.26 CanRenew, a program to award grants to eligible organizations for investments in
111.27 communities where long-term residents are eligible to be social equity applicants.

111.28 Subd. 2. **Definitions.** (a) For the purposes of this section, the following terms have the
111.29 meanings given.

112.1 (b) "Community investment" means a project or program designed to improve
112.2 community-wide outcomes or experiences and may include efforts targeting economic
112.3 development, violence prevention, youth development, or civil legal aid, among others.

112.4 (c) "Eligible community" means a community where long-term residents are eligible to
112.5 be social equity applicants.

112.6 (d) "Eligible organization" means any organization able to make an investment in a
112.7 community where long-term residents are eligible to be social equity applicants and may
112.8 include educational institutions, nonprofit organizations, private businesses, community
112.9 groups, units of local government, or partnerships between different types of organizations.

112.10 (e) "Program" means the CanRenew grant program.

112.11 (f) "Social equity applicant" means a person who meets the qualification requirements
112.12 in section 342.16.

112.13 **Subd. 3. Grants to organizations.** (a) The office must award grants to eligible
112.14 organizations through a competitive grant process.

112.15 (b) To receive grant money, an eligible organization must submit a written application
112.16 to the office, using a form developed by the office, explaining the community investment
112.17 the organization wants to make in an eligible community.

112.18 (c) An eligible organization's grant application must also include:

112.19 (1) an analysis of the community's need for the proposed investment;

112.20 (2) a description of the positive impact that the proposed investment is expected to
112.21 generate for that community;

112.22 (3) any evidence of the organization's ability to successfully achieve that positive impact;

112.23 (4) any evidence of the organization's past success in making similar community
112.24 investments;

112.25 (5) an estimate of the cost of the proposed investment;

112.26 (6) the sources and amounts of any nonstate funds or in-kind contributions that will
112.27 supplement grant money; and

112.28 (7) any additional information requested by the office.

112.29 (d) In awarding grants under this subdivision, the office shall give weight to applications
112.30 from organizations that demonstrate a history of successful community investments,
112.31 particularly in geographic areas that are now eligible communities. The office shall also

113.1 give weight to applications where there is demonstrated community support for the proposed
113.2 investment. The office shall fund investments in eligible communities throughout the state.

113.3 Subd. 4. **Program outreach.** The office shall make extensive efforts to publicize these
113.4 grants, including through partnerships with community organizations, particularly those
113.5 located in eligible communities.

113.6 Subd. 5. **Reports to the legislature.** By January 15, 2024, and each January 15 thereafter,
113.7 the office must submit a report to the chairs and ranking minority members of the committees

113.10 money, including any measures of successful community impact from the grants.
