provided in section 15.0575.

It is hereby declared that for the benefit of the people of the state, the increase of their commerce, welfare and prosperity and the improvement of their health and living conditions it is essential that <u>health care organizations within the state be provided with appropriate</u>

2.29 additional means to establish, acquire, construct, improve, and expand health care facilities

2.30 <u>in furtherance of their purposes; that this and future generations of youth be given the fullest</u>

"Project" means a structure or structures available for use as a dormitory 3.26 or other student housing facility, a dining hall, student union, administration building, 3.27 academic building, library, laboratory, research facility, classroom, athletic facility, health 3.28 care facility, child care facility, and maintenance, storage, or utility facility and other 3.29 structures or facilities related thereto or required or useful for the instruction of students or 3.30 the conducting of research or the operation of an institution of higher education, whether 3.31 proposed, under construction, or completed, including parking and other facilities or 3.32 structures essential or convenient for the orderly conduct of such institution for higher 3.33

3.34 education, and shall also include landscaping, site preparation, furniture, equipment and

machinery, and other similar items necessary or convenient for the operation of a particular 4.1 facility or structure in the manner for which its use is intended but shall not include such 4.2 items as books, fuel, supplies, or other items the costs of which are customarily deemed to 4.3 result in a current operating charge, and shall a health care facility or an education facility 4.4 whether proposed, under construction, or completed, and includes land or interests in land, 4.5 appurtenances, site preparation, landscaping, buildings and structures, systems, fixtures, 4.6 furniture, machinery, equipment, and parking. Project also includes other structures, facilities, 4.7 improvements, machinery, equipment, and means of transport of a capital nature that are 4.8 necessary or convenient for the operation of the facility. Project does not include: (1) any 4.9 facility used or to be used for sectarian instruction or as a place of religious worship nor; 4.10 (2) any facility which is used or to be used primarily in connection with any part of the 4.11 program of a school or department of divinity for any religious denomination; nor (3) any 4.12 books, supplies, medicine, medical supplies, fuel, or other items, the cost of which are 4.13 customarily deemed to result in a current operating charge. 4.14

Subd. 4. Cost. "Cost," as applied to a project or any portion thereof financed under the 4.15 provisions of sections 136A.25 to 136A.42, means all or any part of the cost of construction, 4.16 acquisition, alteration, enlargement, reconstruction and remodeling of a project including 4.17 all lands, structures, real or personal property, rights, rights-of-way, franchises, easements 4.18 and interests acquired or used for or in connection with a project, the cost of demolishing 4.19 or removing any buildings or structures on land so acquired, including the cost of acquiring 4.20 any lands to which such buildings or structures may be moved, the cost of all machinery 4.21 and equipment, financing charges, interest prior to, during and for a period after completion 4.22 of such construction and acquisition, provisions for reserves for principal and interest and 4.23 for extensions, enlargements, additions and improvements, the cost of architectural, 4.24 engineering, financial and legal services, plans, specifications, studies, surveys, estimates 4.25 of cost and of revenues, administrative expenses, expenses necessary or incident to 4.26 4.27 determining the feasibility or practicability of constructing the project and such other expenses as may be necessary or incident to the construction and acquisition of the project, 4.28 the financing of such construction and acquisition and the placing of the project in operation. 4.29

4.30 Subd. 5. Bonds. "Bonds," or "revenue bonds" means revenue bonds of the authority
4.31 issued under the provisions of sections 136A.25 to 136A.42, including revenue refunding
4.32 bonds, notwithstanding that the same may be secured by mortgage or the full faith and credit
4.33 of a participating institution for higher education or any other lawfully pledged security of
4.34 a participating institution for higher education.

Subd. 6. Institution of higher education. "Institution of higher education" means a 5.1 nonprofit educational institution within the state authorized to provide a program of education 5.2 5.3 beyond the high school level. Subd. 6a. Health care organization. (a) "Health care organization" means a nonprofit 5.4 organization located within the state and authorized by law to operate a nonprofit health 5.5 care facility in the state. Health care organization also means a nonprofit affiliate of a health 5.6 care organization as defined under this paragraph, provided the affiliate is located within 5.7 the state or within a state that is geographically contiguous to Minnesota. 5.8 (b) Health care organization also means a nonprofit organization located within another 5.9 5.10 state that is geographically contiguous to Minnesota and authorized by law to operate a nonprofit health care facility in that state, provided that the nonprofit organization located 5.11 within the contiguous state is an affiliate of a health care organization located within the 5.12 state. 5.13 Subd. 6b. Education facility. "Education facility" means a structure or structures 5.14 available for use as a dormitory or other student housing facility, dining hall, student union, 5.15 administration building, academic building, library, laboratory, research facility, classroom, 5.16 athletic facility, student health care facility, or child care facility, and includes other facilities 5.17 or structures related thereto essential or convenient for the orderly conduct of an institution 5.18 of higher education. 5.19 Subd. 6c. Health care facility. (a) "Health care facility" means a structure or structures 5.20 available for use within this state as a hospital, clinic, psychiatric residential treatment 5.21 facility, birth center, outpatient surgical center, comprehensive outpatient rehabilitation 5.22 facility, outpatient physical therapy or speech pathology facility, end-stage renal dialysis 5.23 facility, medical laboratory, pharmacy, radiation therapy facility, diagnostic imaging facility, 5.24 medical office building, residence for nurses or interns, nursing home, boarding care home, 5.25 assisted living facility, residential hospice, intermediate care facility for persons with 5.26 developmental disabilities, supervised living facility, housing with services establishment, 5.27 board and lodging establishment with special services, adult day care center, day services 5.28 facility, prescribed pediatric extended care facility, community residential setting, adult 5.29 foster home, or other facility related to medical or health care research, or the delivery or 5.30 administration of health care services, and includes other structures or facilities related 5.31 thereto essential or convenient for the orderly conduct of a health care organization. 5.32

(b) Health care facility also means a facility in a state that is geographically contiguous to Minnesota operated by a health care organization that corresponds by purpose, function, or use with a facility listed in paragraph (a).

Subd. 7. Participating institution of higher education. "Participating institution of 6.4 higher education" means a health care organization or an institution of higher education 6.5 that, under the provisions of sections 136A.25 to 136A.42, undertakes the financing and 6.6 construction or acquisition of a project or undertakes the refunding or refinancing of 6.7 obligations or of a mortgage or of advances as provided in sections 136A.25 to 136A.42. 6.8 Community colleges and technical colleges may be considered participating institutions of 6.9 higher education for the purpose of financing and constructing child care facilities and 6.10 parking facilities. 6.11

6.12 Sec. 5. Minnesota Statutes 2020, section 136A.29, subdivision 1, is amended to read:

6.13 Subdivision 1. Purpose. The purpose of the authority shall be to assist <u>health care</u>

136A.29 POWERS; DUTIES.

Subd. 4. **Mutual agreement; staff, equipment, office space.** By mutual agreement between the authority and the office, authority staff employees may also be members of the office staff. By mutual agreement, authority employees may be provided office space in the office of the Office of Higher Education, and said employees may make use of equipment, supplies, and office space, provided that the authority fully reimburses the office for salaries and for space, equipment, supplies, and materials used. In the absence of such mutual agreement between the authority and the office, the authority may maintain an office at such place or places as it may designate.
