caused by an intentional act constituting murder may be commenced at any time after the 2.1 death of the decedent. Any other action under this section may be commenced within three 2.2 years after the date of death provided that the action must be commenced within six years 2.3 after the act or omission. The recovery in the action is the amount the jury deems fair and 2.4 just in reference to for all damages suffered by the decedent resulting from the injury prior 2.5 to the decedent's death and the pecuniary loss resulting from the death, and shall be for the 2.6 exclusive benefit of the surviving spouse and next of kin, proportionate to the pecuniary 2.7 loss severally suffered by the death. The court then determines the proportionate pecuniary 2.8 loss of the persons entitled to the recovery and orders distribution accordingly. Funeral 2.9 expenses and any demand for the support of the decedent allowed by the court having 2.10 jurisdiction of the action, are first deducted and paid. Punitive damages may be awarded as 2.11 provided in section 549.20. 2.12

If an action for the injury was commenced by the decedent and not finally determined while living, it may be continued by the trustee for recovery of <u>all</u> damages for the exclusive benefit of the surviving spouse and next of kin, proportionate to the pecuniary loss severally suffered by the death. The court on motion shall make an order allowing the continuance and directing pleadings to be made and issues framed as in actions begun under this section.
