15 school districts except a school district located in any city with more than four hundred thousand  
16 inhabitants and located in more than one county and to each charter school located and operating  
17 within such school district. A"; and

19 Further amend said bill, page and section, Lines 42 to 44, by deleting all of said lines and inserting  
20 in lieu thereof the following:

22 "4. This subsection shall apply in all school districts in all school years ending before July 1,  
23 2023. Beginning July 1, 2023, and in all subsequent school years, this subsection shall apply in all  
24 school districts except a school district located in any city with more than four hundred thousand  
25 inhabitants and located in more than one county and to each charter school located and operating  
26 within such school district. A"; and

29 inserting in lieu thereof the following:

33 school districts except a school district located in any city with more than four hundred thousand

18 thousand inhabitants and located in more than one county and to each charter school located and  
19 operating within such school district."; and
